

I have enjoyed being rescue chair for 10 years now. I am not taking another term. With children grown I can now pursue my dream, starting my very own all breed dog rescue group. I still plan on rescuing Manchesters. Enjoy your summer.

<u>Sparks</u>

Kris had contacted me about a pair of senior Manchesters in need because their owner had passed away. I was able to connect with their owner's sister, and get both of these wonderful dogs: Sparks, a standard, 13 years old at the time; and Vinnie, a toy, 11 years old. Vinnie was then moved to another foster home, where he is doing well also.

Her AKC papers came with her, so I looked up Sparks online and discovered she had earned a CD . . . about 10+ years ago. I teach a weekly rally obedience class, and decided to start bringing Sparks along to the training center with the others to see if she still remembered anything.

Despite being deaf, she was not only trained with hand signals as well and remembered all her obedience—she loved it! So I started working her a bit. She had already been trained, I just needed to figure out how to cue her with signals, and teach her some rally stuff.

I judge World Cynosport Rally (WCR, formerly APDT Rally) and our club hosts trials. WCR allows deaf/blind and other special needs dogs to show, as long as they can safely perform the exercises, so I decided to enter her. Sparks showed us that the old gal can still work. She finished her RL1 title with an Award of Excellence (all scores above 190) in 1 weekend, her RL2 with another AOE in another weekend, and just completed her ARCH (All Rally Championship, which is accumulating at least 100 points, and qualifying 5 times in the same trial in both RL1 and RL2).

Sparks is now 14, and still going strong. I will do rally with her for as long as she wants to, and can comfortably do it. I cannot stress enough how rewarding adopting a senior dog can be. And, despite being in the double digits, many of these seniors are still quite active, fun dogs that are excellent companions.

AKC DELEGATE'S REPORT

MARCH 2013 - DELEGATE'S REPORT

Tuesday, March 12 was the Delegate's Assembly. The major order business was to elect four new members of the Board of Directors. Elected were Alan Kalter, Carl Ashby, Harvey Wooding and Lee Arnold. The only new person was Harvey Wooding, the other three gentlemen were continuing from the last Board. Alan Kalter was again elected as Chairman of the Board.

The president's report was basically concerned with AKC sponsored events. Performance and field trial entries are up, conformation entries are down, obedience entries are up slightly, rally entries are down. Over all entries on all events were up by about 3%.

Financially the AKC is doing better, revenues are up, expenses are down. The AKC pension fund was frozen two years ago, which helped a lot.

Amendments presented to the assembly were to allow agility clubs to become full members of the AKC. There are approximately 55 agility clubs eligible for membership, they figure that perhaps 20 will want to join. The amendment was overwhelmingly approved.

The second amendment presented was to change the number of Delegate's assemblies from 4 to 3. Each assembly would be held for three days rather than four. The delegates were not happy with this proposal and it was resoundingly defeated.

Monday is the day we get to attend committee meetings. I attended the Obedience committee meeting and the Parent's Club committee. Prime topic of conversation was first the possibility of allowing agility clubs to join the AKC. Discussion was also held about allowing obedience clubs to maintain waitlists for their trials. In these parts, agility secretaries maintain wait lists, and some obedience clubs do as well despite the restriction against it. Now this practice will probably be approved. It would allow dogs to be entered even after the show closes if the dog is waitlisted and another dog is withdrawn.

If a judge is to judge more than 5 classes at any given trial, the rules now state that the judge may not judge more than 7 hours.

There was discussion of developing a class for dogs with an OTCH so that dogs looking to attain the title don't have to compete against them. If anyone has any good idea, the committee is open to any and all suggestions.

The 100 mile rule: The AKC has decided to relax the rule somewhat. If the 100 miles is across a natural divide which would preclude straight line transportation, and the actual, physical mileage is more, not as the incredible crow flies but as the car drives, the rule will change to allow two trials to be held at the same time. This is especially good for clubs that hold small trials that close quickly and always fill. If the club holding the date originally allows it, the two trials can go on.

Fees for trials: As some of you know, if a Rally trial has fewer than 30 entries, the following year their rally trial will be free. Every trial, no matter how small engenders cost for the AKC, so it has been suggested that the fee for a small trial will be \$25, and the fee for larger trials will be \$50 (\$50 less than now). The AKC will suffer an approximate \$4000 loss on this venture, but they feel it would be worthwhile. These fees would be for all companion events, not just rally.

AKC DELEGATE'S REPORT - Cont...

For those of you who do tracking. Tracking judges may now handle dogs owned by other people in non-tracking events. There will be an application fee of \$50 for every tracking event.

The Parent Club Committee also discussed the agility club question. They too believed it would be a good thing to allow all those toned and buffed folk to come a join the fun. The AKC is still working on the Breeder of Merit program as well as the Parent Club of Excellence program. This is still a work in progress; the plan is to award parent clubs for doing the things they do best like, rescue, new puppy outreach etc. It will be discussed again in June.

The new Complete Dog Book project: the AKC has been in communication with all the Parent clubs. Hopefully the book will be ready by June 2013. Photographs need to be submitted to the AKC from every club. All the written material will be returned to each club for final approval before it is published.

CGC: The AKC has issued over 4000 titles, of those titles there have been at least 350 requests to have the title added to the end of the dog's name, a money maker for the AKC since it costs to add in the title.

The question of three rather than four meetings per year was discussed. The committee unanimously supported the four meeting format.

Parent Club titles: If a club wishes to add the titles it awards to the end of a dog's name in a catalog for a National, if the superintendent has no problem with doing it, and if they don't care, the AKC doesn't either.

New owner outreach: The Opt-In program has been devised to help new puppy owners find resources in their community to help if they have problems. It also is intended to inform the owners of various types of clubs in their neighborhood, and gives them information about their parent clubs as well. Opt-In is on the AKC web site.

Other topics of discussion: Meet the Breeds....the dates for the Javits Center will be announced soon. Limited registration: will remain as presently constituted, no changes are presently contemplated. The three point reserve major will automatically be awarded at each club's National unless the club chooses to opt out of it. One club asked about allowing on-line elections. It is being researched by the AKC, but at this point it is not allowed.



An Open Letter - Question of the Quarter:

Submitted by Cheryl Roach and Jerri Hobbs

WHY DO THEY DO THAT?

This is an idea that Jerri Hobbs had that we hope will be helpful to new Manchester people and everyone else interested in our breed. **We have SO many knowledgeable** people out there about our breed specifically and it is really helpful when you share your knowledge!

This issue's question is: How do you train your Manchester to stack on the table and free stack?

Any special tricks you've learned? Do you "free" stack or use stacking blocks when you are first starting out?

How young do you start?

Regina R. Allen - Here's how I teach self-stacking to Manchester pups:

I use the clicker and start them on the table as young as possible with a show lead on. Initially, I click and feed simply for standing still and nibbling the block of bait that I have in my hand. Very young puppies (5 weeks or so) seem totally unafraid of the height of the table. After they are comfortable with this initial step, then I touch the front feet and click while the pup is gnawing on the bait. I work up to placing the front feet, clicking and treating the entire time, then work on the back feet separately. Then I'll click/treat for placing both the front and back feet. I'll wait until the pup is entire comfortable with being stacked on the table before we move to the ground.

Once on the ground, I click and reward any foot movement, even if it's not correct to begin with. I start using the cue "fix your feet" when they move them. Eventually, they will self-stack their front feet. They may need some help with the rear - I will gently touch or position them by hand, then click/treat. I will also use the bait block to lure their head, which moves their feet, and then I'll click and release the treat to them when they are properly stacked. Since I do a lot of shaping exercises, the pups are willing to try different behaviors to earn that treat!

Jerri Hobbs - I teach my pups to free stack by getting them used to watching my hands for treats and giving bits of cookies the second all four feet are on the floor at the same time. You have to be quick! and make it a lot of fun. We go from group to individuals as pups leave. Stacking on the table is a completely different exercise. No blocks and no treats until I can set them up in any direction and any place on the table. Only after they know what they are supposed to do while up there do I start with bait. Hate the blocks BTW.

Rachel Taylor Jonas - I read an article on Linda Lewin's web site about training the stack and it's been wonderful!

Beverly Meffert Willeford Leidner - I start stacking puppy as soon as they can stand on table. I also teach free stack while in kitchen with food. They love to watch me as I cook supper. My dogs love to stand on the picnic table in the backyard all the time.

Ellen Murtagh - When I have a litter I start them out on a towel in my bay window as soon as they start walking around and their legs are somewhat steady, around 4 1/2 to 5 weeks old. I use cheese to keep their attention for the short time they are standing. They are only up there for not even a minute at first and work into a bit longer each time. I try to do this 2 to 3 times or so a day. Once their legs get steadier, after a week or so I start them on Happy Legs. Around 6 weeks or so I start trying to get their attention when playing on the

floor. Keeping a treat at the ready, again usually cheese at this age, if they stop and pay attention to me, I treat them.

I normally start show practice, at my training center, when the potential show puppy gets to 3 months old, whether I've breed the dog or not, but before that I have started to work, with, and without, a show lead at home.

Zandi Spicer - I also teach "free stacking", by the time they are 5 or 6 weeks old, they know they get "Goodies" as a reward. I have a ring size table, which is just right for table examinations..and of course, since these guys are smart, they know those goodies are always on hand. Several judges ask you to "go here/there and free stack your dog", and it looks very impressive if you can show off your dog with a beautiful free stack.


