


2015 AMTC 1st and 2nd Quarterly Report of the Board

& July Highlights 2015

The newly elected AMTC Board members have had a busy first and second quarter. Following finalization of the election for the 2015/2016 term, the Board held its first meeting via telephone conference call on April 9<sup>th</sup>, 2015. All officers and board members were in attendance and welcomed by President, Jeremy McClister.

Minutes from the November 2014 Board meeting were read and approved. Subsequent monthly meetings have been held on the third Wednesday of the month via telephone conference call with July 15<sup>th</sup>, 2015 being the most recent meeting held.

The first meeting of the Board in April was an organizational meeting to ensure matters from the previous term follow through to this term. Incoming Secretary, Kathy Nissen, and incoming Treasurer, Dianna Texter are reviewing and updating all records forwarded by their predecessors.

Items discussed/agreed upon by your Board during the first two quarters of 2015:

Redesign and locate cost effective website designer/server for a more user friendly, graphically appealing and more informative website. Research is currently taking place to ensure the club obtains the best option for our club's needs.

AKC Club Relations was notified that due to the Election of Officers & Board Members having to be redone, the AMTC Membership Directory would not make the May 1<sup>st</sup> mailing deadline as stated in our AMTC Standing Rules.

Update Committee Volunteer forms and descriptions for later distribution to the membership via the AMTC Newsletter.

AKC/Eukanuba Medallions/Meet the Breeds Booth – the booth and medallions for both varieties were agreed to. Medallions will also be sponsored for obedience and agility. More information pertaining to the Meet the Breeds Booth will be forthcoming.

Breed Seminar CDs have been provided by Rod Herner, Judges Education, for distribution to District Governors and Breed Mentors.

#### AMTC BOARD RESPONSES & ACTIONS, Cont.

Provided the AKC with the required updated list of current AMTC member names/addresses.

Agreed to allow reimbursements for club related matters up to \$150 without Board approval providing reimbursement requests are accompanied by a receipt(s). Reimbursement (with a receipt(s) provided) for any amount over \$150 will need Board approval.

The AKC requests that all clubs should have 501 (3) status. 1<sup>st</sup> V.P., Lisa Nonog, is looking into this matter and will report back to the Board.

Michelle Barlak will attend the AKC Health Conference with the Club paying her expenses.

Renew the AMTC Parent Club Membership for the Canine Good Health Foundation - \$200.

Award points for HOF for Owner Handler/Group Placements (same dog) as follows:

BIS/Group 1 - 50 points;

Group 2 - 40 points;

Group 3 - 30 points;

Group 4 – 20 points (effective July 16<sup>th</sup> 2015 retroactive to January 1<sup>st</sup> 2015).

Grand Champion Points – 100 points for each level.

Possible "Litter Listing" on website Breeder page, as well as, videos showing Manchesters in action.

Consider updating criteria for Good Sportsmanship Award to "member must be a member in good standing for at least 5 years".

Paypal account for club use. Treasurer, Dianna Texter, setting this up.



# **Biographies of New Board Members**

I met and became close long time friends with Ken and Cloydett Stickney (Bit O Luck), Jan and Dwight Varner (Canty), Marla Zoz (Ambrick), Bev Leidner (Fantasy) and Cathy Vanatta (Inverwood).

The world of showing dogs opened a whole new world for me that I came to love dearly. During my first year of showing I also joined the AMTC but took a break from 1987 through 1999 to raise my children but once they were old enough to be in school I was back at it again and rejoined the club. I also previously held the office of Secretary prior to this current term (finished out vacated 2002 term and continued through 2008).




To the AMTC Board of Directors.

#### AMTC JUDGES EDUCATION COMMITTEE REPORT

We are working on getting the Judges Education Material and list of mentors/presenters on the AMTC site.

#### **HEALTH CHAIR REPORT**

Instead of the usual serious article about canine diseases, some humor this month instead!

Some things I've learned about dog training and life in general, after having major knee surgery ...

- If you accidentally smack a small dog with your crutches, he won't want to heel next to them for a long time.
- 2. Using a walker during training really messes up your fronts and finishes.
- 3. Using crutches during training also really messes up your fronts and finishes.
- Using just one crutch during training and showing really, really messes up your fronts, but isn't so bad for your finishes as long as it's under your right arm.
- 5. Always be nice to your mother-in-law, especially if she's taking care of you after surgery.
- Don't be afraid to take your pain meds as prescribed post-op. Pain slows healing and makes it difficult to sleep, and you're unlikely to become an addict in a week.
- 7. Ice is your new best friend.
- 8. A tired puppy is a good puppy.
- Taking the time to learn to play with your dog as a puppy pays dividends as an adult, especially when you can't take him for long walks or run around with him in the yard to tire him out.
- Don't give commands you can't enforce. If it takes you five minutes just to get off the couch, you aren't going to be able to enforce that ignored command.
- 11. A clicker, a handful of treats, and a shoebox are great tools for keeping a busy puppy occupied.
- A Kong filled with a mixture of kibble and canned dog food, then frozen, is a great way to soothe and occupy a fussy, teething puppy.
- Most puppies don't arrive leash-trained, and turn into bucking broncos when you start the process.
- Listen to your physical therapist, even if it hurts, because you will thank him or her in the long run.
- 15. In retrospect, it's probably not a good idea to use jumping up to kiss your cheek as a reward, especially with a big dog, because it's really easy to knock over someone on crutches.
- A small warm dog cuddling in your lap is therapeutic, whereas a big fat cat jumping up onto your recently-operated leg is not.

Hope you enjoyed my advice for recovering from surgery or major illness, and that it is useful. I know some of you are going through difficult times right now – hug your dogs and feel better!





AMTC Judge's Education Guidelines, Policies, Procedures 2009

#### 5.0 BREED MENTORS AND SEMINAR PRESENTERS

#### 5.1 Qualifications

In order to qualify as an AMTC-approved Breed Mentor and/or Seminar Presenter, the prospective Mentor shall meet or exceed minimum criteria as set forth, below. Each Breed Mentor shall:

- have owned one or more Manchester Terriers for no fewer than seven years;
- have been a member of the AMTC for no fewer than five years;
- have exhibited one or more Manchester Terriers for no fewer than seven years;
- have owned no fewer than three Manchester Terrier AKC Conformation Champions;
- have bred no fewer than two litters of Manchester Terriers, producing at least two Champions; and
- have attended no fewer than two Judges' Education Seminars held in conjunction with AMTC National Specialty Shows.

### 5.2 Application Process

Members interested in becoming an AMTC-approved Breed Mentor shall make application to the Committee Chairman via a letter requesting consideration. Such letter shall contain the following:

- all records or other data which prove the fulfillment of the requirements delineated in this Section 5.1;
- all other accomplishments in the breed which the applicant wishes to note (handling, judging, etc.);
- · identifying information for National Specialty Judges' Education Seminars the applicant attended if he or she has already attended seminars; and,
- contact information for the lead presenter at any seminars at which the applicant acted as an Assistant Presenter, if the applicant is applying to be approved as a Seminar Presenter.



I am a Breeder of Merit – I have bred thirteen Champions – four of which are now Grand Champions.

#### PLACING PUPPIES IN THE 21ST CENTURY

As I watch my new litter of puppies as they grow into the loving companions they were bred and born to be, and I think about my responsibility as their breeder to ensure their new homes are "furever" ones. In addition to the <u>socialization</u> and enrichment they each desire and require, and will receive, it's also my job to find the right people for each puppy. But how best to do that?

Well, I think that brings us to the seemingly "dirty word" of advertising. I think many in the dog fancy associate advertising with merchandise, and we would *never* consider our puppies as such. Back in the day, it was considered taboo to place an ad in the newspaper, and now it's verboten to seek homes online. "We needn't stoop to *that* level in order to place puppies," we think.

I think part of the stigma arises because the Internet is where so many of the shady, back-alley dealings by those dastardly puppy-millers occur. There are all sorts of sites that cater to pet sales—and yes, irresponsible breeders are indeed thriving there. However, we need to realize that online is where people look for *everything* these days—including their puppies and dogs. Rescue organizations have embraced the Internet; it's time reputable breeders do likewise.

If we don't use the Internet as the tool it can be, we, in essence, are giving free rein to those less-than-reputable breeders to peddle their wares. Without any real alternatives for the people seeking a healthy, well-bred dog, the bad breeders are thriving online. If they're the only ones online, then they're the only ones whom people who are seeking will be finding.

We need to make our presence known online so that people who do want to buy—yes, *buy* (that's not a dirty word, either)—will have the option of finding us. Hopefully then they will see the difference between our healthy, well-bred puppies and ones born and reared in sometimes horrible conditions.

Yes, there will always be people for whom the dollar is the bottom line. However, there are also a lot of people out there looking to find the quality puppies we have to offer. We need to make ourselves available. Let's not let our pride get in the way of finding the homes our puppies deserve.

The times are a'changin', and we must realize we need to change with them in order to stay relevant in today's world. I admit I can be fairly "technically challenged" when it comes to many online activities, but in my opinion it's critically important that we do whatever we must in order to find the best homes available for our puppies.

Additionally, thanks to the Internet, the world has become a much smaller place. Because I've used the Internet, I've placed my puppies in outstanding homes quite literally from sea to shining sea. And in addition to the new friends I make, it's so easy to stay in touch, watching our babies develop into beloved family members.

Let's not be intimidated about our brave new world's technology, or so prideful because we don't need to advertise our litters, that we allow these great homes to slip away to irresponsible breeders.

While I once spoke in pristine prose, in dulcet tones and frail I am now using language that would turn a sailor pale.


I adored a man who murmured verse through intimate little dinners But now the words I thrill to hear are just these three: Best of Winners!

# It's Not What's Wrong With Dog Showing... It's Who's Wrong! By Marlene Groves

Dog showing is an interesting sport, or game, or as many call it, a fancy. It brings together a melting pot of people who are rather obsessed with dogs and in particular their breed and their dogs. It showcases fabulous dogs and you get to meet friends who share your crazy passion. It sure is something which can be tons of furry fun!

But then there is the other side, you know, the darker side of things; bringing out the cruel and unkind and for whatever reason this part of the fancy is gaining momentum and ugliness. Lately I keep hearing, "it is not what is wrong with dog showing, but who is wrong".

Imagine if you will a ring full of dogs and someone outside the ring, rambling off ugly comments about a dog (yours or anyone's), or adults glaring at another competitor, or some of the yelling matches we have all witnessed. This is not a fantasy world, it's a sad reality; and it really needs to stop!

So ask yourself, what to do? Most people say nothing or do nothing when they witness poor behavior, and to them I say, you know the phrase if you are not part of the solution, then you are part of the problem (yep, I think it applies).

There are Codes of Ethics in the AKC and in each Breed Club; there are Codes of Ethics in the various Professional Handlers Associations... But are they helping or being enforced? In my personal opinion, I am thinking not so much.

Now I will take this to another level, and that is when "adults" target or aim their cruelty toward our "youth"... Think it does not happen, well, think again. Then apply it to your child, your grandchild, or to yourself as a young child. We need to encourage every junior (and new person) that even tries our sport or is remotely interested. So ask yourself, are you an encourager?

Personal story number one: I was at a dog show out of my area, ringside at juniors, and there were a few "adults" tearing down an out of town "junior" (not mine). Sorry, people, but don't go there or act like that with me around. I turned to both these "adults", and said, yes this "junior" is from XYZ, as am I, and this "junior" is a fabulous handler with a fantastic dog". This stopped the conservation, or at least stopped it around me. Good Lord! Am I the only person who thinks, and knows, this is wrong!

Personal story number two: At a local fun match where a "junior" was showing and she took breed and went on to the group. An "adult" competitor was ringside haranguing the "junior" and her dog. What she did not know is that the junior's mother was in earshot. Honestly, the junior's parents nearly pulled her from this sport of dog showing that she loves as they do not want her subjected to these types of "adults" (bullies) and their ugliness.

Again, this is beyond ridiculous; it's completely unacceptable! But it is tolerated by the masses, including professional handlers, especially if someone has a large wallet or a top dog.

We are all told you need "thick skin" to be in this sport, but really? Why? Are we just giving these people a "free pass" to practice ugly behavior?

And then, of course, there is social media, where dog clubs, including most national breed clubs and the American Kennel Club don't think unsportsmanlike behavior in these formats is under their control or influence in essence giving people another free pass to berate and belittle someone. Hmmm, are these things not "unsportsmanlike behavior"? We all know they certainly are!

If you don't like a person, don't get involved with them. TRY to at least be neutral, and not hostile! Another phrase comes to mind, "if you can't say anything nice, don't say anything at all".

If you don't like a dog, don't breed to it. Try to remember that dog is someone's pride and joy. Maybe it's their first purebred dog or first show dog. And in any conversation about any dog try my 3-2-1 method: find 3 things you like about the dog, 2 things you would change, and then 1, an overall summation. It is much kinder than a petty criticism of any dog, yours or your competitors.

Don't like a judge, or their judging preferences, well you don't have to enter and show under him or her. But on the other hand, you might TRY to share some educational information, or point them to a good breed mentor; or even as hard as it may seem, TRY to understand their logic and/or choices.

Don't like a junior? Or maybe you feel entitled to say or do (or allow) things regardless of if it HURTS them... Sorry, this may sound harsh and I don't want it to be, because I am really a very kind person; but I am taking a stand and I say enough already, because YOU, quite possibly, are what is wrong with this sport!

I don't know what I think writing these words will do, but I can HOPE it inspires the good side in our sport start to stand up against the dark side so we can focus on the dogs, on friendship, on fun, and most importantly on helping to propel this sport to be better and better in the future. In my opinion, this means we help all newcomers, we support all juniors, and we stop the ugliness when we see it or hear it. Please don't think it does not apply to you. You are in this sport and if you want to be part of the solution (not part of the problem), stand up and be heard please!

P.S. – I wrote this article just before the 2015 Westminster Kennel Club Dog Show, and I am saddened to say what I wrote about unsportsmanlike and unprofessional behavior was clearly seen on social media during and after this fantastic show with fabulous dogs. All the dogs in the Best In Show line up were stunning and deserving! And Judge David Merriam was beyond eloquent, and we definitely need more of that in our sport!




