Unfortunately, we lost one of our elected board members, Judy Anderson, due to her husband, Gary's, health. We wish him a full and speedy recovery. The board approved appointing Susan Thrasher to fill the vacancy for this term.

The last quarter of 2015 found your board continuing to research ways to make our National Judges' Selection process simpler. Roberta Berman, 2nd V.P. is putting together a proposal for presentation to the membership in the not too distant future. In the meantime, all input is welcome.

We also continue working on updating the various committees and volunteer forms. If any of you are interested in joining and/or chairing a committee, please contact Lisa Nonog, 1st V.P.

Finalizing information for the newly designed AMTC website was another priority. Unfortunately, as with any new venture, this took a bit of time and glitches do happen but for the most part. But the majority of the feedback received from the membership and general public has been positive. Any issues regarding the website, once known, are immediately provided to the webmaster for repair/updating. Please continue to submit ideas, information, and comments to the board for consideration and inclusion on the website. We are striving to make this website a great venue for everyone to learn about our wonderful breed.

HEALTH STUDY - We need your support. Currently, the American Manchester Terrier Club is collaborating with the Canadian Manchester Terrier Club on an international effort to develop a genetic test for a deadly disease in the Manchester Terrier: Juvenile Cardiomyopathy. Researchers at the University of Minnesota, the University of Pennsylvania and the University of Prince Edward Island are coming together with a single goal -- to find the gene causing Juvenile Cardiomyopathy (JCM) in Toy Manchester Terriers. With the support of the Gold Country Manchester Terrier Club, Manchester and English Toy Terrier clubs overseas, and owners and breeders around the world, we are raising funds for this very important work. We've reached 85% of our \$1500 goal. If they are successful, breeders will be able to test for and eliminate JCM from Toy Manchester Terriers and English Toy Terriers forever.

The Board has also approved the addition of a 'travel assistance' stipend for those Junior Handlers qualifying and exhibiting at Eukanuba. This is the same as the stipend for those Juniors qualifying and attending Westminster. The amount is now \$250 and must be requested in writing.



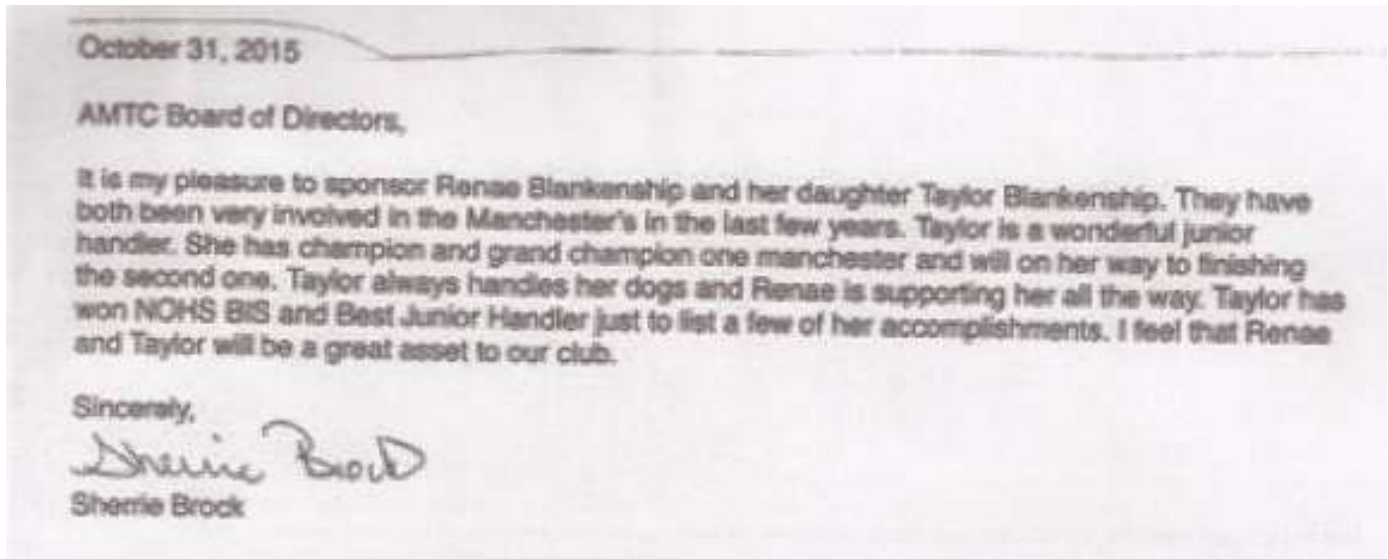

HEALTH CHAIR REPORT

Dog Show Diarrhea

A common affliction that dogs and puppies often come home from shows with is “dog show diarrhea.” This is a non-specific acute diarrhea that can be caused by dietary indiscretion (bait and other treats that they are not used to, eating junk off the floor, eating feces – ugh!), changes in diet, stress, picking up bacteria or parasites from contaminated soil or other dogs’ diarrhea, etc. While many show people are quick to start the dog on Flagyl (Metronidazole) obtained from internet sources, this is really not the best option. Flagyl is an antibiotic for anaerobic bacteria, and an anti-parasite drug effective against Giardia. It is not effective against *Campylobacter*, which is a common bacterium found in contaminated soil at dog parks and dog shows. Flagyl may be effective for non-specific diarrhea due its anti-inflammatory properties, but it is overused, which can lead to resistance when it is really needed for bacterial or Giardia infections.

A better option, rather than throwing Flagyl at a condition where it may or may not be warranted, is to start with fasting the dog for 24 hours. This will help settle down the dog’s upset gastrointestinal tract. Free access to water is fine. Give the dog Pepto Bismol tablets (much easier to give than goopy pink liquid) at a dose of ½ tablet for a small dog (25 lb. or smaller), 1 tablet for a large dog (25 – 75 lbs.), and 2 tables for an extra-large dog, two to three times per day for a day or two.

If the diarrhea stops, you can cease giving the Pepto and start the dog back on solid food with a highly-digestible bland diet such as boiled chicken or boiled hamburger with a small amount of boiled white rice. An alternative is a prescription dog food such as Prescription Diet i/d or Purina Veterinary Diet EN. I keep a couple of cans on hand for such episodes. Additionally, start the dog on probiotics with the bland diet. I really like Purina’s Forti-Flora, which is a powder that you sprinkle on the food. Follow the directions on the box for dosing. I’ve also had good success with Bene-Bac gel, which is convenient for dosing small dogs. If the diarrhea stops, continue the probiotics and bland diet for about 3 days, and then gradually begin reintroducing the dog’s regular diet over a week’s time.

With this regime, most dogs with acute non-specific diarrhea will be back to themselves in a day or so, without needless antibiotic overusage. If there is blood in the diarrhea or it does not stop with the above regime, then a Veterinary visit is warranted. There are easy tests for Giardia, worms, *Campylobacter*, and *Clostridium* bacteria, which all require specific treatments. Then your dog or puppy can be treated appropriately for their condition and recover quickly.

The Manchester Terrier and English Toy Terrier worldwide community has raised 85% of our \$15,000 goal! Donations have come in from across the U.S.A., Canada, Germany, the U.K., and Australia. Included in that total are donations from the American Manchester Terrier Club (\$1,892 raised at the 2015 National & \$826 from the dedicated JCM Health Committee Fund), the Gold Country Manchester Terrier Club (\$250) the Canadian Manchester Terrier Club (\$1,250), and the English Toy Terrier (Black and Tan) Club (\$900) which collected funds from members and breeders in the U.K.

At the time of this writing, we are just \$1,785 away from our target goal. The study is already underway. The research team at the University of Minnesota has prepared the first group of DNA samples to send off for genotyping (this takes 6 to 8 weeks). Our first bill is going to be \$6,500 which we can cover, thanks to all of the generous support the study has received! If you are reading this and made a donation, I thank you from the bottom of my heart.

If you have not yet made a donation, there is still time. We will have ongoing bills for this study as it progresses. At this time, I doubt there will be funds left over, but if there are, we will put them back in the AMTC and CMTC health funds for future health-related research projects.

5.0 BREED MENTORS AND SEMINAR PRESENTERS

5.1 Qualifications

In order to qualify as an AMTC-approved Breed Mentor and/or Seminar Presenter, the prospective Mentor shall meet or exceed minimum criteria as set forth, below. Each Breed Mentor shall:

- have owned one or more Manchester Terriers for no fewer than seven years;
- have been a member of the AMTC for no fewer than five years;
- have exhibited one or more Manchester Terriers for no fewer than seven years;
- have owned no fewer than three Manchester Terrier AKC Conformation Champions;
- have bred no fewer than two litters of Manchester Terriers, producing at least two Champions; and
- have attended no fewer than two Judges' Education Seminars held in conjunction with AMTC National Specialty Shows.

5.2 Application Process

Members interested in becoming an AMTC-approved Breed Mentor shall make application to the Committee Chairman via a letter requesting consideration. Such letter shall contain the following:

- all records or other data which prove the fulfillment of the requirements delineated in this Section 5.1;
 - all other accomplishments in the breed which the applicant wishes to note (handling, judging, etc.);
 - identifying information for National Specialty Judges' Education Seminars the applicant attended if he or she has already attended seminars; and,
 - contact information for the lead presenter at any seminars at which the applicant acted as an Assistant Presenter, if the applicant is applying to be approved as a Seminar Presenter.

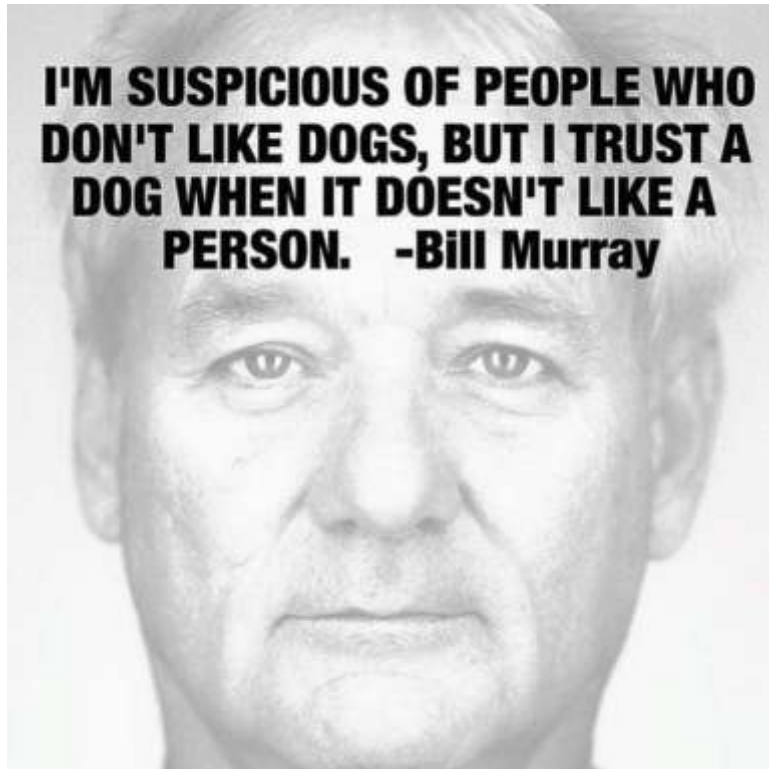

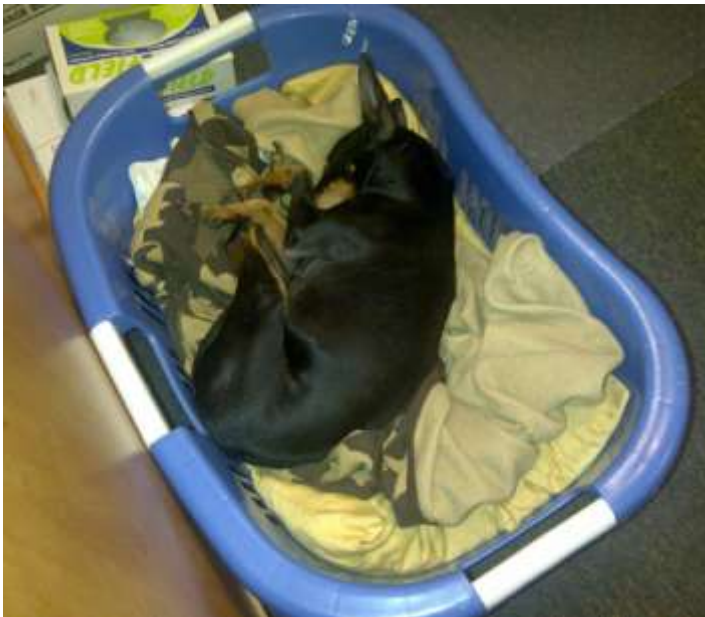

Let me introduce you to Kramer (Ch. Neverland’s Gold Star CD RE OA OAJ XF CAX CGCA TT HOF). Yes, he is named after THAT Kramer. He is just about the most charming, delightful, funny, difficult, frustrating dog I have ever met. He is also the only dog I know who has his own fan club, not because he is a big breed winner or a national hero or a rock star, but because he is just fun to watch, especially in agility where he can always find some new way to run a course that isn’t exactly the course the judge designed.

Kramer is trained in obedience through Utility, however my hopes for that elusive title are very, very slim. He has his CD and his RE, but showing him can be torture. He, the world great retriever, has been known to go out over the jump, look at his dumbbell and forget to bring it back. When heeling, he feels the need to check out the territory to make sure there is no food hiding on the floor. Stays??? He’ll think about it. Lest you think this is anxiety behavior, he also got his CD very quickly, but he is very ring wise and knows full-well that he can do anything he likes while in the ring.

In agility....well....run the course correctly??? “Why bother, I can design a much better course than the judge.” Of course, the course has to be checked for food, or varmints or other interesting objects. “I’ll get back to you, and let you know if it’s worth my while.” I remember one trial in which the tunnel called to him. He disappeared into it and didn’t come out. I looked in one end, the judge looked in the other, he was nowhere to be found. Eventually he emerged, no one knows what he was doing in there or why he felt the need to stay inside. And, of course, he didn’t bother to tell us.

Is there anything this dog really, really loves? Try CATs. THINGS I AM WORRIED ABOUT

I think I had better start with a disclaimer. What follows is strictly a personal opinion. It has nothing to do with anybody else. It is not club policy. There may very well be errors. Just things that have been on my mind based on our low numbers. So, if you want to scream, scream at me.

VWD is something the breed has dealt with forever. In the early 80s you were able to get a blood test for it. I do not even know what the factors were for sure but you had the blood drawn and your Vet told you if your dog had a problem or not. Then, the DNA test was developed and made available. The first time I remember hearing about that was at the first Lincoln National. 2008. It may have been available before that but there was a huge push at that time to start using it and a lot of dogs were swabbed during that show.

The number that sticks in my mind was 6% of the dogs in that batch were affected. So, 94% were either Clear or Carriers. 94% of those dogs could have been bred without any fear of producing an Affected dog. Also, at that point, I kept hearing that there had NEVER been a documented case of any Manchester ever dying of VWD which is a fatal problem in some other breeds.

That did not stop a fair number of people from clearing all the Carriers from their breeding programs for no other reason than they were Carriers. This included a young dog from my own breeding that was neutered without my every being aware of it. A multi group placing dog who was everything a TMT should be but Clear.

Seems to me it was about that time that our numbers began falling. A number of dogs that would have been used were gone and there were more people refusing to use anything that was not clear. IF memory serves, our AKC numbers were between 550 and 700 dogs registered every year and it just seemed to shrink away to what it has been getting down to now.

Up to that point, I had never heard of Juvenile Cardio Myopathy. Not saying it didn't exist but unknown to me. Suddenly, there is was and puppies were dying horribly and people were screaming about it being of major importance to study.

Any puppy that died was suspect and if you didn't have the money to spend on having it tested you were a disgrace to the breed. As a result, a lot of people quit talking about dead babies no matter how they died and a program that might have benefited the breed never really took off.

Then came CHIC. This was just a few years ago and while I know some people who are testing every dog they own I do not know how it has affected our gene pool. Do you remove a dog with one problem? Two? I just do not know.

NOW the club wants to support a DNA test for the cardio issue. Absolutely nobody wants to watch puppies die. Nobody! Knowing for sure that you can breed a litter of babies without worry would be a good thing.

BUT if our gene pool continues to shrink, it may be a moot point because there will be no way to avoid extreme inbreeding which will carry its own set of problems.

Please, when this test is available, learn from the past. Be sure you stop and think before making a knee jerk decision to purge your breeding animals. With a good dose of common sense we can continue to produce pups who are a credit to the breed. Type, smart, sweet, strong animals that will bring us pride and pleasure. Anything else is going to move us away from that ideal.

My time as an involved Breeder is winding down. I won't produce puppies I cannot do my best for. Hopefully, that time is far enough away to allow me to keep doing what I love so much but I will not let desire overcome responsibility.

So – it is up to all of you. Please stop and think about the decisions you are going to make. Thank you.

UDX = I must be out of my mind!

I had that exact thought *many* times while attempting to put a Utility Dog Excellent title on our intact male Manchester Terrier but the day Tripp became GCh. Shal-Mar's Mancunian Hot Rock **UDX**, RE HOF, was the best feeling ever, EV-ER. If taking him to Westminster was the most exciting thing we had ever done, getting his UDX title was the most joyous thing I have done. Other exhibitors left their dogs in the ring to hug the pair of us and the whole building knew by the noise. A friend gave me a glittery, faux diamond "UDX" pin (really not my style) but I wore that pin constantly for days to show everyone and anyone how stinking proud I was of our little Manchester man.

But the journey to that day was long, hard and painful and I frequently thought, "I must be out of my mind." So did Tripp since there is no food permitted in obedience, unlike conformation that he did with his Dad.

Jonathan and I have 2 dogs with UD titles. Tripp, and our first Manchester, Ch. Saltaire Windsor Who Am I UD RE HOF. Aka Gypsy. Gypsy is my Novice A dog which makes her unique. The first time you, the handler, put an AKC obedience title on a dog you can go in the Novice A ring but after that, regardless of whether the dog has competed or not, the handler can never again go in Novice A and always has to go in Novice B. That also makes Gypsy the dog that I made all my learning mistakes on.

Her patience is phenomenal.

The journey starts in the Novice ring. You and the dog do a heeling pattern on and off the leash, a stand for examination off leash and a recall across the ring. The dogs also have to do a 1-minute sit and a 3 minute down, with the handlers across the ring. Novice is terrifying and a huge accomplishment for any

dog. Probably more so with our bunch who tend to be the “take a number, I’m busy” type. Once the dog has qualified in Novice 3 times you move to Open.

In Open the heeling pattern and figure 8 is off leash, meaning the umbilical cord is forever severed and freedom is an option. There is a tricky lie-down in the middle of the recall which our exceptionally intelligent breed learns to anticipate and do all by themselves. Which is a failure of course. They also have to retrieve their dumb bell after you throw it across the ring (they like that one) and then do the same thing taking a jump on the way out and on the way back with the dumb bell in their mouth. The broad jump is usually fun as it is wide and low but they do need to remember to execute a tight turn and return to a perfect sitting position in front of you.

The 3-minute sit and 5-minute down with the handlers out of sight is a big challenge for a lot of dogs. It is also scary for the handler not knowing if their dog is behaving or chatting up that nice poodle girl sitting next to him. 3 more qualifying scores and then on to the really fun stuff.

In Utility the heeling pattern is part of the Signal exercise. That means you cannot verbally tell the dog to heel, just use hand signals. Then the dog must stop in a stand from a walk, without sitting and remain standing while you walk across the 50-foot ring. He then lies down, sits up and comes, all on your hand signal, not when he feels like it.

A large percentage of dogs suddenly need glasses and are unable to see you waving both arms in the air, despite having been able to see a tennis ball across a football pitch the previous day!

Next we have the Articles. Articles are 5 identical leather (usually dumb bell like) objects and 5 metal ones that are put in a pile. The handler rubs one to scent it and the judge drops it in the pile behind the dog’s back. The dog is then sent out to retrieve the recently scented article from the pile of identical objects. Gypsy instinctively knew how to do it and as a puppy could retrieve the exact pinecone that I tossed into a pile of 50 other pinecones, no trouble. Tripp refused to pick up the metal for months so Jonathan made him special ones out of canning jar rings and he was fine with those. Then he had to have leather rings made out of horse reins because he bit through the leather on the bar. Besides, then they all matched which looked much nicer. Sometimes his sniffer would pick up the scent of a bitch and follow it all round the ring until the judge called a halt to the exercise. This was his toughest thing. He likes the ladies!

For the Glove Retrieve, 3 white gloves are placed across the back of ring and from the center of the ring the dog is directed to whichever glove the judge indicates. Lazy dogs go the closest glove rather than where they are sent. And really enthusiastic terriers shake the glove until it is dead on the way back to you.

The Moving Stand for Exam is a more comprehensive hands on examination of the dog who has to stop and stand from a heeling motion, without the handler slowing their pace. The handler then stops and faces the dog from 10 feet away. After the judge has examined the motionless dog, the handler calls the dog straight to a heel position.

The final exercise of Directed Jumping can be the hardest and probably fails more dogs than anything. The handler sends the dog across the ring, in a straight line then commands him to turn around and sit approximately 45 feet away. This is the “go out”.

The dog is then directed to jump one of 2 types of jump, left or right before repeating the exercise and taking the other jump, on command. Gypsy never liked to leave me if she was not chasing something like a dumb bell or glove. Tripp has the most beautiful go outs but became fearful of jumping at the age of 3 so we missed a year while I retaught him how to jump, using set point exercises. I always thought dogs knew how to jump but sometimes they don't and need to be taught, like a horse. Part of his training was to jump a regulation jump into the bathroom (his personal dining room) if he wanted his dinner, to build up motivation. Once he stopped crashing and “stuttering” he was away and got his title fairly quickly but to this day my heart is in my mouth every time he jumps.

Utility Dog Excellent requires the dog qualify in Open and Utility on the same day, 10 times. That is 12 different exercise in the same day, often with several hours of hanging around in between. It is really hard for their little brains to give that much focus in a day especially when their Mum has been replaced by a scary stress monster in different clothes who seems to have forgotten to bring the treats into the ring for goodness sake! But we did it and now we are onto different times.

No longer is everything about training.

If Tripp or Gypsy do not give me a perfect front when I give them a treat or Tripp drops his dinner bowl when I ask him to bring it to me...it doesn't matter! But, signals are now invaluable as Gypsy is deaf and Tripp's hearing is fading. They can heel impressively in Home Depot and stack beautifully. They will go in the direction that I indicate because I can see which bush their ball is under when they cannot and Tripp will retrieve anything that I ask him to, even keys or a flat piece of paper. He will jump a stream or fence if I tell him to and even attempted to jump a cattle guard because I stupidly waved my arm in a “jump” command gesture.

Both dogs worked their little hearts out in the breed ring and in obedience. Now they are enjoying the marshmallow period of their lives and I love them even more.

American Manchester Terrier Club National Specialty 2015

Manchesters became “Stars” in the “Star City”

Manchester owners, breeders and handlers from all over the United States met in the capitol city of Lincoln, Nebraska at the Lancaster Event Center for the 77th Annual American Manchester Terrier Club National Specialty. With more than 100 entries, the Manchester Nationals is the highlight of the year for these charming, beautiful and rare dogs.

This year the Nationals was held in conjunction with the Cornhusker Kennel Club of Lincoln Nebraska and Platte Valley Kennel Club of Fremont all breed cluster shows and was hosted by the AMTC Districts 4 and 5 on October 1st and 2nd, 2015.

The Host Hotel was The Staybridge Suites on Fletcher Avenue. This location was very accommodating with large areas of grass surrounding the hotel. The breakfast/lounge area provided a great place for everyone to relax and catch up, while snacking on delicious snacks and morning fare.

Preliminary events included a Welcome at the Host Hotel, Board meeting, and Judges Seminar on Wednesday. This was followed by the first day of conformation judging both Nationals and all breed, our independent Obedience & Rally trial, and the Annual General Meeting on Thursday. Manchesters in Performance - Because this venue offered such a variety of additional dog sport activities, it was perfect for showing off just how versatile and talented our Manchesters can be. Besides Conformation showcasing beautiful representatives of Toy and Standard Manchesters, the additional offerings included Obedience, Rally, Agility, Lure Coursing/Coursing Ability Tests (CAT), and the new sports of Barn Hunt and Dock Diving. Quite a full slate!

Incidentally, a majority of the Manchesters, Toys and Standards, that participated in the AMTC performance events were also breed champions. Some of the Manchesters who did especially well in their performance events, competed in the breed ring as well. Not only that but during the four days of competition, the HIT agility Manchester and the HIT Obedience Manchesters also ranged from making the final cuts in tough breed competition to earning Select, or even Best of Opposites. Proving that Manchesters are not only beautiful, but are not afraid to "roll their sleeves up" and perform as well.

In Obedience and Rally, **Rick Garvin** judged a respectably sized National entry. Teams came from California, Minnesota, and Texas, with a majority performing qualifying runs. In Obedience, Standard Manchester Terrier, CH Just Misselle CD BN RA, owned and handled by Annette Bujold, was awarded High In Trial (HIT), while in Rally, Standard Manchester Terrier, Ch. Just Cast A Giant Shadow, CDX, RE, owned and handled by Karen Anderson, was awarded High Combined (HC).

Manchester Terriers actually take quite well to training and are very bright and witty. Do not let anyone tell you they cannot be trained!!! It might take a trainer that's willing to be patient and as crafty as a terrier, but it undoubtedly CAN be done. Those who choose to take on the challenge of the intelligence of a Manchester Terrier find them to be fun partners to work with. The Manchesters that were entered in Obedience and Rally were not only in the first, Novice levels, but covered the whole spectrum of classes, with a majority of them being in the upper classes such as Open and Utility in Obedience and Advanced and Excellent in Rally.

Manchesters also got to show off how well they excel in the agility arena. Two handlers, one from California, the other from Texas, each had two agility entries. Each handler had one each of the highest level, Masters level dog, and also a less experienced, "up and coming" dog. There were some very nice courses with fair challenges for all, judged by Terry Elger. While not all were Qualifying runs, each was very exciting and our Manchesters put forth an outstanding effort and caught the eye of a number of spectators.
