

# Optimal Breeding Timing in the Bitch When Using Artificial Insemination Regina R. Allen DVM

Before we can discuss artificial insemination, it is important to understand the normal canine reproductive cycle. The four stages are proestrus, estrus, diestrus, and anestrus.

**Proestrus** lasts approximately 3-17 days, with an average of 9 days. Male dogs are attracted to the bitch, as her vulva is swollen and she has a serosanguinous (straw-colored and blood-tinged) discharge. However, she will not allow them to mount her. Blood progesterone concentrations during most of proestrus are less than 2 ng/ml.

Estrus follows proestrus, and lasts approximately 3-21 days, with an average of 9 days. The bitch will allow the male to mount and breed her. Most bitches have straw-colored discharge at this point, although some may continue to be blood-tinged. Hormonally, estrous usually begins at the time of the luteinizing hormone (LH) surge, which lasts 24-48 hours. This coincides with a rise in progesterone concentrations, which are generally 2-3 ng/ml at the LH surge. Ovulation occurs 2 days after the LH surge, the eggs require 2-3 additional days to mature to allow fertilization, and then the eggs remain fertile for 2-3 days. So the best conception rate and litter size are achieved by breeding 4-7 days after the LH surge. Progesterone concentrations continue to rise, and are about 5-8 ng/ml at ovulation and 4-20 ng/ml during the fertile period.

The next stage is **diestrus**, which lasts about 56 – 58 days from ovulation. The bitch's vulva is no longer swollen, and she will not stand to be mounted. Blood concentrations of progesterone remain elevated, and the bitch may experience a false pregnancy even if she was not bred.

Anestrus lasts for 2-9 months, sometimes longer in certain breeds (sighthounds). During this time period, uterine involution (the process by which the uterus contracts to its non-pregnant size after the delivery of the young or enlargement during the heat cycle) occurs. Progesterone levels gradually decrease.

#### Management of the bitch for optimal fertilization and litter size:

Both the male and female should be vaccinated, free of internal parasites, in good health, and tested negative for *Brucella canis*. Recall that when the bitch initially comes into heat (proestrus), her vaginal discharge will be serosanguinous (straw-colored and blood-tinged), and she will reject the male. When she reaches estrus in an average of 9 days (but it may vary as much as 3-21 days), her discharge will typically become straw-colored and clear, and she will show interest in the male. Begin progesterone testing at this time (send the sample to an outside lab, do not use the in-house test as it is unreliable), and continue testing every 48 hours until the level is 2-3 ng/ml. This level coincides with the LH surge. Recheck the progesterone the next day to confirm that it is continuing to rise.

Remember that ovulation occurs 2 days after the LH surge, and then the eggs require 2 – 3 days to mature to allow fertilization. So, **optimal breeding time is 4 – 7 days after the LH surge** with fresh (side-by-side collection) and fresh-chilled semen. If semen is available for two breedings, then the bitch

should be inseminated on days 5 and 7 after the LH surge. If only one breeding can take place, then it should be done on day 5 or 6 after the LH surge.

Artificial insemination with fresh semen involves depositing it vaginally immediately after collection. There are pipettes made specifically for AI in the bitch, and these and a syringe are all that is needed to perform vaginal insemination. The non-lubricated pipette is inserted into the dorsal (towards the back) apex of the vulva, then over the brim of the pelvis, and into the cranial (towards the head) vagina near the cervix. Next, the bitch's hindquarters are elevated to a 45-degree angle, and the semen is injected through the pipette, followed by a small amount of air to flush any remaining semen into the vagina. After removal of the pipette, the bitch's hindquarters are elevated for one minute. You may have read that the bitch's rear should be elevated for 10 - 20 minutes after insemination, but a published study demonstrated the same pregnancy rate in bitches that were elevated for 1 minute vs. 10 minutes.

Using fresh-chilled semen (also called chilled shipped semen or chilled extended semen) to inseminate a bitch requires a coordinated effort among the stud dog and bitch owners, the Veterinarian collecting, extending, and shipping the semen, and the Veterinarian inseminating the bitch. Not all male dogs, especially inexperienced ones, will cooperate with the collection process in a Veterinary office without a bitch in season present. It is advised to practice collection with the male well ahead of time before any semen is needed to overcome this potential issue. It is also advised to perform a "test shipment" with his prepared semen to ensure that it will withstand collection, extension, and chilling without detrimental effects on semen quality. Extension involves providing an energy source and pH buffer to enhance the survival of the chilled sperm cells; however, not all semen reacts the same to extension, and different preparations may need to be tried. Additionally, consider that the semen may not be able to be sent out or received on the appropriate day (No Sunday deliveries!).

Once received, no special preparation with fresh-chilled semen is needed other than setting aside a small aliquot to determine motility and sperm concentration. Vaginal insemination (as done with fresh semen) should ideally occur within 24 hours of collection and extension, thus the need for overnight delivery. The optimal day for insemination is 4 days after the LH surge, but multiple breedings should be done to increase the conception rate.

Artificial insemination with frozen semen is far more complicated, as it requires starting with good-quality semen, special preparation and packaging methods, freezing, and a storage facility. Additionally, it must the thawed properly, and insemination of the bitch is either surgical or transcervical, with the thawed semen deposited directly into her uterus, and timing is critical. Thus, artificial insemination with frozen semen is best left to those who are experienced with it.

#### Research

The team that brought everyone together for Juvenile Dilated Cardiomyopathy research is looking for a new project to focus on and we are hoping to gain breeder and support in researching Protein Losing Enteropathy (PLE). This is an umbrella term that includes diseases such as inflammatory bowel disease and lymphangiectasia. We are hoping to collect DNA, so if you have a dog that has been diagnosed with a form of PLE, please contact me.

#### Canine Influenza Update

Regina wrote an informative article about the canine influenza virus (CIV), please take the time to read it. The International Boarding & Pet Services Association held a webinar with Dr. Melissa Bourgeois DVM, PhD, DACVM (virology and immunology) in June, which I joined. I have taken some time to go over CIV vaccine statistics and research documents made available by Merck Animal Health, the vaccine manufacturer.

I purchased a batch of vaccines and split it with another breeder (a batch has 25 doses and can cover 12 dogs). The batch I ordered did not expire for a year so I could have used the left overs for my annual boosters if I had not found someone to split it with. We used the bivalent vaccine manufactured by Merck. It is the only vaccine that covers both CIV strains and is widely available now. The vaccines need to be boostered 2 to 4 weeks after the first vaccine and then annually after that. Dogs who are boarded, who attend dog events, or who have contact with dogs through dog parks, training classes, etc., are all considered high risk. I urge everyone to take this seriously. The infection rate for H3N8 is 100% for dogs who are exposed, even though some may not show symptoms they are still capable of infecting other dogs. Data is still being gathered about the new strain, H3N2, but we know that the infection rate for H3N2 is greater than 80%.

Dogs can shed the H3N2 virus for up to 24 days. This means dogs that appear healthy are still contagious for nearly a month. You have no way to know if your dog has been exposed until it is too late. The incubation period after exposure is up to 7 days so if you plan to vaccinate, it is advised to wait one week after your last dog event to begin or booster the vaccine.

I have heard people say that there is no point in getting the vaccine when the dogs could still get sick. The vaccine is not a live virus so your dog cannot get sick from the vaccine. It is true that the vaccine will not always prevent illness if your dog is exposed, but the vaccine reduces the amount of time your dog will be sick, the length of time it will be spreading disease and it prevents CIV from progressing to

the point of causing permanent damage to the lungs or deadly pneumonia. This disease is not going to disappear in a few months so the argument that it takes too long for dogs to gain immunity after receiving the vaccine is simply not logical.

I know others are concerned about safety. As of early June, more than 7 million dogs had been vaccinated and the risk of a vaccine reaction is extremely low. I did choose to vaccinate my senior dogs who range in age from 10 to 14 years and we had no vaccine reactions. I also know someone who vaccinated some immune compromised dogs who would certainly die if they contract CIV and her dogs were also fine. The vaccine should NOT be given to animals who are pregnant or nursing. Puppies can be started on the vaccine as early as their 2<sup>nd</sup> DHPP booster.

#### **AMTC Rescue Chair Report**

AMTC Rescue has received and approved grant requests to cover vet care for 3 dogs rescued by Robin Gates and Dina Sellers. Two of these dogs have been adopted and a senior female is currently with Dina in Texas and ready for her new home. A grant was also paid out to cover vet care provided to a senior that Madonna Lee rescued in Florida. The board also approved a grant for a foster home that cared for two of the Dillard dogs. They were spayed and neutered and adopted out to pet homes.





Also, please be sure to complete the health survey. It will be open until September. While we had a lot of early submissions it has hit a plateau and there are so many of us breeding. It's completely anonymous and meant to gather info about the health of our beloved little black and tans.

Some truly lovely <u>guidelines</u> pertaining to end-of-life care for pets have recently been published. I use the word lovely because everything within this document feels exceptionally loving and humane, not only for the animals, but also for their human companions. The guidelines were a collaborative effort, created by the <u>International Association for Animal Hospice and Palliative Care</u> and the <u>American Animal Hospital</u> Association.

Here are some examples that will give you a sense of the wisdom and compassion found within these Endof-Life Care Guidelines.

End-of-life care and decision making embody the critical final stage in a pet's life and are as important and meaningful as the sum of the clinical care provided for all prior life stages.

End-of-life care should focus on maximizing patient comfort and minimizing suffering while providing a collaborative and supportive partnership with the caregiver client.

Timely, empathetic, and nonjudgmental communication is the hallmark of effective client support. Veterinarians should not allow an end-of-life patient to succumb to a natural death without considering the option of euthanasia and ensuring that other measures to alleviate discomfort and distress are in place. Hospice care

The end-of-life care guidelines defines animal hospice as follows:

A philosophy or program of care that addresses the physical, emotional, and social needs of animals in the advanced stages of a progressive, life-limiting illness or disability. Animal hospice care is provided to the patient from the time of a terminal diagnosis through the death of the animal, inclusive of death by euthanasia or by hospice-supported natural death. Animal hospice addresses the emotional, social, and spiritual needs of the human caregivers in preparation for the death of the animal and the grief experience. Animal hospice care is enhanced when provided by an interdisciplinary team approach.

There are many similarities here between animal and human hospice care. The major difference is that, in human hospice, death is neither hastened nor postponed. With the exception of a handful of states, euthanasia is not legal in this country.

Some people do not believe in euthanasia for their pets, and these guidelines accept that the pet owner has the ethical and legal right to choose for or against this process. However, animal hospice does not accept the decision to allow a pet to die without euthanasia unless effective measures provided by a veterinarian are in place to alleviate discomfort and distress.

#### Hospice care pyramid

The end-of-life care guidelines feature a three-tiered "Animal Hospice Care Pyramid" that illustrates the many ways in which the hospice patient's care is to be managed. The base of the pyramid addresses the components of maintaining the patient's physical comfort, including:

· Pain management

- · Management of symptoms
- Hygiene
- Nutrition
- Mobility
- Safety
- · Environmental needs

The middle tier addresses the animal's social engagement with family members, both people and other pets in the household. The goals are to provide mental stimulation and avoid social isolation.

The very top of the pyramid addresses the emotional needs of the animal specifically at the end of his or her life. The objectives here are preservation of dignity (maintaining grooming, managing self-soiling with urine and feces), stress reduction, and, to the greatest degree possible, preserving the animal's role in the household such as providing human companionship and barking at the UPS truck.

#### Client support

Found within these end-of-life care guidelines is a lengthy description of how hospice veterinarians can attend to the emotional needs of their clients. It is well recognized that most people begin the grieving process for their pets well before death occurs. It makes sense then that hospice care veterinarians must be prepared to provide emotional support at the time of their very first client interactions.

#### Other topics

The end-of-life care guidelines are rich with other important information including the specifics of the euthanasia process. Throughout, empathy is stressed. An example is, "Never rush the process- clients want, and and need your undivided attention and you have an obligation to give it to them."

The guidelines also address compassion fatigue amongst veterinarians and their staff members. In depth suggestions for detecting this issue and providing emotional self-care are included within this document.

I encourage you to take a look at these <u>end-of-life care guidelines</u>. While no one wants to think about the loss of a beloved animal, reading this piece is ironically restorative in the sense that it's filled to the brim with suggestions for creating a loving and gentle final passage.

Would you ever consider hospice care for your pet?






