

REPORTS FROM THE SECRETARY

American Manchester Terrier Club January 25, 2017 Teleconference Board Meeting

President, Jeremy McClister brought the January teleconference meeting to order at 7:43 p.m. CST. Present: Jeremy McClister, Roberta Berman, Kathy Nissen, Sherrie Brock, Beverly Leidner, Ellen Murtagh, Sue Thrasher. Absent: Dianna Texter, Christina Caridis.

Minutes of the December 7, 2016 board meeting were provided via email for board review prior to this meeting. Sue Thrasher made a motion to approve the December 7, 2016 Board Meeting minutes. 2nd by Roberta Berman. All in favor, motion carried.

Jeremy noted our 2017 AMTC National will be held during the AKC/Royal Canin event in December. Recently, the board was made aware there might be some question as to whether breed specialties would be held during this venue which put this location in question, however, Show Chair, Carolyn Horowitz, has now been given the go ahead to continue planning our upcoming National event.

Our 2018 National will be held in Lexington, KY during Labor Day weekend. More information in future newsletters.

The AKC contacted President, Jeremy McClister, requesting the possibility having a member with standard Manchesters who is actively involved in all aspects of the purebred dog world - breeding, exhibiting in conformation, performance, etc. for an informational breed video for their website. The board is compiling a list of members for consideration.

A motion was made by Sherrie Brock: Due to the sensitivity of personal information contained within the AKC Awards as provided by the AKC to one board member (Roberta Berman)by paid subscription utilized for compiling breed awards for accomplishments of Manchester terriers, the information will not, currently or in the future, be distributed to any club member. Motion 2nd by Sue Thrasher. All in favor, motion carried. (It was noted this information – with the sensitive information removed - has always been made available by Roberta for distribution at our yearly National events and may be requested if not in attendance.)

With expenses rising for publishing/mailing the club newsletter it was discussed that those members wishing to receive hard copy pay a subscription fee. The fee would be \$15/year, however, since the February issue is due to be published shortly, a prorated subscription price of \$12 will be the cost for the remaining 2017 issues. This does not apply to those members who do not have access to email or a computer. The website will be updated for receiving the newsletter via email, web view or hard copy subscription. Motion to institute a subscription fee for hard copy club newsletter at the cost of \$15 per year beginning 2018 and \$12 prorated for 2017 made by Sue Thrasher, 2nd by Sherrie Brock. All in favor. Motion carried.

District 2 is still in need of a Governor. If you reside in this district, please consider volunteering for this position.

Information pertaining to the AKC Outstanding Sportsmanship Award, formerly known as Good Sportsmanship Award, will be published in a future newsletter. In the meantime, please begin thinking of a club member you feel would be a good candidate to receive this award.

According to the Club's By Laws Article 1 Section 2. "DUES: Membership dues shall be set by the Board of Directors and shall become payable on or before the first day of January of each year...." The AMTC has not had an increase in membership dues for several years. Our General Fund operates mainly from payment of membership dues and donations marked for same. In order to avoid possible low GF balances in the future, a motion was made by Sue Thrasher to raise single and family membership dues by \$5.00 effective for 2018 dues payments. Dear Kathy,

Thank you for considering us for membership in the American Manchester Terrier Club. HEALTH REPORT

What is Legg-Calve-Perthes Disease? By Regina R. Allen DVM

Legg-Calve-Perthes Disease, also known as LCP or Ischemic Femoral Head Necrosis, is hip joint disorder that occurs in both humans and dogs. It is sometimes called "hip dysplasia of little dogs," but this is a misnomer, as the two disorders have nothing in common in how they occur.




Figure 2. Normal and Abnormal dog hip.

The hip is a simple ball and socket joint. In normal hips, the femoral head (ball) fits snuggly in the acetabulum (socket), without visible space between them (Figure 1). LCP is caused by interruption of the blood supply to the femoral head, causing avascular necrosis, or death of bone cells (Figure 2). Infection is not involved.

This is the previously-mentioned necrosis that occurs with LCP.

Symptoms of Legg-Calve-Perthes typically appear in Miniature and Toy breeds between four months and one year of age, with a peak incidence at about seven months. Affected dogs display stiffness, lameness, and pain on extension in the affected leg. The condition is usually present in one leg only. These symptoms occur as bone cells die due to interrupted blood supply, then resume their blood supply and remodel the femoral head, creating an irregular fit in the acetabulum. Eventually, the femoral head collapses, causing shortening of the affected leg, significant pain, and obvious lameness.

Treatment can be conservative or surgical. Conservative treatment consists of four to six months of strict crate rest, with leash walks only to potty. Conservative treatment is only successful if there is no remodeling or collapse of the femoral head, and the confinement protocol is strictly adhered to.

If conservative treatment fails or the owner is unable to comply with strict rest or there is femoral head remodeling or collapse, then surgical treatment is indicated. Surgery involves removal of the diseased femoral head, creating a "false joint," which relieves the pain. The small size of the patient enables the dog to walk with a normal or nearly normal (shortened stride) gait.

If left untreated, dogs with LCP will have significant muscle atrophy, osteoarthritis, and become severely crippled and painful. Anti-inflammatory pain medications such as Rimadyl, Metacam, or Deramaxx are indicated to help relieve pain and improve function. 3

Legg-Calves-Perthes (LCP) is not caused by trauma, and is believed to be genetic, although the exact mode of inheritance is not known. The Manchester Terrier is considered an "at risk" breed by the Orthopedic Foundation for Animals (OFA). Additionally, the OFA recommends not breeding dogs affected with LCP.



Manchester Terriers

*25 USES FOR A MANCHESTER

 Foot Warmer in Bed. Takes one Standard or two Toys.

 Non-Toxic Spill Clean Up (e.g., Rice Krispies). Takes one Standard or one Toy; more than one of each can cause a toxic spill (i.e., blood).

 Vermin Control. Good for eradicating mice, rats, insects, snakes and anything perceived as such–squeaky toys, fleecy slippers, anything furry.

 Sentry Duty Outside. Warn of impending danger from squirrels, dogs, cats, birds, people, wind blowing.

 Sentry Duty Inside. Takes just one of either variety; add more for additional volume. Function activation is a cross between a motion detector and a clapper.



In Memorium

January 24, 2017, the Manchester terrier community lost one of the most dedicated, loving and caring persons ever involved with the breed. Cloydett Stickney peacefully passed away to join her husband, Kenny who passed away July 1, 2012, and the many Manchesters that passed before them. Ken and Cj, as she was affectionately known, were Bit O Luck Manchesters...a prefix well known to many long time Manchester fanciers and in many many Manchester pedigrees. Few Manchester fanciers are aware of how their involvement with the breed began and it truly was a "bit o luck"....

Many many years ago, a beautiful cold, hungry, shivering sweet dog was found outside just a little "bit" from their home in Walton, Nebraska. They took him in to their home. They didn't recognize what breed he was way back then although knew he was a purebred. They did some research and contacted long time Manchester terrier breeder, Ruth Guthrie, who immediately recognized his ear crop. After tracing him back to his original breeder in Washington, it was found he had been sold to someone who couldn't keep him and was given to a relative who also ended up placing him and again he was given away to someone who had mistreated him. He ran away and was "lucky" enough to be found near their home. He soon became a much loved member of their family. This sweet dog won their hearts and they fell in love with the breed. This cold hungry dog went on to become Brandyman's Mr. Pibbs (with a Terrier Group 2 & 3 to his credit) and the foundation of Bit O Luck. Soon after, (Ch.) Whiteoak Lady Diane (CD) - bred by Ruth Guthrie – joined their family. Brandyman and Whiteoak prefixes go back many years and later on, Ruth sent Whiteoak Khamir Le Baron to Ken and Cj's family of black and tans. If one were to hazard a guess, many of the dogs you own/owned over the years very well may have Bit O Luck somewhere in their pedigree. Many of their dogs are listed in our AMTC Hall of Fame and many of the dogs they placed have achieved great accomplishments in the show and performance rings in the States and Canada.

Both Ken and CJ became involved in showing in conformation and obedience and eventually, after a great deal of research into the breed and a great deal of thought and consideration pertaining to what is involved, breeding. In 1981, they joined the American Manchester Terrier Club and attended almost every National event until Kenny's death. Ken also served on the AMTC Board of Directors and Ethics Committee at one time. They were also very active members in the Cornhusker Kennel Club where they met and became good friends with Lourene Wishert (Lilac Farms, Bennett, Nebraska) who bred and showed toys, as well as a brace in the 1940s. Eventually, it was time to infuse new lines into theirs so they acquired Shal Mar's Salutaire Stil In-Flite (Derek) and Shal Mar's Bit O Luck Khaptain K (Snickers) from Gerrie Hart.

Ken and Cj never knew a stranger. They were always willing to lend a helping hand or answer questions from anyone whether new to the breed or long time fanciers. One of their favorite things to do whenever there was a national, district specialty or all breed show in the area, was to invite everyone to their home for a potluck meal and good old fashioned country hospitality. Those gatherings were always a good time and enjoyed by those who came.

When Cj was no longer able to remain home with her beloved manchesters after falling and breaking her hip, their last two, Ch. Bit O Luck's Close E'Nuf (Annette) and Bit O Luck Shyann, spent the rest of their lives warming my heart and lap in my home. To my knowledge, there are no longer any true Bit O Luck bred dogs living today but all those that have passed are now reunited with their beloved Ken and Cj. There are, however, a few remaining that have a true Bit O Luck sire or dam.

Ken and Cj's love and knowledge of, devotion, and contribution to the breed and the manchester community will be greatly missed.

AMTC member Jeanne Dalesky left us August 25, 2016 to join the others that have preceded her in death, to the Big Showing up above.

Jeanne was a long time member of the AMTC and wore different Badges throughout the years. She will long be remembered as a hard worker, extraordinary mentor and her never ending love and knowledge of our breed, the Manchester Terrier.

Jeanne's involvement in the breed came early, as her mother was a breeder of Toy Manchester Terriers.

Starting her Standard line with a dog Ruth Turner entrusted to her, was CH. Classey Chip Of Chatham. Chip went on to sire 16 Champions. Jeanne proudly bred her Toy and Standard lines under the legendary Hidden Hill prefix.

Perhaps the most important dog Jeanne produced was CH. Hidden Hill's Tic-Tac CDX, owned by Sue Moody of Invermood fame. Tic-Tac sired 17 champions, several of whom also had back end titles.

The best producing of her Toys was CH. Hidden Hill Hardly Here with 12 champions.

Jeanne's other big producers were CH. Hidden Hill's Hallmark CD with 9 champions and CH. Hidden Hill's Bartley of Do-Bain CD with 6 champions plus two Utility Dog Titles.

So, list of the most prominent dogs of Jeanne's that highly influenced the breed throughout the years are as follows:

CH. Classey Chip of Chatham CD HOF ROM – 16 titled get (S)

CH. Hidden Hill's Tic-Tac CDX HOF ROM – 17 titled get (S)

CH. Hidden Hill's Hardly Here HOF ROM – 12 titled get (T)

CH. Hidden Hill's Hallmark CD HOF ROM – 9 titled get (S)

Jeanne's Hidden Hill Manchester Terriers were no stranger when it came to HOF and ROM dogs. There were many with 4 get to their credit. Listed here are only the seriously big boys!

Also, Jeanne had many dogs with both front and back end titles who might not have been big producers, however, certainly did add to the glory and luster of the breed simply because of their accomplishments!

Hats off to you my friend and mentor, until we meet again. We will never forget "our" Jeanne Dalesky. God's Speed.


