REPORTS FROM THE SECRETARY

American Manchester Terrier Club
January 23rd, 2019 Board Meeting Minutes

President, Susan Thrasher, brought the January 2019 meeting of the American Manchester Terrier Club (AMTC) Board of Directors to order at 7: 35 p.m. CST.

Roll Call: Pres.: Susan Thrasher, 1st V.P: Christina Caridis, 2nd V.P. : Roberta Berman, Secretary: Kathy Nissen; Treasurer: Dianna Texter. Board members: Jean Good, Beverly Leidner, Patrick Mackesey, and Ellen Murtagh. The necessary quorum was in attendance.

President's Report: Susan welcomed the members of the 2019/2020 term AMTC Board and looks forward to a very productive term.

Susan asked for a motion to approve the December 2018 AMTC Board meeting minutes as drafted with corrections. Motion to approve: Beverly Leidner. 2nd: Roberta Berman. All in favor. Motion to approve the December Board meeting minutes carried.

Secretary's Report: Kathy requested the meeting minutes contain information discussed during each monthly board meeting with the exception that proposed revisions, etc. pertaining to SRs and/or Guidelines be published separately, as required, in order to ensure the membership make note of these proposed revisions when these items are put to a membership vote at a later time. It has been noted these revisions, while approved by the board and prior to membership ratification, may be overlooked when the minutes are read.

Treasurer's Report: Dianna provided her financial report which can be found elsewhere in this issue of the NL. She also requested the board make a motion to vote to reinstate a lapsed family membership and waive the \$10 late fee. A motion to reinstate the lapsed family membership and waive the late fee was made by Kathy Nissen, 2nd by Jean Good. All in favor. Motion carried. Note: This lapsed membership did not exceed the two(2) year time limit for board approved reinstatement as noted in the By Laws under Article 1: Membership: Section 5, therefore, the board did not incur the late fee with the reinstatement.

Christina Caridis provided an update on the upcoming 2019 AMTC National. She informed the board that Jessica Lynn Stover has offered to design the logo for the National at no cost to the club. As a gesture on behalf of the AMTC, Christina would like to personally offer to pay Ms. Stover's membership dues for 2 years should she wish to join.

Christina also noted she is working closely with 2020's National Chairperson and Dist. 2 Governor, Jerri Hobbs, in locating a location for the event. Currently, the proposed location may conflict with Woofstock and attendance at a location for a National that falls within a week of this well attended show on the opposite side of the country might be affected. Patrick Mackesey will look into other show site locations, dates and events offered in the Dist. 2 area and report back to the board when he has gathered the information.

REPORTS FROM THE SECRETARY, Cont.

Unfinished Business:

Proposed formation of three (3) new committees:

Juniors/Legacy Trophy Committee - Judi Fleischaker, chairperson. Kathy received a response from Judi noting she is hoping to have the draft of the committee's purpose finalized by the end of this week (January 25th, 2019). Kathy will submit this to the board upon receipt.

MTOY Committee – Robin Gates, chairperson. As you may or may not know, Robin's mother has been dealing with a health issue, therefore, Robin has not been able to draft the information for presentation to the board. Susan will contact her at a later date. The AMTC Board wishes Robin's mother a full and speedy recovery.

Performance/Agility/Obedience Committee: Roberta Berman is working on combining these important events in to one committee. Jean Good has offered Roberta her assistance.

Charitable Venues for AMTC Fund Donation(s): Tabled until next month. Dianna was to research various venues and report her findings to the board but had to leave the meeting prior to discussion of this agenda item.

Donations to AKC CHF Theriogenology Foundation and National Animal Interest Alliance: After discussion, a motion to donate \$150.00 to each organization this year made by Patrick Mackesey, 2nd by Ellen Murtagh. All in favor. Motion carried. The board will review this donation on a yearly basis.

New Business:

The board tabled until next month's meeting, the review of past and current club committees and whether or not to propose removal of those committees that have not been active or productive; and possibly reinstate those that have been previously removed from the Standing Rules that would still be beneficial to the club as well as, revisiting verbiage and purpose to existing committees. Following board discussion and possible approval, any changes to the committees would need approval by a vote of the membership.

Kathy noted an aged out Junior's membership was paid as a 'family' membership and until such time as the By Laws are reviewed, voted on by the membership for approval revising types of membership, the Junior in question will need to pay individual membership dues.

AKC Archives: Roberta Berman provided the Board with information pertaining to the AKC Archival Donation. In summary, (1) The AKC would preserve the material record of the breed and its parent club's operations, functions, and activities. (2) Contribute to the efforts of the AKC Library & Archives to comprehensively chronicle the history of the sport of the purebred dog. (3) Secure a permanent storage solution for your club records, which will be organized, described, and preserved according to professional standards and best practices. (4) Make information about your breed available to a larger researcher base.

With this information being presented, and with a member request for AMTC Archives information being a concern due to fragility of requested materials, Roberta will request Chairperson, Ginny Antia, provide an updated itemized listing of AMTC Archives content and their condition. Any further action regarding this was tabled until the next meeting.

REPORTS FROM THE SECRETARY, Cont.

Cloud or similar storage option: Christina asked the board about possibly engaging the use of a Cloud or similar online storage service for retention of club documents. This was tabled until next month's meeting in order for Christina to gather more information on the services available and amount of storage available.

Proposed Change of Date for Mailing Deadline of AMTC Membership Directory to April 15th each year: Kathy informed the board the Standing Rules and Guidelines list two different dates for final mailing of the directory. SR state April 1st of each year. Guidelines state May 1st. While the directory is continually updated on a monthly basis with new members, it is still quite time consuming. The board also realizes the SR supersede the Guidelines but also is in agreement the April 1st deadline is too short of timeframe to make revisions, corrections, have it proofed, printed, prepared for mailing and mailed following the March 1st grace period for dues renewal. With this being a possible revision to the Standing Rules, this will need to be voted on by the membership at a later date.

No further business. Motion to adjourn the January 2019 meeting of the AMTC Board of Directors made by Roberta Berman. 2nd by Beverly Leidner. All in favor. Motion to adjourn carried.

Motion to approve the January 2019 AMTC Board meeting minutes made by Christina Caridis, 2nd by Patrick Mackesey. All in favor. Motion carried.

Treasurer, Dianna Texter, provided the financial report which can be found elsewhere in this newsletter. Dianna noted an issue with Staples regarding the printing of our quarterly newsletter and will contact editor, Cheryl Roach, to find out if there is another option available for printing the newsletter. Dianna suggested the board look in to purchasing an accounting program for club finances and will research various programs that would best benefit our accounting needs.

1st V.P. Christina Caridis discussed the By Laws revision and asked the board to approve the proposed revisions ,as agreed to by the committee, for presentation to the membership for a vote by secret ballot. The By Laws revision packet will be sent to the membership with the 2019 AMTC Directory. Motion to approve final draft of By Laws revision as drafted, be presented to the membership for a vote made by Kathy Nissen, 2nd by Roberta Berman. All in favor. Motion carried.

Christina provided updates for the 2019 AMTC National and noted everything is going well. She also noted the weights are in her possession and will get them certified.

Christina requested the various online services for storing club info be tabled until such time more information is gathered for presentation to the board. The board agreed.

Concerns regarding the official AMTC e-list was discussed. While this e-list is noted as a means of official communication for the members of the AMTC in our SR/Guidelines, it is no longer being utilized as in the past by the membership. The board will review other options that are available and discuss these at a later time.

AKC Gazette Articles – A club member had a concern that articles pertaining to the Manchester Terrier had not been appearing in the AKC Gazette. Roberta Berman stated Ginny Antia no longer wished to provide articles for this publication. The board feels this information should be provided for publication and President, Susan Thrasher, will look in to this and report back to the board.

Following board review of the 2020 AMTC National proposal as submitted by showchair, Jerri Hobbs, a motion was made by Kathy Nissen and 2nd by Christina Caridis to approve the proposal for our 2020 AMTC National event to be held in Lexington, KY during Labor Day weekend. More info is forthcoming in future newsletters. Kathy noted the judge selected by membership vote, Betty Ann Stenmark, is not available to judge our national event and has contacted the next candidate with the 2nd highest vote count, Sari Brewster Tietjen, and as of March 10th, has not heard back so she will contact via phone.

Possible revisions regarding percentages of disbursement of funds generated from our annual raffle and auction is being researched by the board since several members have requested the proceeds from their donated items be specifically given to Rescue, Health, etc. This would be a revision to our current SR/Guidelines but deemed a necessary revision. Further discussion will take place at the March 2019 board meeting.

No further business. Motion to adjourn the February board meeting made by Roberta Berman. 2nd by Patrick Mackesey. All in favor. Motion to adjourn carried. Meeting adjourned at 8:52 p.m. CST.

Absent: Christina Caridis.

The February 2019 board meeting minutes were sent to the board via email for review and possible approval prior to the March meeting. Motion to approve made by Beverly Leidner, 2nd by Roberta Berman. All in favor, motion to approve the February 2019 AMTC board meeting minutes carried. Secretary, Kathy Nissen, noted the directory would not be mailed to the membership by the April 1st deadline due to the additional time needed for inclusion of the By Laws packet in order to utilize one membership mailing expense.

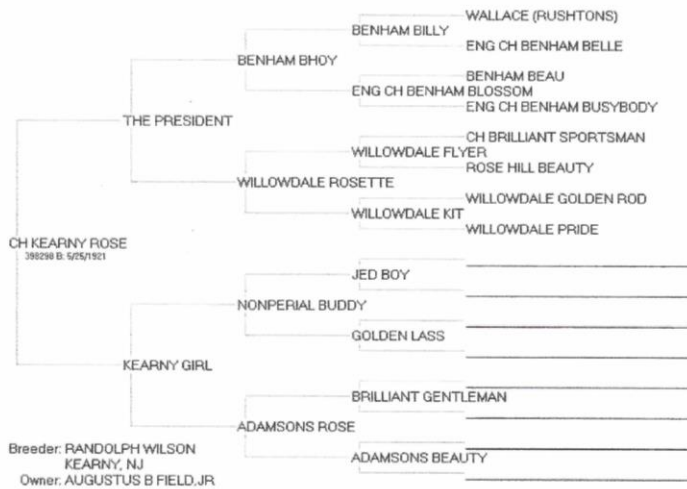

Field, Jr.** of **Sterlington, NY**. Somewhat later ownership changed to **T. Pearsall Field** of **New York City**. The majority of current **Manchesters** are direct or indirect descendent of **Ch. Kearny Rose** through her daughters **Fanfare Rose**, **The Vixen** and **Red Roof Rage**.

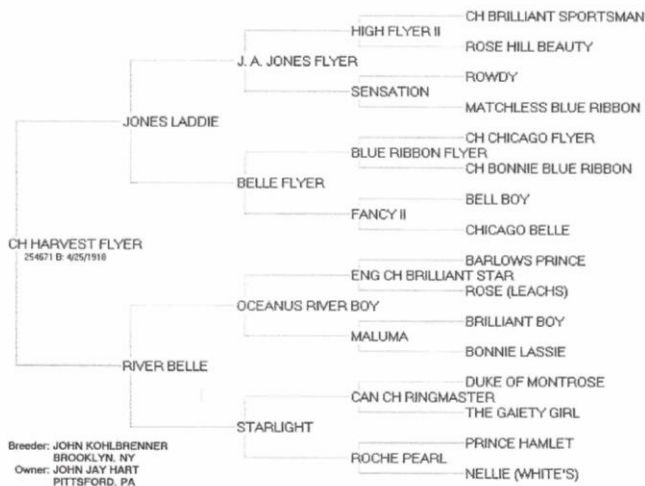

'Flyer' was acquired by **Mr. John Jay Hart** of **Pittsford, PA**. He was a popular sire producing such notable Standards as **Ch. Crystal Bandmaster**, **Ryrock Baby Peggy**, **Redroof Bantam**, and **Harvest Girl**.

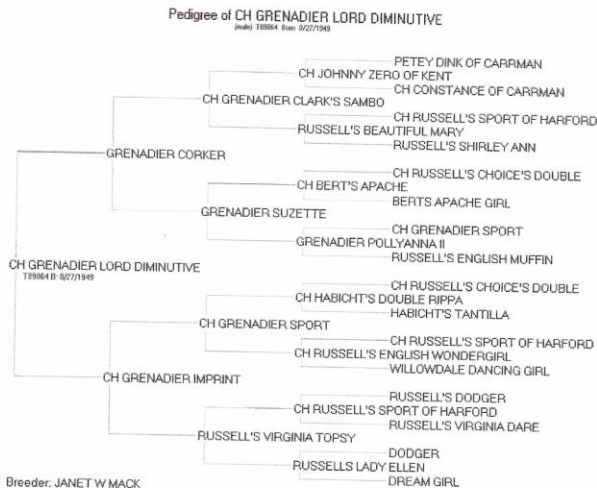

CH. GRENADIER LORD DIMINUTIVE

Ch. Grenadier Lord Diminutive was bred by Miss Janet W. Mack of New York City, Miss Mack bred one litter from before sending to Henderson Bratcher of the Jolly beggars' kennels in California. In California 'Lord Diminutive sired 8 champions, and several top producing non-champions all out of Jolly Beggars' bitches.



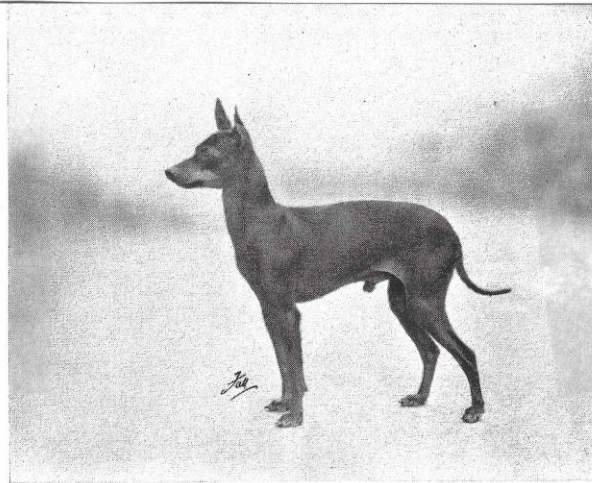
Janet Mack was a Canadian who emigrated to the United States in the early 1930s with several Standard Manchester Terriers. Her activity in Manchesters spanned the period from about 1925 to about 1968. She owned a townhouse in New York City which housed an exclusive pet shop which catered to the elite of the city. Late in the 1930s she acquired several Toy Manchester Terriers from Russell Clark which started her in the smaller variety. It is rare to find an extended pedigree in either Standards or Toys which doesn't contain the name of a Grenadier Manchester.

Janet Mack wrote for many dog publications and authored PET MANCHESTER published in 1956.

Miss Mack was also instrumental in the introduction and early development in the U.S. of the Bouvier De Flandre.

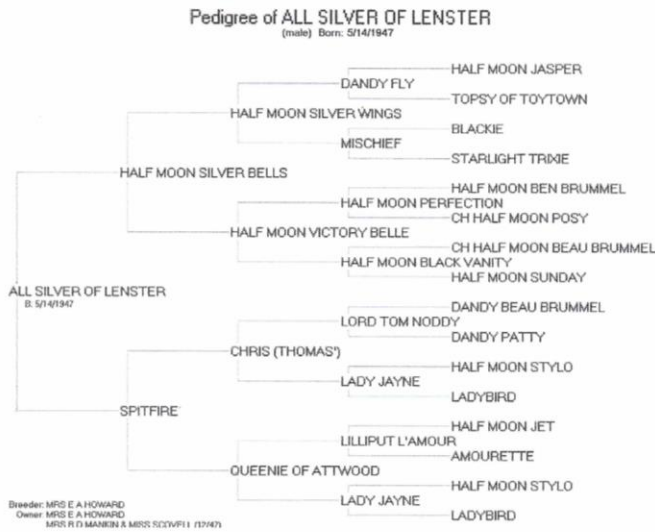
ALL SILVER OF LENSTER

All Silver of Lenster, an English Toy Terrier, was bred by a Mrs. E. A. Howard, and acquired as a puppy by the partnership of Mrs. B. D. Mankin and Miss E. Scovell, Lenster Kennels. Unfortunately he was never able to garner an elusive third challenge certificate necessary to gain his English championship. He proved his merit by siring two English champions and a host of important dogs. His daughter, Tandy Of Lenster, was one of the ETTs used in the crossbreeding program permitted by The Kennel Club to reestablish the Manchester Terrier which was on the verge of extinction.

 Mrs. Mankin's *All Silver of Lenster*

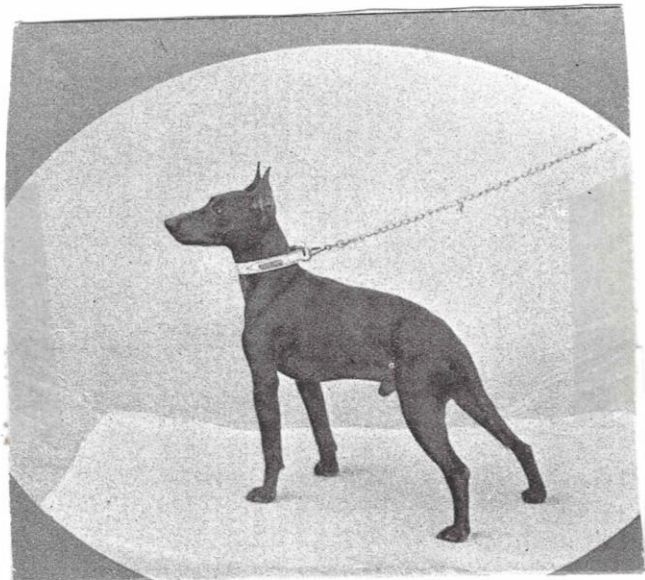
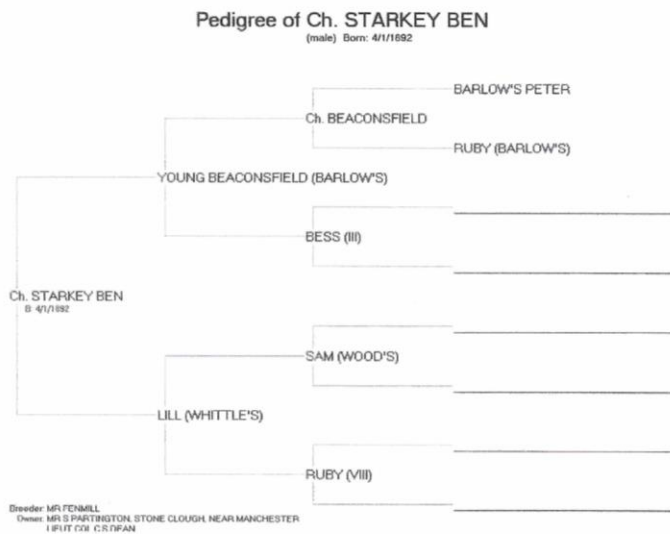

The Lenster kennels of Mrs. B. D. Mankin and Miss E. Scovell was a large breeding kennel that was active in English Toy Terriers from about 1944 to about 1972. Over the years they also owned Manchester Terriers (Standards) as well. The kennel was also well-known for their Bull Terriers.

ENG. CH. STARKEY BEN

Eng. Ch. Starkey Ben (also spelled Starkie Ben) was bred by Mr. Fenmill out of the unregistered bitch Lill sired by Mr. William Barlow's unregistered Young Beaconsfield. As a puppy his ownership passed to Mr. S. Partington. As a young adult he was acquired by Lt. Col. C. Stewart Dean. He sired one English champion, Benham Bounce. He has no current direct or indirect descendents.



Lt. Col. C. Stewart Dean of Bromborough Birkenhead and later Bebington, Birkenhead was active in Manchester Terriers as a breeder and exhibitor from about 1884 to about 1923. Beside Manchesters he was also deeply involved with Field Spaniels and fancy poultry. In the late 1890s a turn of fortune forced him into bankruptcy which necessitated the auctioning of his dogs as well as his property. To his credit he was able to reestablish his kennel and breeding program. Col. Dean was also a popular championship show judge.

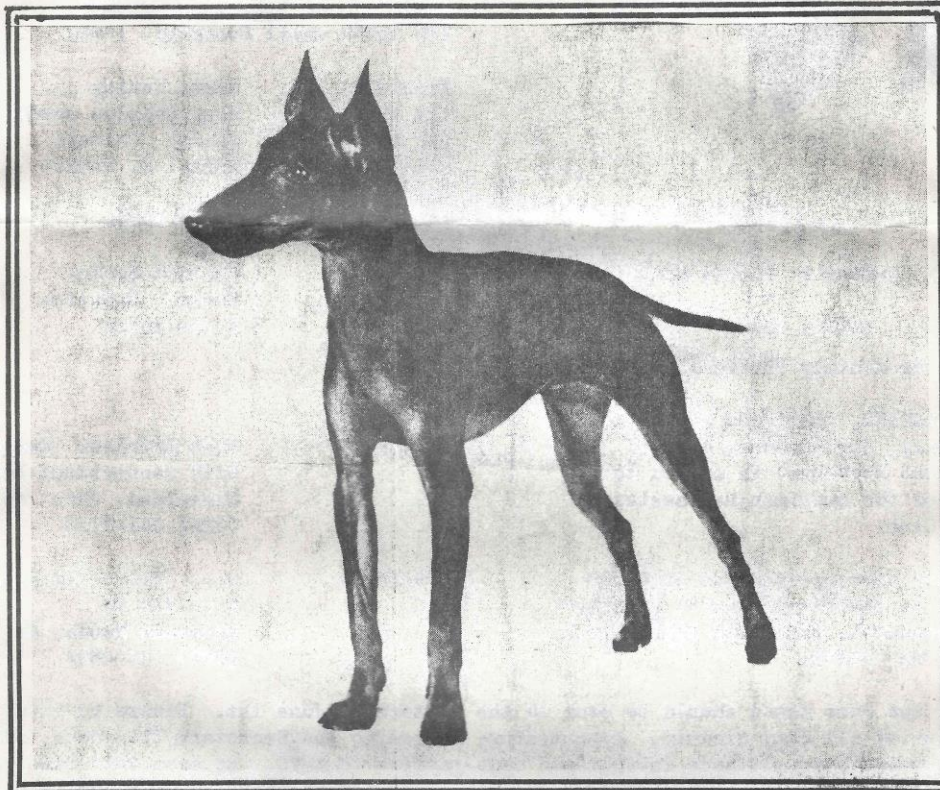

In 1963 she had been similarly honored by Dogs in Canada, when she was chosen as that magazine's representative of the standard of perfection, just as for years she had been the model for the breed in the Popular Dogs' "Visualizations of the Dog Standards."

Guidelines for Submitting Catalog Advertising Material to MB-F, Inc.

I. A BRIEF WORD ABOUT OUR CATALOG PROCESS — We publish our catalogs electronically, using *Adobe® Illustrator® 10.0, Adobe® InDesign 4.0® CS4 & Adobe® Photoshop® CS4* for the PCs running Windows operating system. All advertising, Premium Lists; Judging Programs; and the final catalogs, along with the covers, are produced using the same programs. All print and graphics are then sent to an imagesetter, where plates are made. Those plates then go onto our presses. And, finally, the printed pages are folded, collated, bound, and trimmed into the finished catalog.

II. PRODUCTION PROCESS — Once advertising has been received for a particular catalog, the ads are then arranged into packs according to the ad # you've assigned and the specifications given to us on the accompanying **Ad Control Sheet** per the advertising chairman's request. It is only by working with the submitted Ad Control Sheet that the typesetters and proofreaders know if we have received all your ads and whether we've placed them in the catalog as you wished. Then all copy is hand typed or put through an OCR program (Omnipage) that automatically converts information into a text file. That file is given a specific name for the club. When a pack is completed, it is then typeset and layed out in relation to the ad copy given. After setting, all photos and logos for the ads are scanned on a flatbed scanner and balanced for best results on our image setter. All ads are then proofread and checked for correctness.

PLEASE NOTE: — We are the printer of the material you are sending us. Because we use PC related hardware and software, any electronic files submitted from a Mac must be saved using the 3-letter extension associated with each program (see **COMPUTER—File Formats** below). Any converting of materials for our use will be the responsibility of the customer, not ours.

III. REQUIREMENTS FOR MATERIAL SENT IN FOR REPRODUCTION

- A. Original photographs (ie., show photographs, other professional photographs, snapshots, etc.) **ALWAYS** reproduce the best. Reprinted photographs & inkjet photographs reproduce the poorest.
- B. **No copyrighted material, including photographer proofs, may be printed without their express written authorization. If submitting such material be sure you include those authorizations.**
- C. All submitted material on disk **MUST BE** accompanied by a printed copy along with the exact file name of the file to be used. This assures that the information submitted is correct (layout, copy, and any artwork including photos) as to what is to be expected in catalog reproduction. *Note: Do not send images placed in a Word document as the only image to be used. Please send the original photograph or include a disk with the photo in one of the formats listed below.*
- D. If the fonts that you choose to set your ad in are not available to us, the fonts **WILL BE** changed to the closest match available. **DO NOT** send us your fonts; we cannot accept outside fonts.
- E. Please provide contact phone number (daytime & evening), e-mail address, and home address. This is in case the disk(s) do not reach us in operating order, are not usable, or are missing information.
- F. The measurements for ad size are 4½" x 7¾" for a full page, 4½" x 3¾" for a half page, and 4½" x 1¾" for a quarter page. Please do not exceed these measurements as reductions may affect final ad size.

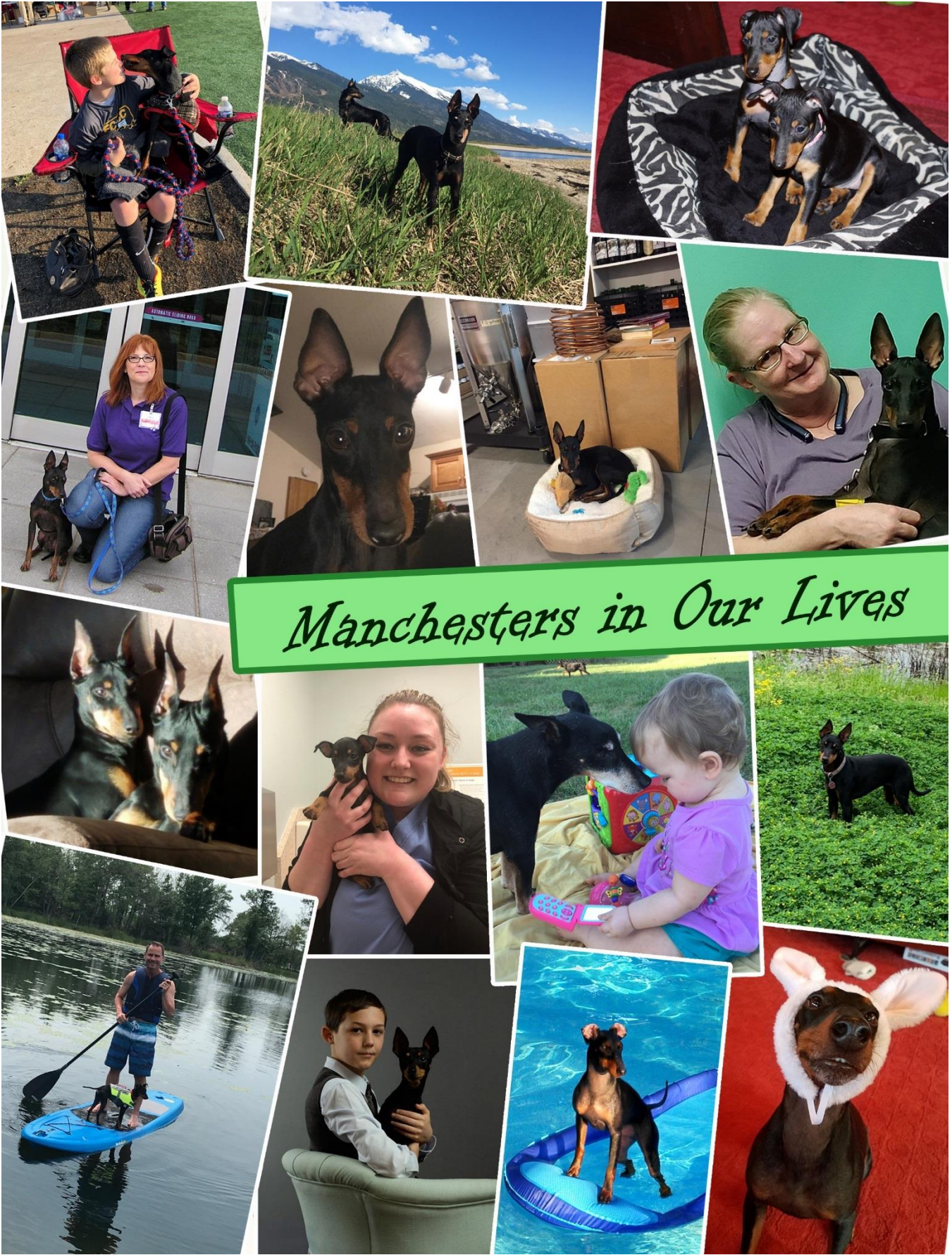

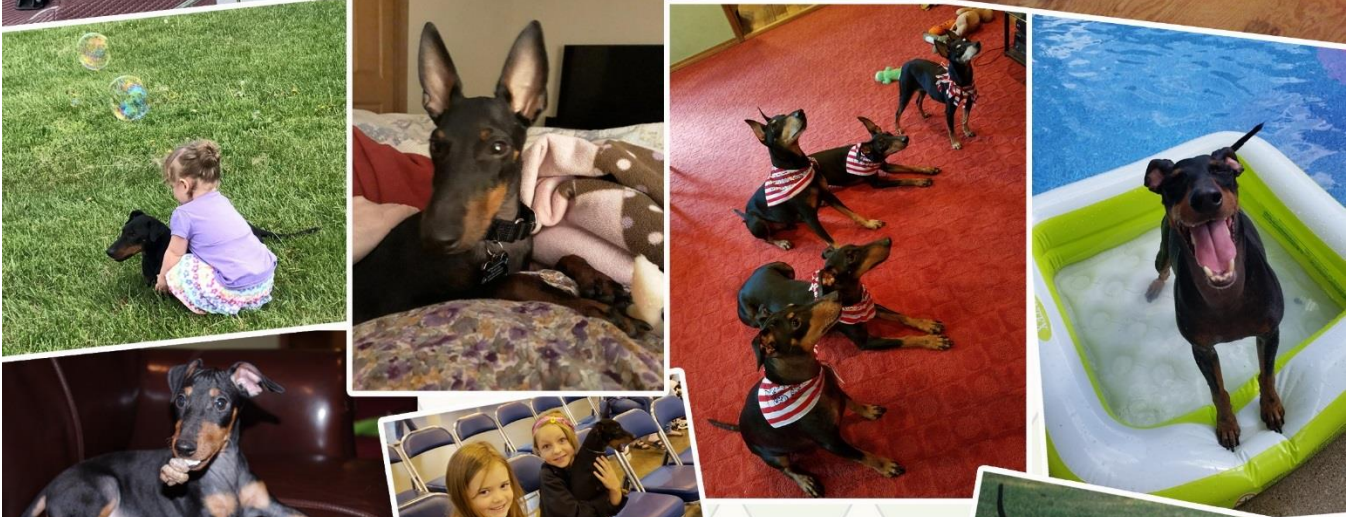

We have made tremendous strides in the last few years to find the genetic marker and develop a test for Cardiomyopathy and Xanthinuria but it is critical that we continue to work diligently with club members, veterinary clinics, research universities, and other breed clubs to increase our knowledge of such diseases as Leggs Perthes, Progressive Retinal Atrophy (PRA) and Protein-Losing Enteropathy (PLE). It is imperative that we learn as much as we can about the diseases that afflict our breed so we

can work to reduce and/or eradicate these diseases from the breed. We also need to work on judges' education, public education and an overall membership drive. It is of the utmost importance to encourage people (especially young people / Junior Handlers), that have our breed's best interest at heart, to get involved with the breed through agility, conformation, obedience, rescue and responsible breeding and pet ownership.

I would welcome the opportunity to serve you in the capacity of a Board of Director in the upcoming term.

American Manchester Terrier Club Code of Ethics

Membership in the American Manchester Terrier Club (AMTC) is a privilege. In return for acceptance into the AMTC, I promise to abide by the following Code of Ethics and to submit to the enforcement of this Code by the AMTC Board of Directors.

GENERAL

I pledge as an owner of Manchester Terriers to be responsible for the dogs in my care. My responsibilities include providing proper shelter which is clean, dry and warm; appropriate veterinary care and inoculations; emergency veterinary care when needed; quality food and water; adherence to local and state animal control and licensing laws.

BREEDING

I pledge:

1. To accept and uphold the Standard of the Manchester Terrier as developed by the AMTC and approved by the AKC.
2. To breed only physically and mentally sound Manchester Terriers in order to maintain or improve the qualities of the breed as set forth in the Standard. I will not participate in the indiscriminate breeding of studs or bitches with no regard to quality.
3. To screen or obtain proof of screening of breeding stock for communicable diseases, hereditary faults or defects, either active or dormant. Questionable animals will not be used in my breeding program.
4. To forego breeding unless financially capable and willing to responsibly and caringly maintain whelped puppies until placed in their new homes.
5. To maintain complete and accurate breeding records in accordance with AKC regulations.

SELLING

I pledge:

1. To in no way misrepresent any Manchester Terrier for sale.
2. To provide all buyers with:
 - A. AKC individual registration application or certificate properly filled out by seller.
 - B. Minimum three-generation pedigree.
 - C. Record of inoculations, worming, etc.
 - D. Provide instructions for feeding and care.
 - E. Be available for guidance and questions.
3. Not to sell, give, trade, abandon or in any manner transfer litters or individual Manchester Terriers to pet dealers, pet wholesalers, auctions, laboratories, raffles, pet stores, puppy mills, animal shelters, or any source for resale. I will not knowingly transfer ownership or provide stud service to anyone who intends to breed Manchester Terriers for any of the above listed purposes.
4. To take back any Manchester Terrier I bred if the current owner of the dog can no longer keep him or her. I will evaluate the dog as to whether or not s/he is suitable for placing in a new home. In the very unfortunate circumstance that the dog is not suitable, I will either keep the dog myself or provide proper veterinary euthanasia. In the rare event that I cannot take back a dog due to current personal circumstances, I will place the dog in AMTC rescue. I, the breeder, will reimburse any and all reasonable expenses incurred on behalf of a dog in this unusual situation to AMTC rescue.

EXHIBITING

I pledge:

1. To serve as an example of good sportsmanship in any aspect of the sport of dogs, assisting and befriending newcomers to the best of my ability.
2. To show only those Manchester Terriers which deserve to be champions in light of the Standard and which are in proper condition.
3. Not to kennel pack for points in conformation or to engage in any other unfair practices in competition.

PENALTIES

I acknowledge and accept for disciplinary purposes a sliding scale of penalties based upon the seriousness of the deviation from this Code of Ethics. The Board of Directors will apply penalties equally to any and all offenders after a proper review of the evidence. Penalties include but are not limited to: reprimand from the Board; temporary suspension from AMTC membership; permanent suspension from AMTC membership; reporting offenders to the AKC; withholding AMTC awards. I have read and I promise to abide by the above Code of Ethics as set forth by the AMTC.
