


# American Manchester Terrier Club Newsletter

Phyllis' dogs contributed to the Toys of today, and Phyllis contributed to the dog world. She was president of the AMTC, and AKC delegate. For years she was the secretary/treasurer of the Delaware Manchester Terrier Club. This issue features articles written about and by Dr. H.T. Foote of Rochelle Kennels during the year of 1891.

the different breeds to write about the dogs they knew best.

1891 was an interesting year. It is the first year that the "Cruft's Greatest Dog Show" —was held at the Royal Agricultural Hall, Islington. It is also the year that the American Book of the Dog was published. It took a different approach to writing and used many considered experts of

The Black and Tan experts at the time as noted in Field and Stream were — in England, T. Ellis and W. Adams. In America, Dr. H. T. (Hubert Townsend) Foote and J. F. Campbell.

Dr. Foote wrote the section on the Black and Tan Terrier for the American Dog book 1891, and The dog and how to breed, train and keep him 1894.

Dr. Foote, was a successful physician, veterinarian, AKC delegate for the Toledo KC, Atlanta KC, and Scottish Terrier Club of America, A member of the AKC Executive Board and Chairmen of Membership (1898), and a noted breeder of Wires and Manchesters. At the time he was a strong supporter of the Black-and-Tan Terriers (Manchester) for approximately 20 years.

"It was not until Dr. Foote of New Rochelle took up this breed that we got a fancier with the necessary persistence. For it is one of the hardest to breed to perfection... Dr. Foote stuck with it for twenty years until Mrs. Foote took (Continued on page 8)

up Scottish Terriers and he fell victim to their enticing qualities."

It is written that the breed fell on hard times in the US after he and his wife switched to Scottish Terriers. As late as 1901~1902 Dr. Foote was the Honorary President of the newly formed Black and Tan Club of America and Fred "F.C" McLean "King of the Manchesters" was President. Dr. Foote, George G. Mitchell and R.J. McGaughey donated a silver cup called The International Cup which was valued at the time to be \$100 to the newly formed club.

Dr. and Mrs. Foote continued to show Black and Tans. In 1902 there are mentions of Rochelle's Ringcraft, Ticket, Clicker, Blinker, Winker and Brunswick Dutchess. They were also showing Scottish Terriers and Fox Terriers (smooth). They won the Ladies Kennel Association of America the Best Brace (dog and bitch) for Black and Tan Terriers. Mrs. Foote was a member of this association. It is around this time that Dr. Foote contracted

Tuberculosis, which would trouble him for the next ten years.

By 1906 Dr. Foote was the Vice President of the Scottish Terrier Club of America and is still showing Black and Tan Terriers.

In the Dog Book, 1906; V.I - Dr. HT Foote is noted for the unique kennels he used: "Perhaps the most unique kennel is that Dr. Foote recently had at New Rochelle, consisting of rows of



empty kerosene barrels and about thirty yards of galvanized wire strung from a tree behind each barrel to a tree in a parallel line. About twenty dogs were so kept summer and winter, the barrels being sheltered from the sun by the everareen under which it was placed, and a sack over the entrance in winter be-

President's Report: Susan Thrasher - none

**2nd V.P. Report**: Roberta Berman addressed her receipt of two nominees for the Outstanding Sportsmanship Award – Christina Caridis and Kathy Nissen noting their hard work on behalf of the club and our breed. Roberta requested board votes for their choices be sent directly to her for results to be noted later.

**Secretary's Report**: Kathy noted we have two new applications for publication in the August issue of the newsletter.

**Treasurer's Report**: Dianna noted since the club is incorporated in Washington State, a state ID

number is not necessary for California, therefore, Dianna will contact the State of California to remedy this matter.

Dianna presented her report on the financial status of the club which will be uploaded to the website at a later date. Dianna also presented information pertaining to additional insurance coverage for potential theft, fraud, etc. and quoted coverage and pricing. While it is realized, an occurrence of theft of club monies, properties, etc. would likely never take place, in this day and age of computer hacking, etc.; it was felt the club did need to protect its assets. Two options were presented -one covering basic theft with a premium of \$394.00/year, and the second covering six potential options, noted below, with a premium of \$491.00/year. Following several questions by the board and all information being presented by Dianna and taking the cost of broader coverage into consideration, the board suggested we go with the second option. Where stated in the policy in reference to employees, this will be revised, as suggested by the insurance agent, to club officers and volunteers. Areas covered would be:

- 1. Club Officer/Volunteer Dishonesty
- 2. Forgery or Alteration
- Inside the Premises Theft, Disappearance, Destruction
- Outside the Premises Theft, Disappearance, Destruction
- 5. Money Orders and Counterfeit Paper Currency
- 6. Computer Funds and Transfer Fraud

Manchester Terrier Fans page alone. Pricing for approximately 60 frames will be looked into and information presented to the board at a later time.

#### NEW BUSINESS:

\*With the 2020 AMTC National event being cancelled as noted in OLD BUSINESS, the board discussed, at great length possible options for holding our 2020 Annual General Membership Meeting.

#### Our By-Laws state: Article II Meetings Section

1. Annual Meeting: "The Annual Meeting of the Club shall be held in conjunction with the Club's annual National Specialty Show, if possible, at a place, date and hour designated by the Board of Directors. ...." Our National event was canceled due to the pandemic which had been declared a National Emergency at the time of these meeting minutes. It still exists, thereby negating the possibility of holding our Annual Meeting during this event.

Further discussion ensued with concerns as to how to set a new location in a timely manner for the membership to consider physically attending a meeting only event. Would enough members travel to attend a physical location, would another venue be canceled due to the pandemic.

The board noted there is no old business to carry over nor pending crucial new business to necessitate holding an annual meeting for 2020.

Utilizing Zoom was also discussed. In order to do so, members would need to download the program to their computer, smartphone, tablet, etc. and become familiar with the program and in addition, it would take a great deal of time for all 'attending' members to log in and become familiar with and organized in order to conduct business. Again, would enough members attend utilizing this venue? The club does have members that do not utilize the various forms of social media.

Following a great deal of discussion, the board agreed that cancelling our 2020 Annual General

Dianna will notify Karen informing her of the board's request and approval upon her comparing costs with Hodges since they have our die on hand, and with Stineman for a cost with the addition of the latter creating a die for these ribbons and submits her findings to the board.

\*Late Dues Renewals: Dianna noted several members paid their dues past the March 1st grace period as noted in our Governing documents, however, due to circumstances noted by lapsed members, late fees were waived by the board. <u>Please note: Dues are payable on or be-</u> fore the first day of January of each year.

During the month of November, the Treasurer shall inform each member of dues for the ensuing

There are no companion dog events at this site but a potential companion event site may be "What a Great Dog". The cluster would be willing to use our judge to offset costs. Onofrio would be the Superintendent. More info will be submitted by Robin at a later date.

\*Manchester Terrier Database Team – Christina reported to the board that a team has been set in place to form a worldwide database for the Manchester terrier. The team consists of: Michele Barlak, Christina Caridis, Sam Hessel, Donna Young, Amanda Kelly, Carolyn Inch, Jodi Whitehead and Samantha Avenall. All are currently in the process of merging approximately three databases each containing approximately 30,000 entries. Christina also informed the board the team had discussed setting up an unlimited use Zoom

account that would allow the team to work together for consistency of the database. The Canadian club would be willing to go in half for its cost, however, with our club's business and discussions already utilizing the use of email, official website, social media venues, etc., it was agreed that perhaps the AMTC should pay the entire annual cost of \$149.00. It was suggested our monthly board meetings could utilize the program and in the future the club could possibly realize other options for its use. \*Various types of 501c3 status offered by the AKC were addressed by the board. The board was in agreement not to pursue this status as it is not financially beneficial to our club nor the welfare and preservation of our breed.

## When a dog club chooses to convert to a tax exempt *charity*, unforeseen effects can destroy the club's purpose and the preservation of purebred dogs.

Becoming a 501(c)(3) tax exempt charity it is very much like the fellow who found it difficult to remember his initial objective was to drain the swamp when he was up to his arse in alligators.

Organized religion was coerced into a corporate changeover that moved it under I.R.S. controls. Prior to 1954, there was no such thing as a 501(c)(3) church. Then in 1954, Senator Lyndon Baines Johnson (D Texas) sponsored legislation which brought churches under the new 501(c) (3) section of the Internal Revenue code. As a part of this legislation, churches would incorporate thus subjugating their God-given mandate to the authority of the federal government. Do you still believe in separation of church and state? Did the dog world also sell its soul to the devil for a tax exemption?

Perhaps you have noticed that in the past decade AKC parent clubs have been converting to tax -exempt charity organizations? Did you join your National Parent Club for personal prestige?



Education? To help out? In short order you discovered that it's a 501(c)(3) run by a board; a board that accepts little, if any, input from members.

As a 501(c)(3) you are no longer a dog club dedicated to the preservation of one breed; your breed. Instead your club is lumped in with a whole host of divergent organizations such as HSUS, Black Panthers , the Royal Order of Jesters, the Citizens Opposing Nuclear Arms, the Oddfellows, the International Association of Machinists and Aerospace workers, etc. With this in mind 501(c)(3) dog clubs often end up supporting diametrically opposed

philosophies which results in deep divisions within the club, and it is the breed that suffers!

David Horowitz, editor of FrontPage Magazine, and director of Discover the Networks described

501(c)(3) not-for-profits thusly, "*Oh, yeah, the foundation for every criminal organization.*"

As a further example of the degradation process, let's examine the first parent club to become a 501(c)(3); the Doberman Pinscher Club of America (DPCA). Since converting in 2001 the approximately 2000 members of this parent club NEVER, in some 14 years, had a budget, NEVER had a forensic audit, and NEVER had properly maintained club records REQUIRED of a 501(c)(3) organization.

In fact some DPCA members contend that there was no constitutionally required vote to foment the actual change over and club leadership has not yet been able to present such proof of a membership approval.

With the change to a public charity comes the loss of control of both the future of, and the specificity of club funding to benefit the breed. Instead, IRS obligations require your club to constantly direct funds to a general public benefit and while your breed may benefit, it is NOT the sole focus anymore. The registry through its charitable status no longer promotes purebreds, instead they promote themselves as a humane society for all dogs. The registry is not only concerned with purebreds but Mixed Breeds that the AKC has labeled as the "ALL AMERICAN DOG" (mixed breed) that serves as a profitable registration promotion while your club suffers. We've got to get our priorities straight.

You have to ask yourself, are our breed clubs representing a breed or do they represent an AKC agenda of funneling moneys through 501(c)(3) projects like ...

AKC Political Fund AKC Humane Fund AKC Health Foundation AKC National Breed Club Rescue AKC/Eukanuba National Championship (Meet the Breeds) AKC Penn Vet Working Dog Conference AKC recommended Scientists & Researchers AKC Reunite (former AKC CAR) AKC Canine Support and Relief Fund AKC DOGNY The NAIA founded by former AKC Director Patti Strand NAIA Conferences (see AKC connection above) Seeing red yet? I'm sure it is clear that the majority of benefits from the 501(c)(3) accrue NOT to your breed or club but to the registry (AKC).

As described by a Doberman Pinscher Club of America Past-President on the occasion of achieving 501c3 tax-exempt status, "We have transitioned from a breed club to an education, health and rescue entity and the show raises funds to support these activities."

If your dog club is anything like the DPCA, the sole source of outside monies come from a dog food company; they are not club-supporting incomes and they are NOT regular annual donations. So the premise of "taxdeductable" is illusive and misleading as to having a financially healthy club.

Further, here is a reality check to apply to your 501c3 club:

- \* Has the club membership increased?
- \* Is your breed more populous or less?
- \* How is the health of your breed? Improved or the same?

WE ARE NO LONGER IN THE PROCESS OF EVOLV-ING OUR PUREBRED DOGS - RATHER WE ARE IN AN AGE OF PRESERV-ING THEM.

I hope you have come to the reasonable conclusion that 501(c)(3) parent clubs are businesses about and for people and not dogs. The national dog organizations have moved past purebred dogs and directly to the business of making and redistributing money. Those of us who have the passion for purebreds can no longer dismiss the shenanigans of the dog world as harmless and annoying political misbehavior.

We must help 'man's best friend' escape the web of corruption and lies. We must reject this faulty business model imposed upon us and use our collective power to recapture the artistry, history and excitement that is the PURERED dog.

undoubtedly right to consider the lack of proper tan markings a serious defect.

Much has been said and written about the faking practiced with the Black and Tan, but so far as I can observe, there is no more of it done in this breed than in most others. Of course, where correctness of markings is so essential, the closest scrutiny must be exercised by the judge to detect fraudulent practices. I have referred in this writing to the Black and Tan Terrier proper, whose weight ranges from about seven to twenty-two pounds.

The following is the latest standard of points of the Black and Tan Terrier, as set forth by the Black and Tan Terrier Club of England:

**Head**.—Should be narrow, almost flat, with a slight indentation up the forehead; long and tight-skinned, level in mouth, with no visible cheek muscles; it should be slightly wedgeshaped, tapering to the nose, and well filled up under the eyes with tight-lipped jaws.

**Eyes**.—Should be small, bright, and sparkling, set moderately close together, as near black as possible, oblong in shape, slanting upward on the outside; they shall neither protrude nor sink in the skull.

**Nose.** —Should be perfectly black. Ears.-Should be button, small, and thin; small at the root, and set as close together as possible at the top of the head.

**Neck and shoulders**.-The neck should be slim and graceful, gradually becoming larger as it approaches the shoulders, and perfectly free from throatiness, slightly arched from the occiput. The shoulders slope off elegantly.

**Chest**.—Narrow between the legs, deep in the brisket.

**Body**.-Short, with powerful loin, ribs well sprung out behind the shoulders, the back being slightly arched at the loin, and falling again to the joining of the tail to the same height as the shoulder. Legs.-Perfectly straight, and well under the body, strong, and of proportionate length.

**Feet**.—Compact, split up between the toes, and well arched, with jet-black nails; the two middle toes of the front feet rather longer than the others, and the hind feet shaped like those of a cat.

**Tail**.—Should be moderately short, and set on where the arch of the back ends, thick

where it joins the body, and gracefully tapering to a point, and not carried higher than the loin.

**Coat.**—Close, short, and glossy, not soft.

**Color**.—Black and tan as distinct as possible; the tan should be a rich mahogany color; a tan spot over each eye, and another on each cheek, the latter as small as possible; the lips of the upper and lower jaws should be tanned, the tan extending under the jaw to the throat, ending in the shape of the letter V; the inside of the ear is partly tanned; the fore leg is tanned to the knee, with a black patch ("thumb-mark") between the pastern and the knee; the toes have a distinct black mark running up each, called the "pencilmark; " the tan on the hind legs should continue from the penciling on the feet up the inside of the legs to a little below the stifle-joint, and the outside of the legs should be perfectly black. There should be tan under the tail and on the vent, but only of such size as to be covered by the tail. In every case, the tan should meet the black abruptly.

**Weight.**—A medium-sized dog should not exceed fourteen pounds, and a large-sized twen-ty-two pounds.

"In a rat-pitting contest at Newwere tried on a big rat. The rodent bit the cat twice, and she retreated. The fox terrier played with the rat for a time and finally nipped it from behind, but couldn't be persuaded to shake the rodent. The black and tan gave one bound, nipped it by the head, gave a shake and the rat was dead. Dr. Foote would have walked a good way to see that bit of fun. The black and tan is always a terrier where rats are concerned."

I have owned and bred black and tan terriers for twelve years. The best ratter I ever saw was of this She weighed sixteen breed. pounds when in condition — I mean in condition for the rat pit, not the show bench. Lilly II (that was her name) at one time killed fifty rats in a round pit, five feet across, without stopping to sponge her. Her time in killing them was not taken, but she has on several occasions killed eighteen rats in a minute. Although not in good condition, being due to whelp in two weeks, at a match held in this vicinity some

dogs. Each contestant was to kill five rats; she did hers up in thir-teen seconds.

Lilly II came from Truro, in Cornwall, England, in 1882, and had the reputation of being the best ratter in that vicinity. She was by Old Champion Cupid out of Burton's Lilly. Her former owner, Mr. Thomas Trenerry, wrote me that I could match her with anything her weight living. While I owned her I bred four litters of pups and never heard of one that would not kill. She was the dam of the following prize winners, well known to our old exhibitors: Vortex, Lady, Nanon and Brilliant.

I sold Lilly II to Mr. A. W. Smith, of Buffalo, N. Y. She died shortly after wards, and I never expect to see her like again. In the pit she was chained lightning at rats.

I wish to have a few words on the dogs they are now importing. I think they are sacrificing terrier character and game- ness in the craze for long heads, color and markings. I like to see a wellmarked dog as well as anyone, but I perfer more terrier and less color and markings.

The long-looked for publication, the American Book of the Dog, edited by G. O. Shields, and published by Rand, Mc-Nally & Co., is now out. It is a handsomely gotten up book of over 700 pages and contains 85 illustrations.

We acknowledge the receipt of a copy, which, as yet, we have not had time to peruse. A cursory "glance at the pages show, as must be expected in a work of this kind where each breed is discussed by a different person, much unevenness in literary merit. Some of the writers have made the mistake of lauding their favorites and making extravagant claims for them.

The publication as a whole is an invaluable one for American dog fanciers, and we do not propose to slight its importance. After a thorough examination we will give a more extended criticism.

#### **ENGLISH TERRIERS**.

The English terrier, whether the black and tan, formerly called the Manchester terrier, or the pure white, is always a slimmer dog than any terrier yet referred to, of decidedly elegant shape and who has much attention paid to the cropping of his ears, and too often destroys a delicateness of constitution and a barrenness of hair about the chest, neck and head. These terriers vary very much in size from the little nursling toy of three pounds weight up to one of thirty pounds or more, which many notable prize winners have been, although those from ten pounds to twenty pounds are probably on the whole the most in favor.

#### Takes Exception. — New York. - Editor Forest and Stream:

I must take exception to your statement in last issue, that Beaconsfleld led the black and tan breed in England both on the bench and as a sire. He was certainly one of the best show dogs, but his bench record hardly entitles him to unquestionable superiority. As a sire, his get can probably be figured to a larger number than any dog of this breed in numbers make the reputation of a sire, the names of a few of his get that have attained marked distinction on the bench would not be out of the way. As he is in his seventh year they should not be difficult to find.- H. T. Foote. [Will Dr. Foote please read the Canine World report of the Oldtal Palace show, Oct. 31, 1890.]

The protest which Dr. Foote entered against the black and tan terriers Beaconsfield and Empress owned by Mr. Symonds, at the Baltimore show, has been overruled by the M. K. C. We are told that Dr. Foote entered four black and tans and then was informed by the committee that his dogs were the only entries. Not wishing to rush his dogs too much, he sent his second string — The Senator and Bloomfield

Madge. When, however, the classes were judged, Mr. Symonds' two dogs turned up and won. They and been entered in the Clydesdale class and we are told were so entered on the entry blank received from the Salem kennels. The outcome of the protest is unsatisfactory to Dr. Foote and he will very likely appeal the case. It was a very unfortunate go for him, for on the journey down The Senator caught cold and this, developing into pneumonia, carried him off during the show week. We know that it is customary to transfer dogs wrongly classified, at the same time this is a peculiar case, and though there is no rule under which the protest would hold, still justice seems to lean toward Dr. Foote's side of the case.

Some good black and tans are being dispersed throughout the country, evidently proving that this smart terrier is gaining ground in public favor. Dr. Foote writes us he has sold Rochelle Knickerbocker, winner of second, Boston and New York, and first, Buffalo, 1890, to Mr. Michel Hilgert, St. Joseph, Mo. That nice-looking daughter of Meersbrook Maiden. Rochelle Nadjy, second, Detroit; third, Toronto; first, Ottawa, and first Danbury, finds a home with Mr. Joseph J. Lang, of Buffalo, N. Y.

In connection with this sale it may be noted that these terriers are from the first litter of black and tans Dr. Foote ever bred. They are by champion Vortigern out of champion Meersbrook Maiden.

**BLACK AND TANS AT CHICAGO** —Buffalo, N. Y. — Editor Forest and Stream: You are right when you say that black and tan terrier men surely cannot grumble at the Chicago show. As this club has been liberal enough to give us four classes, besides three specials, they certainly deserve a large entry, and I hope they may have at least 20 entries. – A.W. Smith

Thanks to Dr. Foote and the enthusiasm he has displayed in their interests, black and tans are "away up." Though several importations have been made during the past year, yet Meersbrook Maiden still holds her own over those that have been shown, and it was a bold venture of her owner to send her back to England purposely to mate her to Broomfield Dick. his pluck being rewarded last October with seven youngsters. Many of the new arrivals have not yet graced the bench, so that

Dr. H. T. Foote, proprietor of the Rochelle Kennels, writes that he has found it absolutely necessary to withdraw from the fancy. As will be seen in our advertising columns he offers his grand kennels of black and tan terriers for sale without reserve. This affords an excel lent opportunity for those desirous of purchasing good show specimens of this popular breed of terriers.

Editors Note: Dr Foote continued to breed for the next ten years and remained showing Black and Tans at least through 1906. We cannot locate any information that would have caused Dr. Foote to write to the editors or to place the ad he did to sell all Dogs. In the AKC Stud book V,15 1898 He is listed as the breeder of 2 entries Rochelle Spray (49,378) by Perfecto and Scalchi (48,461)by Broom Field Sultan.





Throughout the years, many have asked about Ch. Amick's Foolarian aka "Topper."

More recently, someone asked, "where do we go when you're not here any longer?" Which got me to thinking about getting things on paper, as I know it.

Topper, for me, came on the scene when Myrtle Klensch, "Salutaire" fame,

used him for stud on Ch. Salutaire Most Likely to bring in markings. Out of this breeding comes the infamous Salutaire Signature aka "Mark." He was campaigned quite heavily by Myrtle and Peter Rank. shortly after Myrtle passed on in August of 2000, Mark went to Nancy Elliott.

Little was known about "Topper" until his breeder, Laura Manuel, "Amick" took an ad out stating (and I'm paraphrasing) do you wonder who produced the dog that's been doing all the winning? With that, the following picture in the ad came out introducing Mark's sire, Topper, or as some of us continue to call him, "Foolarian."

A very popular stud dog, especially after he was collected. Some rushed to by this frozen semen at any cost.

It was said Foolarian was vWD CLEAR using the old ELYSSA test.



Not until a breeder decided to use him on her CARRIER bitch, and after testing her litter, found one puppy to be vWD Affected. Foolarian couldn't possibly be a CLEAR for vWD with this result.

After reading the announcement on an old Manchester Terrier list, I immediately contacted another breeder that was going to use Foolarian's frozen semen he had purchased. His bitch was CLEAR, that wasn't the issue. After reading the announcement to him, I suggested having the semen tested for vWD status and letting the previous breeder that used him know the results. Testing was completed and confirmed, CARRIER.

Just a little insight and history on a popular Standard Manchester Terrier stud dog.





## **Health Committee Report**

#### Genetic Disorders

Several breeders have grown concerned about a genetic disorder that causes poor balance and coordination in SMTs, called cerebellar abiotrophy. Puppies can appear normal and not develop symptoms until they are in their new homes.

It is a degenerative disease so it may not be apparent in early puppy hood. There are some tests for the gene mutation that causes this disease, however, it's only available for specific breeds. It's not known whether these tests would detect the gene mutation in our breed and the AMTC and CMTC are working with an owner in the USA and an owner in Canada to have the Embark DNA panel run on their affected SMTs so we can examine the results.

Interestingly, I recently had a toy puppy born (the litter is 4 weeks old as I write this) who was showing poor balance, coordination and had a head tilt as soon as he was old enough to start toddling around.

My vet and I chose to start him on clavamox, though he felt is was likely a cerebellar disease called cerebellar hypoplasia, which is similar to what I described above in the SMT.

I took him to a neurologist who agreed he was displaying symptoms of a neurological problem. Now, after a week on antibiotics, he appears completely normal and we will follow up with the neurologist in two weeks to see what he thinks.

He certainly would not have improved so dramatically if he had a cerebellar disease so our theory right now is that he had some kind of inner ear infection, but it's difficult to diagnose a puppy so small and young that we may never know. The neurologist advised me to have him on the clavamox for 3 weeks. I just wanted to publish this experience here as a learning opportunity for others. If you've had a similar experience, I would like to hear about it. I think it is important to learn from each other. While I may use your story as an educational opportunity, I will always keep your privacy if you wish it.

## Agalactia in the Bitch Regina R. Allen DVM



Agalactia is defined as the failure to produce or secrete milk. Primary agalactia, lack of or non -functioning mammary tissue, is

fortunately very rare. There is no treatment, and the puppies must be hand-raised, because the bitch cannot produce milk. Secondary agalactia, known as poor milk let-down, is usually what we see in our dams when they cannot produce milk or do not have enough for the puppies to thrive. It can be caused by poor nutrition, stress, premature delivery, progesterone therapy, or illness such as mastitis or uterine infection. Treatment depends on the underlying condition and may be successful, or the breeder will have to supplement or hand-raise the puppies.

The bitch and her litter should be in a quiet, calm environment without other dogs around. Oxytocin is a hormone that can increase milk let-down by stimulating release of milk from the mammary gland. One injection may be enough, or she may need repeated injections at every nursing, which is undesirable and may add to her stress. Oxytocin will not work if there is no milk to release. Another potential treatment is Metoclopramide (commonly known as Reglan) orally, which caus-

es release of prolactin, another lactation hormone that actually stimulates the gland to produce milk. It can be given up to three times daily, and typically works within a few doses. Metoclopramide is commonly kept at Veterinary practices due to its usefulness in treating vomiting and nausea, and is available in tablet and liquid form. Whether these drugs work or not, it is extremely important for breeders to weigh the puppies at least once daily to make sure they are getting enough nutrition and supplement them if needed.


I hope everyone is staying cool and enjoying the summer. It is hard to believe our final summer month is already here and many of us long for some cooler Fall temperatures.



## How the PPCP Program Works

#### American Manchester Terrier Club Code of Ethics

Membership in the American Manchester Terrier Club (AMTC) is a privilege. In return for acceptance into the AMTC, I promise to abide by the following Code of Ethics and to submit to the enforcement of this Code by the AMTC Board of Directors.

#### GENERAL

I pledge as an owner of Manchester Terriers to be responsible for the dogs in my care. My responsibilities include providing proper shelter which is clean, dry and warm; appropriate veterinary care and inoculations; emergency veterinary care when needed; quality food and water; adherence to local and state animal control and licensing laws. **BREEDING** 

#### Inladay

I pledge:

1. To accept and uphold the Standard of the Manchester Terrier as developed by the AMTC and approved by the AKC.

To breed only physically and mentally sound Manchester Terriers in order to maintain or improve the qualities of the breed as set forth in the Standard. I will not participate in the indiscriminate breeding of studs or bitches with no regard to quality.

To screen or obtain proof of screening of breeding stock for communicable diseases, hereditary faults or defects, either active or dormant. Questionable animals will not be used in my breeding program.

To forego breeding unless financially capable and willing to responsibly and caringly maintain whelped puppies until placed in their new homes.

5. To maintain complete and accurate breeding records in accordance with AKC regulations.

#### SELLING

I pledge:

1. To in no way misrepresent any Manchester Terrier for sale.

To provide all buyers with:

A. AKC individual registration application or certificate properly filled out by seller.

B. Minimum three-generation pedigree.

C. Record of inoculations, worming, etc.

D. Provide instructions for feeding and care.

E. Be available for guidance and questions.

3. Not to sell, give, trade, abandon or in any manner transfer litters or individual Manchester Terriers to pet dealers, pet wholesalers, auctions, laboratories, raffles, pet stores, puppy mills, animal shelters, or any source for resale. I will not knowingly transfer ownership or provide stud service to anyone who intends to breed Manchester Terriers for any of the above listed purposes.

4. To take back any Manchester Terrier I bred if the current owner of the dog can no longer keep him or her. I will evaluate the dog as to whether or not s/he is suitable for placing in a new home. In the very unfortunate circumstance that the dog is not suitable, I will either keep the dog myself or provide proper veterinary euthanasia. In the rare event that I cannot take back a dog due to current personal circumstances, I will place the dog in AMTC rescue. I, the breeder, will reimburse any and all reasonable expenses incurred on behalf of a dog in this unusual situation to AMTC rescue.

#### EXHIBITING

I pledge:

1. To serve as an example of good sportsmanship in any aspect of the sport of dogs, assisting and befriending newcomers to the best of my ability.

To show only those Manchester Terriers which deserve to be champions in light of the Standard and which are in proper condition.

3. Not to kennel pack for points in conformation or to engage in any other unfair practices in competition.

#### PENALTIES

I acknowledge and accept for disciplinary purposes a sliding scale of penalties based upon the seriousness of the deviation from this Code of Ethics. The Board of Directors will apply penalties equally to any and all offenders after a proper review of the evidence. Penalties include but are not limited to: reprimand from the Board; temporary suspension from AMTC membership; permanent suspension from AMTC membership; reporting offenders to the AKC; withholding AMTC awards. I have read and I promise to abide by the above Code of Ethics as set forth by the AMTC.
