



I hope everyone has a safe and productive time this summer. Perhaps I'll see you around the ring.





A WORD ABOUT DOGS

By Lewis F. Allen

Rural Architecture 1852

We always loved a dog; and it almost broke our little heart, when but a trudging schoolboy, in our first jacket-and-trousers, our kind mother made us take back the young puppy that had hardly got its eyes open, which we one day brought home, to be kept until it was fit to be taken from its natural nurse. We are now among the boys, John, Tom, and Harry; and intend to give them the benefit of our own experience in this line, as well as to say a few words to the elder brothers,-and fathers, even, -if they do not turn up their noses in contempt of our instruction, on a subject so much beneath their notice.

We say that we love dogs: not all dogs, however. But we love some dogs--of the right breeds. There is probably no other civilized country so dog-ridden as this, both in

*"Mongrel, puppy, whelp, and hound,
And curs of low degree."*

Goldsmith, kind man that he was, must have been a capital judge of dogs, like many other poetical gentlemen. Still, other men than poets are sometimes good judges, and great lovers of dogs; but the mass of people are quite as well satisfied with one kind of dog as with another, so that it be a dog; and they too often indulge in their companionship, much to the annoyance of good neighborhood, good morals, and, indeed, of propriety, thrift, and common justice. Of all these we have nothing to say---here, at least. Ours is a "free country"--for dogs, if for nothing else. Nor shall we discuss the various qualities, or the different breeds of dogs for sporting purposes. We never go out shooting; nor do we take a hunt -having no taste that way. Perhaps in this we are to be pitied, but we are content as it is.



Therefore, we shall let the hounds, and pointers, and setters, the springers, and the land and the water spaniels, all alone. The mastiffs, and the bull dogs, too, we shall leave to those who like them. The poodle, and the little lap-dog of other kinds, also, we shall turn over to the kindness of those who--we are sorry for them, in having nothing better to interest themselves about--take a pleasure in keeping and tending them.

We want to mix in a little *usefulness*, as well as amusement, in the way of a dog; and after a whole life, thus far, of dog companionship, and the trial of pretty much everything in the line of a dog--from the great Newfoundland, of a hundred pounds weight, down to the squeaking little whiffet, of six--we have, for many years past, settled down into the practical belief that the small rattling terrier is the only one, except the shepherd dog, we care to keep; and of these, chiefly, we shall speak.

There are many varieties of the Terrier. Some are large, weighing forty or fifty pounds, rough-haired, and savage looking. There is the bull-terrier, of less size, not a kindly, well-disposed creature to strangers; but irascibly inclined, and unamiable in his deportment; still useful as a watch-dog, and a determined enemy to all vermin, whatever. Then, again, are the small ratterriers, as they are termed, weighing from a doz-

en to twenty pounds; some with rough, long, wiry hair; a fierce, whiskered muzzle; of prodigious strength for their size; wonderful instinct and sagacity; kind in temper, and possessing valuable qualities, bating a lack of beauty in appearance. They are of all colors, but are generally uniform in their color, whatever it be. Another kind, still, is the smooth terrier, of the same sizes as the last; a very pretty dog indeed; with a kinder disposition to mankind; yet equally destructive to vermin, and watchful to the premises which they inhabit, or of whatever else is put under their charge. The fidelity of the terrier to his master is wonderful; equal, if not superior to any other dog whatever.



In courage and perseverance, in hardihood, and feats of daring, he has hardly an equal; and in general usefulness, no dog can compare with him.

THE SMOOTH TERRIER.

Sir Walter Scott, who was a great friend to dogs, as well as a nice and critical judge of their qualities, used to tell this story:--When a young man, first attending, as an advocate, the Jedburgh assizes, a notorious burglar engaged Sir Walter to defend him on his trial for housebreaking in the neighborhood. The case was a hard one; the proof direct and conclusive; and no ingenuity of the defence could avoid the conviction of the culprit. The matter was settled beyond redemption; and

before he left for his imprisonment, or transportation, the thief requested Sir Walter to come into his cell. On meeting, the fellow frankly told his counsel that he felt very grateful to him for his efforts to clear him; that he had done the best he could; but the proof was too palpable against him. He would gladly reward Sir Walter for his services; but he had no money, and could only give him a piece of advice, which might, perhaps, be serviceable hereafter. Sir Walter heard him, no doubt, with some regret at losing his fee; but concluding to hear what he had to say. "You are a housekeeper, Mr. Scott. For security to your doors, use nothing but a common lock-if rusty and old, no matter; they are quite as hard to pick as any others.

(Neither Chubbs' nor Hobbs' *non-pickable* locks were then invented.) Then provide yourself with a small rat terrier, and keep him in your house at night. There is no safety in a mastiff, or bull-dog, or in a large dog of any breed. They can always be appeased and quieted, and burglars understand them, but a terrier can neither be terrified nor silenced; nor do we attempt to break in where one is known to be kept." Sir Walter heeded the advice, and, in his housekeeping experience, afterward, confirmed the good qualities of the terrier, as related to him by the burglar. He also commemorated the conversation by the following not exceedingly poetical couplet:

"A terrier dog and a rusty key,
Was Walter Scan's first Jedburgh fee."

The terrier has a perfect thorough, unappeasable instinct for, and hatred to all kinds of vermin. He takes to rats and mice as naturally as a cat. He will scent out their haunts and burrows. He will lie for hours by their places of passage, and point them with the sagacity of a pointer at a bird. He is as quick as lightning, in pouncing upon them, when in sight, and rarely misses them when he springs. A single bite settles the matter; and where there

are several rats found together, a dog will frequently dispatch half a dozen of them, before they can get twenty feet from him. A dog of our own has killed that number, before they could get across the stable floor. In the grain field, with the harvesters, a terrier will catch hundreds of field-mice in a day; or, in the hay field, he is equally destructive. With a woodchuck, a raccoon, or anything of their size-even a skunk, which many dogs avoid he engages, with the same readiness that he will a rat. The night is no bar to his vigils. He has the sight of an owl, in the dark. Minks, and weasels, are his aversion, as much as other vermin. He will follow the first into the water, till he exhausts him with diving, and overtakes him in swimming. He is a hunter, too. He will tree a squirrel, or a raccoon, as readily as the best of sporting dogs. He will catch, and hold a pig, or anything not too large or heavy for him. He will lie down on your garment, and watch it far hours; or by anything else left in his charge. He will play with the children, and share their sports as joyfully as a dumb creature can do; and nothing can be more affectionate, kind, and gentle among them. He is cleanly, honest, and seldom addicted to tricks of any kind.

We prefer the high-bred, smooth, English terrier, to any other variety. They are rather more gentle in temper, and very much handsomer in appearance, than the rough-haired kind; but perhaps no better in their useful qualities, We have kept them for years; we keep them now; and no reasonable inducement would let us part with them, A year or two ago, having accidentally lost our farm terrier, and nothing remaining on the place but our shepherd dog, the buildings soon swarmed with rats. They were in, and about everything. During the winter, the men who tended the horses, and cattle, at their nightly rounds of inspection before going to bed, would kill, with their clubs, three or four, in the barns and stables, every evening. But still the rats increased, and they became unendur-

able. They got into the grain-mows, where they burrowed, and brought forth with a fecundity second only to the frogs of Egypt. They gnawed into the granaries. They dug into the dairy. They entered the meat barrels. They carried off the eggs from the hen-nests. They stole away and devoured, the young ducks, and chickens. They literally came into the "kneading troughs of the kitchen. Oh! the rats were intolerable! Traps were no use. Arsenic was innocuous—they wouldn't touch it. Opportunity favored us, and we got two high-bred, smooth, English terriers—a dog, and a slut. Then commenced such a slaughter as we seldom see. The rats had got bold. The dogs caught them daily by dozens, as they came out from their haunts, fearless of evil, as before. As they grew more shy, their holes were watched, and every morning dead rats were found about the premises. The dogs, during the day, pointed out their holes. Planks were removed, nests were found, and the rats, young and old, killed, *instantly*. Hundreds on hundreds were slaughtered, in the first few weeks; and in a short time, the place was mostly rid of them, until enough only are left to keep the dugs "in play," and to show that in spite of all precaution, they will harbor wherever there is a thing to eat, and a possible place of covert for them to burrow.

To have the terrier in full perfection, it is important that the breed be *pure*. We are so prone to mix up everything we get, in this country, that it is sometimes difficult to get anything exactly as it should be; but a little care will provide us, in this particular. He should be properly trained, too, when young. That is, to mind what is said to him. His intelligence will be equal to all your wants in the *dog-line*; but he should not be fooled with. His instincts are *sure*. And, with a good education, the terrier will prove all you need in a farm, and a watchdog. We speak from long experience, and observation.

Manchester Terriers

Recognized in 1887 by the AKC

Black-and-tan terriers are mentioned in Dr. Caius's *Encyclopededia of Dogs*, written in 1570. In J.A. Walsh's *The Dog in Health and Disease*, written in the early 1800's, a full chapter is devoted to the black-and-tan. Mr. Walsh's description – "coat smooth ... nose long and tapering ... skull narrow and flat ... eyes small and bright ... chest rather deep than wide ... color only black and tan" would serve today.

Rats became a health menace in England in the early 1800's, and rat-killing became a popular sport. John Hulme, a rat-killing and rabbit-coursing devotee, bred a Whippet to a black-and-tan terrier, developing one dog for both sports.

This cross proved so successful that it was repeated, establishing a definite type. The breed's fighting spirit made them handy in the rat pit or along a hedgerow. They could tackle and opponent twice their size with silent determination, and were often called "the gentleman's terrier." Because the dining halls of public inns were often rat-infested, many inn-keepers had their own kennels of black-and-tans.

By 1860, the Manchester District of England became the breed center for these ratting terriers, thus the name. Smaller specimens became the English Toy Terrier while the larger ones remained Manchester Terriers. – *Virginia Anita, American Manchester Terrier Club.*



Wallace.

WE reproduce from the Scottish Fancier the cut of the champion black and tan terrier Wallace. That journal says of him: "Champion Wallace was bred by Mr. J. Wood, and is by Sam out of Queen. He was born on Dec. 21, 1879, and is the winner of numerous first prizes, among which we may mention champion prizes at Crystal Palace, Alexandra Palace, Margate, and Henley-on-Thames; first prizes at Birmingham, Hertford, Macclesfield: first and cup. Sheffield: first, and cup, -Liverpool; first, Dublin, Ayr, Wishaw and Glasgow.

"Wallace has been knocked about a good deal. He was sold at one time in London for £140; after that he fell into the hands of his present owner, Mr. Samuel Cameron, St. Rollox, Glasgow, who sold him for £40 two years ago and a few months since bought him back again. Not on the show bench only has Wallace distinguished himself, but also as a stud dog. Champion Vicountess, winner of champion prizes at the Palace and his first prizes at all the large English shows, claims him as her sire. He is also sire of Mr. Amey's Wanstead Queen (first, Palace, Warwick, etc.), Mr. Stratford's Stockwell, another winner and Mr. Pestell's Harvester that won second in the puppy class at the last Palace show. Champion Wallace has a grand terrier head, is nicely marked, and is full of terrier character, properties which he has transmitted to his progeny, this making him a valuable stud dog."



Prince George

The Stock-Keeper and Fancier Chronicle
Friday March 25, 1887

The Black-and-Tan Terrier Champion Prince George

This handsome specimen of a graceful breed has been mentioned so often in reports and prize-lists that Terrier men will be glad to see a portrait of him. Dr. Webster Adams, a name familiar to the students of dog show catalogues, is the owner of Prince George, and is reasonably proud of the unbeaten list of successes obtained by his Terrier. From sixteen exhibitions in succession Prince George has taken home premier honours. His last appearance on the bench was at Portsmouth, where he won in the challenge class, and there-with earned the title champion. Whelped on July 1, 1885, he is yet a very young dog; he was bred by Mr. Wm. Boulton, by Charmer – Luce. Dr. Webster Adams purchased his dog from Mr. Joseph Tatham for a long figure, and had good rea-

son to be satisfied with his judgement.

In addition to the possession of exceptional outward beauty, pleasing to the eye of the learned, Prince George has also a proper Terrier character; he is as game as a lion, and a determined destroyer of four-footed vermin. Existing show regulations are not favourable to champion dogs.

The challenge class has become a sort of House of Lords – nothing but dignity to sustain it. At many shows champions are entirely debarred, and at others the prize is often so insignificant that owners will not go to the expense of winning it. The public, therefore, lose sight of many precocious cup-bearers, who sit at home resting on their laurels. We hope, however, that Dr. Webster Adams does not contemplate allowing his dog, which to see is a lesson for breeders, to retire from public life at this early age. Prince George is a stud, and, if like begets like, his progeny may also become famous one day.



Exhibitor's Prayer

AKC Gazette 1954 August ATMTC Column

Mrs Karen Reed Governor of District 6. opens her report of the District Specialty, held at Kirkland, Wash., on June 19, with a 'Exhibitor's Prayer' which she composed:

" Dear Lord, may I see fit to win or lose with equal grace.

And never blame an honest judge should my own dog not place;

He puts them as he sees them; the show's the thing—It's fun

If we will trust his judgment that the better dog has won.

Please never let my temper my dear breed dis-

grace.

And help me—win or lose—to keep a smiling face.

Answering a few questions: C. L.: Never hold the tail of your T.M.T. in the showing. If it has a tendency to be carried under the legs, nervousness may be part of the cause, lack of self-confidence. Support it with your hand opened flat so the end inch or two of the tail rests on your fingers. The tail should be carried never higher than the level of the back. In moving, it often is carried gayly and allowance is made for the dog being in motion. R. N.: Markings are ultra important. Read the official Standard of the breed. "Shape and color" make our breed. A well balanced, cobby body, head length in proportion to overall size; small dark eyes, small, erect ears, and rich mahogany tan



There are a number of details to be worked out at the -American Kennel Club with respect to the new arrangement. Further communication from them will be received when these details have been gone into, and this col-



umn will report results to you in due time.

I am heartily in accord with our breed now being known as “Manchesters,” with size divisions determined by weights. I hope that our Club membership may be strengthened by the owners of the Standards affiliating themselves and also putting their shoulders to the wheel to promote Manchesters of both varieties



Y. in 1851.



THE AMERICAN Manchester Terrier Club is now the Parent Club for the entire breed, Toys and Standards. This step forward was initiated by the American Toy Manchester Terrier Club. The American Kennel Club’s Board approved the change. The varieties are identical in type, differing in size, ear cropping being prohibited for the Toys and optional for the Standards. Supporters of both

sizes have always considered the breed as one. There will be no change in regard to show classifications. Toys will continue in the Toy group: Standards in the Terrier group. Over-size toys, those beyond 12 pounds, will naturally fall into the Terrier classification. As a long time breeder of Standard Manchesters it is wonderful to feel that this size now has a Parent Club with which to work. A definite set-back to Standards took place when the latter’s Parent Club was abandoned some years ago. It is hoped that all Manchester fanciers will ally with the new Parent Club and cooperate in promoting all sizes of Manchesters. On Jan. 1, the AKC listed 111 breeds of dogs accepted by them, one less than the 112 and—this is the first time there has ever occurred a decrease in AKC recognized breeds. I hope that this in itself will




arouse new interest in our breed, via the publicity angle.

John Rendel in his Thursday New York Times column (Nov. 13), stressed the “Three Keys in Dog-dom”—breeder, judge, and breed Standards. And how very right he is in summing up Percy Roberts’ talk before the Dog Fanciers Luncheon Group, held the second Monday of each month, in New York City. Type is certainly the most important of all features in our breed as well as all others. Most breed Standards do not say nearly enough about type and ours is, I am sorry to admit, somewhat in that category of short-coming. Type, balance (structure): action. Not one, but all to be found in the same dog. I could mention Toy Manchesters that are tops in type, but move badly, show not at all, and lose to an inferior competitor that is

trained to show. Judges approved to do Toy Manchesters are now eligible to do the Standards, which can result in a better sorting out of Toys if these judges will take the time and trouble to look at Standards. Not long ago a Toy judge admitted never having looked closely at a Standard and on visiting my kennel did not take to my best Standard because it did not look like “her idea of a good Toy.” A return visit and some reading up, ultimately put my friend straight

For some reason which we cannot fathom, too little stress is put upon the importance of grooming the Manchester. Clipping nails, removing whiskers, trimming stray hair and brushing as show time approaches just does not do the job. No harm comes from letting the whiskers and




The Manchester terrier and the Toy

hairs grow except that it is esthetically very unsatisfactory. Great harm can result from nails allowed to grow in the "off season." We have learned from sorry experience that one's Manchester can become permanently "down in the foot" as a result of stretched tendons and muscles brought about by excessive nail length. As for the coat, brushing daily with a medium bristle brush is nice, but not really enough. It is stimulating to be sure, and lots of fun for Mr. Manchester, yet it cannot and does not accomplish the important end of removing 1) dead hair, 2) skin scales, and, 3) excessive deposits of sebum in their respective objectionable entirety. When the latter, usually useful secretion accumulates to extremes it may necessitate over-bathing to eliminate that doggie odor. This in turn may result in scaling due to loss

of the natural oils, and then you have caught yourself and your Manchester in a vicious circle. There is a four letter word which can do much to spare us all a ride on that merry go-round. C-o-m-b. Daily use of a clean fine toothed comb (gently against and then with grain of growth) is most hygienic. Then buff with brush or soft lint free cloth. You'll be glad you did, and so will your Manchester!

We have been asked by many interested parties to advise on both conformation and health problems peculiar to the breed. Not being an oracle we do not wish to sermonize, however, in the last decade the Toy Manchester Terrier is doubtless one of the most improved breeds of those recognized by the AKC. The uniformity of quality in the

conformation rings is often a sheer delight to view, although there still appears to be some room for improvement in straightness of fronts, strength of hindquarters and size of ears.

To the Standard Manchester fancy we all owe a vote of thanks, for it is through their dogs that much of the excellent quality of our toys is derived. With little competition to spur them on, the Standard buffs are benching the most beautiful Manchesters to step foot in the show ring in many a moon. The ones we have had the good fortune to see are strong, elegant, and of good temperament and disposition. While on the topic, the neophyte should keep in mind that the Manchester is a true terrier and much about him may appear to be willful and capricious. Trained with an iron hand in a velvet glove the Manchester Terrier is the most consistent yet spirited canine available. Healthwise, we cannot think of another breed with so much to offer a prospective master. In all the volumes of correspondence we receive and in all the writings we have read on the subject, congenital maladies attributable to the Manchester per se seem nil. Toy Manchesters are especially long-lived and hearty. Many “teenagers” abound, some ready to step as sedately as ever into the show ring as veterans and more than a few have had the remarkable life span of two decades. The magnificent Manchester Terrier affords maximum pleasure and service with a minimum of problems to the owner—shedding notwithstanding!

Recently, one of our parent club members brought out a Standard Manchester with button ears. From his experiences down the challenging road to championship status, the dog might well have been solid white. Comments on the plus side ran the gamut of..."I'll give you \$500 if you'll show me how you set those ears"... to ... "he looks more like a terrier than a baby Dobe."

The minus side carries on it a rather shocking statement by an A K C licensed judge; "I couldn't even consider the dog; Standard Manchesters should have cropped ears."

Wait a minute! Couldn't CONSIDER the dog? Couldn't compare the rest of the dog with those in competition because he had button ears? The Standard states: Erect, or button, small and thin; smaller at the root and set as close together as possible at the top of the head. If cropped, to a point and carried erect." Mercy!



Reflections on Chatham Farm—Jo Ann Emrick

Going back to 1996-97, Bill and I had the great pleasure of enjoying a very memorable visit from Charles and Ruth Turner's son, John Turner and his lovely wife.

They resided in Corpus Christi, Texas at the time. They were looking for a Toy Manchester Terrier because their TMT "Dragon" was aging.

John could tell immediately, and was so impressed, our Standards went back to his mother and father's Chatham lines. He commented, as the dogs were playing in the living room, "these dogs look just like my mom and dad's dogs looked when I was growing up!" I recall having goose bumps as I glanced at Bill.

I do believe that Charles Turner's top winner was Am., Can., Bda. International Champion Chatham's Mitzie, HOF.

Here is a brief commentary on Mitzi taken from the September, 1965 issue of the AMTC Newsletter: There is nothing you can name, (nothing in the world) there is nothing you can name that is anything like this great dame. Here is the redoubtable 5 time BEST IN SHOW Standard Manchester Terrier who has in good sporting fashion campaigned just about everywhere but the South Pacific.

Note the musculature of the powerful hind quarters; the solid bone of limb; the massive brisket; strong neck; bone crushing jaw.

Cleaner than Mr. Clean, this daughter of Champion Downey Boy of Chatham ex Champion Sundown of Chatham isn't mean.

A very nice customer to greet and pet, she just makes you green with envy because she doesn't belong to you.

A "Mitzi" could only belong to a few... like Charlie Turner who breeds Manchester's only to the purple and gives nothing short of his life's blood to



show them in all their excellence to the world.

Mitzi has been campaigned in Canada, Bermuda and the United States and in 3 regions she is a Champion of record. This has been accomplished when Standard competition was at a minimum and expenses to the exhibitor at a maximum.

Chatham Farm is the home of great Champions not only because of the breeding program outline by a thoughtful and wise District 8 Governor Charles H. Turner Jr. but because Charlie is himself a Champion of the breed.

That fair minded man who never complained at a decision of the judges...who always congratulated the winner...who was a magnanimous victor...who would go out of his way to visit you at a dog show even if he weren't entered, to root for your dog. That good natured man...who never raised his voice or spoke in anger... he will not be at the shows with us again. How sad it makes us all.

The last time it was my good fortune to see Charlie Turner was at the District 1 Specialty in September. He came with the most handsome lot of Chatham Farm Manchester's foremost among them the 5 time Best In Show winner Champion Chatham's Mitzie.

Though she did not win that day, the Master Of Chatham Farm was in good spirits. During lunch, someone yelled over, "hey Charlie how much does Mitzi weigh?" His face aglow at the mention of his favorite subject, Charlie crowed, "17 pounds."

That of course is considered the ideal weight and what all other aspects of his Mitzi being ideal

Charles Turner knew quite well that he had in his lifetime come as close as perhaps anyone will to creating the perfect Manchester Terrier. He adored Mitzi and the feeling was quite mutual and now the pair is broken.

Mr. Turner was attached to the legal staff of the Philadelphia Electric Company and retired in 1964 after 37 years of distinguished service. He was also master of the William L. Elkins Masonic Lodge.

Mr. Turner is survived by his wife Ruth, a journalist with the Philadelphia Evening Bulletin; two sons Charles H. III, John W., daughter Mrs. Ruth Nazer, 11 grandchildren; 3 sisters and a brother.

The officers and members of the American Manchester Terrier Club extend deepest and heartfelt sympathy to the entire family.

I have Mrs. Ruth Turner's complete biography. Will dig it out and continue someday.

This has been very interesting. I still get goosebumps reading about the greatest people and dogs in our breed, of days gone by.



An Agility Dog Trainer's Journey with Manchester Terriers




"Meet Beth Mathews-Bradshaw and her Manchester's. Beth has been training and showing in agility for almost 20 years. She currently trains dogs at A Click Above LLC in Leesburg, VA. She has handled dogs of all sizes from Dobermans to 8-pound toy Manchester's. She currently lives in Haymarket, Virginia with her husband, 6 dogs (3 Standard Manchester's, 3 Toy Manchester's) and 2 cats.

How did you get into agility training and agility? I competed with horses from the age of 13 to 30, and at one of the events back in the 90s they had an agility demonstration going on. I didn't think much about it until I got out of horses and still had my Dobe that traveled with me. She needed something to do so we signed up for an agility class and it went from there. I originally started helping my training facility with registration, and then over time I became an instructor in their classes and then an instructor there as well as other places in Northern Virginia teaching private lessons.

Can you explain for those new to owning dogs and new to agility what is it, how it works, why is a clean run important, speed/time etc. Agility is a sport based on speed and faults – so the fastest clean running dog wins. Faults can consist of a refusal (running past the obstacle, turning away at the last minute, spinning right in front of it), missing a contact (the yellow part of the three contacts – teeter, dog walk and A-frame), missing the weave entrance or popping your weaves, or an off-course which is typically an elimination except at the novice level for one particular class. It is always a bal-




ance of teaching the behaviors and encouraging the speed, and what you emphasize with the dog will vary over their career with you as you develop as a team.

Can you tell us about the 2021 AKC National Agility Championship? Competitions in Tulsa OK and how you felt when Prix was the winner of the AKC National Agility Champions 12 inch. 2021 was a tough year for many due to covid, so I have to admit we weren't expecting overly challenging courses since we had some of the year off from showing and the showing we did do was sporadic and variable compared to other normal years. So needless to say we were a bit surprised to get extremely challenging courses the entire weekend – probably the most challenging courses AKC has ever had at their National event. My girls ran great and did exactly as I asked them to do. My older dog Pixel would have gone to finals but I over handled and pulled her off the last obstacle in standard. Prix benefited from running second all weekend so I could fix my errors! She did a great job of running all 5 courses clean, which was quite a feat on these particular courses.

I just wanted Prix to have a good round in the finals and if possible run clean to match the rest of the weekend. We were the fourth dog to run and I was just excited to be able to be in the hot seat (that's where they put the dog that is currently in first) for a run or so, I never expected it to last for 6 more

dogs! In fact, when the last dog came in – he won the gold medal at the World Championships - I was telling Prix that she was going to be on the podium with a World Champion and how exciting was that when that dog faulted and I realized Prix won!

You are a true ambassador for Manchester Terriers to help them get exposure and recognition. Can you share with us what people say or ask you about your dogs. Well, they ask me the same as all of us – why is your MinPin so tall? When I had the Dobermans it was – is that their puppy? LOL I do have agility people ask about them sometimes, if they would be a good dog for them, and I always say it depends and I explain about their personalities and needs. I have recommended a few people for litters, so hopefully more people will get to enjoy these fabulous, joyful little dogs.

How long have you owned Manchesters? My first Manchester was born in 1999, so just over 20 years now.

How did you decide on the Manchester Terrier as the type of dog you wanted? I was thinking about getting a small dog for agility and was at an agility trial with my Dobs and I saw a Manchester and went wait – that looks exactly like a small Dobe! People always say that about MinPins but they never looked like my Dobs to me. I then started researching them and found out Manchesters were the oldest terrier breed and a foundation breed for the Doberman and I was hooked. It doesn't hurt that

they are very elegant and athletic, like my thoroughbred horses, and have the same sleek coat that doesn't require a lot of grooming.

Puppy Extraordinaire

Have you trained all your dogs in Agility? Yes, all my current dogs are trained in agility, and they all have at least 1 MACH, except the ten month old! At one point all 5 of the adults were on the Top 5 list of Manchesters in the US in agility.

Your Dogs are MACH champions, how difficult is that to achieve and what does it take to earn that title? MACH's mostly take a good bit of consistency – to get 20 double Qs, and a reasonable amount of speed to get 750 MACH points. In the case of all my dogs, I have the points I need for a long time before I get the double Qs!

What advice would you give others considering Agility? Give it a try – have fun – enjoy your dog – get good help – don't over face your dog in the beginning. One bad incident takes 20-50 good ones to overcome, so take your time on the hard stuff, and emphasize the fun.

When do you start training your dogs for agility? My puppies start basically as soon as they get home, but probably not the way people think. I do a lot of playing with my puppies – lots of games and retrieving, directionals (left and right) switching back and forth from toy to food rewards, although I use toys more than food when possible, but that varies per dog. I focus on things that small dogs take a long time to do if they are worried – like the teeter and dog walk so I do a lot of foundation work on that from the beginning (back chaining the end of the teeter – running flat boards on the ground to a toy) to get them confident and fast on them low and then slowly work the difficulty up, and of course with Manchesters the stay – which all of mine wish I would be willing to go without! LOL I don't train weaves until they are at least 14 months old, and even handling I keep simple and to a minimum until they are close to a year.

Where do you start training for Agility and what other training do you consider foundational or vital to help succeed in Agility training and competition? Agility training starts at home but I also do puppy class with all of mine and usually one or two of the lower level foundation type classes to get them used to working around other dogs while in drive. ACA where I teach has great classes at all levels so I take advantage of that for my dogs whenever possible.

Because Manchesters are small dogs – I also think a good recall and a good stay are vital, just for their safety in life and at trials. For my toys, I also spend time holding them during class, because my drivey toys want to be on the ground doing things, but:

- a) 90% of agility is sitting around waiting for 1 minute or less in the ring, and
- b) it isn't always safe for really small dogs to be on the ground around other dogs you don't know for sure





are good with small dogs. They can be mistaken for prey. So teaching some patience with being held is also key.

What essential equipment do you to have at home to practice for agility? I have all of the equipment at home but I don't use it much since I tend to train where I teach. That said at home I have a small contact sized board to start with, I have a dogwalk but that is usually just the ramps leaning on a table, I have a teeter, and a set of channel weaves and a set of 2X2s. Things that dogs learn better in short bursts of training (running contacts, weaves) are the things I use at home most.

If you are going to do running contacts you really do need to have contacts at home, or rather, have good access to contacts multiple times a week. Stopped contacts are easier to train without equipment.

Is there a difference in agility equipment and what is your favorite brand(s) to buy for durability and reliability? There are definitely differences in agility equipment, and a lot of it has evolved over time, from sand contacts to rubber, different bases, etc. We use M.A.D. Agility Equipment a lot in my

area, and they supply equipment at AKC's big events too. That said, it's good to expose them to different manufacturer's equipment if it will be at a big event. Teeters especially can have very different balance points that small dogs are sensitive to, and weave base structure can also affect performance in the weaves for some dogs.

What activities do you and your dogs do together regularly? All my dogs going hiking on trails 5-6 days a week, even my 14 and 15 year old. I also do some core strength training exercises at home. Pixel and Prix go to the barn with me and go hacking with the horses. My toys are too small to do this safely so they don't get that fun! And if my yard is dry I also play Frisbee or let them run in the yard – only under supervision as some of that helps with the agility fitness, but no body slamming or roughhousing allowed, especially since I have such size differences. Dash is doing some rally now that she isn't allowed to do agility anymore.


What type of ongoing training and exercise do you do with your dogs for agility? See above...

As an Agility trainer and an owner of Manchesters what general training tips can you provide to others pet owners and breeders about the Manchester Terrier? Manchesters are incredibly smart, joyful little dogs so you need to target your training to that. For instance, Pixel likes to do a course with her ball in her mouth after we do my course – it is a compromise we came to years ago and it works for both of us. I also think with every dog you need to be flexible. Every dog I have has learned how to weave a different way. I've used multiple methods but some click with certain dogs more than

others. Be willing to think outside the box with this breed – if they love to run and retrieve a ball, but don't want to tug, that's totally fine, use a ball. I like to figure out what is the most natural thing for my puppies and train that way – for example – I figure out which position they like best and are most stable in for their stays and that is what I ask them to do on course. I also think it is important to look at the big picture – I've had dogs that are very latent learners, that I've thought would take forever to figure something out that get it with some time to think – and they have become great agility dogs. I've had others that are so brilliant you teach them something in 30 seconds and are then like, hmm, what do we do now? I tweak my training to each dog because they all are individuals, but at the end of the day I want them to be fast and joyful about playing with me, because that's what it's all about. I think for this breed there is a fine line you have to walk between obedience/accuracy and the joy that gives you speed – Manchesters are terriers and can be a little independent at times so you need to work with that, not against it, or you will lose the joy and get accurate dogs that trot around the course and for me at least that's not what I'm after.

What would you tell others who are considering a Manchester Terrier? I always tell them how active a breed they are – many pet owners are not prepared for that. Of course, I look for the busiest, drieviest puppy in the litter. But I personally love how they also work very collectively in a group – mine



are very bonded to each other and me. It's a big pile of Manchesters (and a black cat who thinks she's a Manchester!) at my house at night on the couch with me. I also mention that their smooth coat is great for hiking and dirt/mud but they do need climate control help if you live where it is really cold or really warm, especially if you are working or competing with them.

Can you share with others how Dash is doing and the background around the need for a pacemaker? So Dash's case has been unusual to say the least. She has an AV block arrhythmia that over time worsened in severity. We don't know why, it isn't hereditary, it just is. She is doing great with her pacemaker. She has had some other complications but they are not heart related – she has had a bit of an auto-immune response – perhaps to the pacemaker as we can't diagnose an actual disease – but she is responding to the meds well. She was trying to play with the other dogs in the yard yesterday – but I keep her under wraps a bit as I don't want anyone running into the pacemaker – it is on her side and as small as she is it takes up a good bit of room in her abdomen. We are doing some rally work to keep her entertained. She's a super tough little dog and we are thrilled every day to still have her with all of us.

Is there anything else you would like to share about yourself, training, agility your dogs and or Manchesters in general? Just that I love this breed and I think they can do many sports, or be a pet, very well. I really hope we don't lose them as a breed, and that we can get more people to appreciate what awesome little dogs they are. And that it was really, really great to see a Manchester terrier on the AKC web page for agility!



The Black and Tan Terrier

The New Book of the Dog, 1907, By Robert Leighton.

F.C. Hignett

*“Calm though not mean, courageous without rage,
Serious not dull, and without thinking sage;
Pleased at the lot that Nature hath assigned,
Snarl as I list, and freely bark my mind;
As churchman wrangle not with jarring spite,
Nor statesmanlike caressing whom I bite;
View all the canine kind with equal eyes,*

*I dread no mastiff, and no cur despise.
True from the first, and faithful to the end,
I balk no mistress, and forsake no friend.
My days and nights one equal tenour keep,
Fast but to eat, and only wake to sleep.
Thus stealing along life I live incog.,
A very plain and downright honest dog.”*

THE Black-and-tan, or Manchester, Terrier as we know him to-day is a comparatively new variety, and he is not to be confounded with the original terrier with tan and black colouring which was referred to by Dr. Caius in the sixteenth century, and which was at that time used for going to ground and driving out badgers and foxes:

“Another sort there is that hunteth the fox and the badger only, whom we call Terrars,” wrote the Doctor’s translator. “They (after the manner and custom of ferrets in searching for coney) creep into the ground, and by that means make afraid, nip and bite the fox and the badger in such sort that either they tear them in pieces with their teeth being in the earth, or else hail and pull them perforce out of their lurking angles, dark dungeons, and close caves, or, at least, through conceived fear, drive them out of their hollow harbours, inasmuch as they are compelled to prepare speedy flight, and being desirous of the next (albeit not the safest) refuge are otherwise taken and entrapped with snares and nets laid on holes to the same purpose. But these be the least in that kind called Sagax.”

Formerly there was but little regard paid to colour and markings, and there was a considerably greater proportion of tan in the coat than there is at the present day, while the fancy markings, such as pencilled toes, thumb-marks, and kissing spots were not cultivated. The general outline of the dog, too, was less graceful and altogether coarser. A fair idea of what the ancient Black-and-tan Terrier

was like may be gathered from the accompanying woodcut, where the dogs appear not only of a very different colour, but also far heavier in build, as well as thicker in the head, than would now be tolerated.

During the first half of the nineteenth century the chief accomplishment of this terrier was rat-killing. There are some extraordinary accounts of his adroitness, as well as courage, in destroying these vermin. The feats of a dog called Billy are recorded. He was matched to destroy one hundred large rats in eight minutes and a half. The rats were brought into the ring in bags, and as soon as the number was complete Billy was put over the railing into their midst. In six minutes and thirty-five seconds they were all destroyed. In another match he killed the same number in six minutes and thirteen seconds. At length, when he was getting old and had but two teeth and one eye left, a wager was laid of thirty sovereigns by the owner of a Berkshire bitch that she would kill fifty rats in less time than Billy. The old dog killed his fifty in five minutes and six seconds. The pit was then cleared and the bitch let in. When she had killed thirty rats she was completely exhausted, fell into a fit, and lay barking and yelping, utterly incapable of completing her task.

It was a popular terrier in Lancashire, and it was in this county that the refining process in his shape and colouring was practised, and where he came by the name of the Manchester terrier. The method by which he was transformed into the

handsome Black-and-tan is not difficult to trace, as several of the men who took part in the process are still living.

Rat-killing was a favourite pursuit in the Manchester district, the old-fashioned terrier being used to hunt the rivers and water-courses where the rodents were to be found in plenty. Rat-pits were also very much in vogue, one of the principal rendezvous being a room in "The Three Tuns" public-house, in Chapel Street, Bolton, then kept by old Joe Orrell, quite a character in his way and an enthusiastic lover of the sport.

One of the most famous dogs, by reason of his winning so many matches, was a cross-bred terrier, dark brown in colour; and, as rabbit-coursing was also freely indulged in by the same school, the idea occurred to one John Hulme, who lived at Crumpsall, to produce a dog which would suit

both purposes; hence it was that he bred from this terrier and a Whippet. The idea was also taken up by W. Pearson, of the same place, and, as the result was very satisfactory from a utilitarian point of view, many others in the neighbourhood of Manchester followed suit, a few of the more notable being Jos. Kay, Henry Lacy, M. Openshaw, C. Harling, J. Barrow, W. Fielding, Josh Fielding, W. Fletcher, J. Fietcher, Joe Walker, S. Handley, Robt.

Lee (Bolton), T. Swinburn, Joe Holt, and a few others who earned the sobriquet of "The Manchester School." It was from their joint efforts that the variety became known as the Manchester terrier, and was gradually brought to a state of perfection in colour, markings, and type. Most of these worthies have joined the great majority, but Mr. Swinburn, Mr. Holt, and Mr. Lee—the last-named, by the way, is now the oldest dog fancier in the country—still survive.

In those days very few dog shows were promoted, the majority of them being held in public-houses, and, of course, the individuals before mentioned took an active interest in them; wherefore it follows that classes for these terriers were introduced, and very shortly many other adherents who afterwards gained fame, joined the ranks of exhibitors. Of these several became prominent judges, notably J. Barrow and J. Taylor, while the successful prize-winners were J. Allen's Cupid, Mr. Justice's Vixen, Viper, and Victor, Mr. J. Key's Topsy and Virago. Then Mr. John Tatham introduced his two Jerrys, and a little later Mr. J. H. Mather got together a very formidable team, the nucleus of which was obtained from Mr. Justice.

It is not generally known that the eminent Fox-terrier expert, Mr. Robert Vicary, is also a very old admirer of the breed under notice. He judged them at important shows long years ago, and has still an affection for them.

Coming to a later epoch, we find Mr. T. Ellis, of Cheetham Hill, introduced to the fancy, and he very soon made his presence felt by his success, eventually attaining a very high position, for his Ch. Pearl was practically invincible. At all events, she won during her career something like 150 first prizes and a large number of cups and other trophies. Mr. Ellis has also the distinction of having been represented by the largest number of entries ever made at a show by one owner or firm, for on two occasions when the Aquarium Terrier Shows were promoted he sent in twenty entries, completely ousting all his rivals by securing all the principal prizes as well as the one for the best team of any variety. Turk was another celebrity owned by him.

Colonel C. S. Dean afterwards came into possession of Ch. Pearl, he having established at Bebbington the largest and most complete kennels ever devoted to the breed, from which ema-

nated many champions, notable amongst which were Starkie Ben—picked up cheaply after he had made a successful appearance at a small show which took place at Farnworth, near Bolton—Benham Daisy, Benham Beauty, and others who did credit to that prefix. Mr. J. Howarth, of Manchester; also made his mark; one of his dogs, Strangeways General, being not only a big winner but a noted sire. Mr. T. Whalley, ex-chairman of the Kennel Club Council of Representatives, Mr. Tweed, and Mr. H. Monk have been amongst the most successful exhibitors in the south, but for some occult reason the breed has never become so popular there as it is in the north; the neighbourhood of Bolton, in particular, is noted as a breeding centre.

No one, however, has been quite so successful in recent years as regards the number of prizes won as Mr. W. Barlow, of Redcliffe, and his brother James, of Farnworth, for between them they have bred more noted winners than anyone else, such names as Prince Imperial, Beaconsfield, Marvel, and Brilliant Star, being familiar through the frequency of their appearance in the prize-lists. The first mentioned is also the progenitor of nearly all our biggest winners at the present time, for his alliance with old Queen and Beauty, two of his kennel mates, has resulted in a greater certainty of the production of long, clean heads, with correct colour and markings, where formerly wide skulls and smutty colouring were the all too common whims of fortune, which had, perforce, to be endured by the majority of breeders. We must not omit to mention the late Mr. Brereton Lathom, of Eccles, whose efforts to revive public interest in the breed at a time when it had reached the lowest ebb will always be acknowledged. He also owned several good specimens, the best being probably Sir Alfred, amongst whose many victories may be cited that at one of the earlier Manchester Dog Shows, where he carried off the cup. Nor would this chapter be anything like com-

plete if mention were not made of Mr. J. J. Johnson, of Manchester, an old and faithful friend of the breed, and one of the most respected judges of to-day.

There are many who hold the opinion that one of the chief reasons for the decadence in the popularity of the Black-and-tan terrier, notwithstanding its many claims to favour, is to be found in the loss of that very alert appearance which was a general characteristic before the Ken-

nel Club made it illegal to crop the ears of such as were intended for exhibition. It must be admitted that until very recently there was a considerable amount of truth in the prevalent opinion, inasmuch as a rather heavy ear, if carried pretty erect, was the best material to work upon, and from which to produce the long, fine, and upright, or 'pricked' effect which was looked upon as being the correct thing in a cropped dog; hence it followed that no care was taken to select breeding stock likely to produce the small, semi-erect, well-carried, and thin ears required to-day, consequently when the edict forbidding the use of scissors came into force there were very few small eared dogs to be found. It has taken at least ten

or a dozen years to eradicate the mischief, and even yet the cure is not complete, although the difficulty has, to a great extent, been overcome, for the majority of the exhibits at the principal shows are as nearly correct as may reasonably be

expected. Still, prejudice will prevail, and it would be futile to indulge the hope of any immediate prospect of greater partiality being shown to the breed by those who are undecided as to what variety is most suitable to start with in the exhibition world.

Another factor which has had a bad effect is the belief, which has become much too prevalent, that a great deal of "faking" has been practised in the past, and that it has been so cleverly performed as to deceive the most observant judge, whereby a very artificial standard of quality has been obtained. Worse still, it is thought to be almost impossible to win the best prizes even now without adopting unfair means in the preparation of these dogs for show; and this notwithstanding the stringency of the Kennel Club regulations now in force. As a matter of fact, this prejudice is quite unreasonable; no dogs are more easily kept in proper condition; besides, their dark colour does not show dirt, hence washing becomes almost unnecessary,

a very great consideration where dogs are kept as companions or guards, but more so in the case of those who travel long distances for exhibition at shows.

The breed is gaining ground in Scotland owing to the enterprise of the club which exists and fosters it north of the Tweed, but the original Black-and-tan Terrier Club, which has its headquarters and holds all its annual meetings in London, does not appear to exert itself much in the direction which would place it in a position of greater influence, and bring sufficient funds into its exchequer, from which more shows could be supported, and the prosperity of the breed ensured. This is in some measure probably to be accounted for by the fact that most of the members who can attend the meetings are principally interested in the Toy variety (which are separately dealt with in another chapter); at all events, it has only been on very rare occasions during the last two years that the club has granted special prizes, much less guaranteed classes, at any shows, for Black-and-tan terriers proper.

The standard of points by which the breed should be judged as laid down by the club is as follows:

1. **General Appearance.**—A terrier calculated to take his own part in the rat pit, and not of the Whippet type.
2. **Head.**—The head should be long, flat, and narrow, level and wedge-shaped, without showing cheek muscles; well filled up under the eyes, with tapering, tightly-lipped jaws and level teeth.
3. **Eyes.**—The eyes should be very small, sparkling, and bright, set fairly close together and oblong in shape.
4. **Nose.**—Black.
5. **Ears.**—The correct carriage of ears is a debatable point since cropping has been abolished. Probably in the large breed the drop ear is correct, but for Toys either erect or semi-erect carriage of the ear is most desirable.
6. **Neck and Shoulders.**—The neck should be fairly long and tapering from the shoulders to the head, with sloping shoulders, the neck being free from throatiness and slightly arched at the occiput.
7. **Chest.**—The chest should be narrow but deep.
8. **Body.**—The body should be moderately short and curving upwards at the loin; ribs well sprung, back slightly arched at the loin and falling again at the joining of the tail to the same height as the shoulders.
9. **Feet.**—The feet should be more inclined to be cat- than hare-footed.
10. **Tail.**—The tail should be of moderate length and set on where the arch of the back ends, thick where it joins the body, tapering to a point, and not carried higher than the back.
11. **Coat.**—The coat should be close, smooth, short and glossy.
12. **Colour.**—The coat should be jet black and rich mahogany tan, distributed over the body as follows: On the head the muzzle is tanned to the nose, which with the nasal bone is jet black. There is also a bright spot on each cheek and above each eye; the underjaw and throat are tanned, and the hair inside the ears is the same colour; the forelegs tanned up to the knee, with black lines (pencil marks) up each toe, and a black mark (thumb-mark) above the foot; inside the hindlegs tanned, but divided with black at the hock joints; and under the tail also tanned; and so is the vent, but only sufficiently to be easily covered by the

tail ; also slightly tanned on each side of the chest. Tan outside the hind legs—commonly called breaching—is a serious defect. In all cases the black should not run into the tan, nor vice versa, but the division between the two colours should be well defined.

13. **Weight.**—For toys not exceeding 7 lb.; for the large breed from 10 to 20 lb. is most desirable.

An ultimate world-class Dogman

Jo Ann Emrick

The Kendrick name is legendary in purebred dog circles. William Kendrick, also called "Bill", "Billy" and "Wild Bill" was born in 1904. He was a native of Philadelphia.

He attended Haverford School and graduated from Princeton University in 1926.

While a junior (age 21) at Princeton University he became a licensed dog judge.

He was a diligent student of pure-bred dogs. Kendrick collected rare books on dogs and had lengthy correspondence with other fanciers such as Geraldine Rockefeller Dodge, the founder of the prestigious Morris and Essex Dog Show.

Kendrick was known as a serious, colorful and highly respected judge with a wonderful sense of humor.

During his career the AKC approved him to judge all breeds. Mel Downing has said that, "He (William Kendrick) probably possessed a greater knowledge of dogs than any other judge." Other notable legendary judges such as Alva Rosenberg

and Henry Stoecker were awed by his knowledge and Anne Clark often cited Kendrick.

During his 60 years as a judge he built a reputation as the fancier's fancier.

As a breeder and a judge he was one of few who could boast to have attended both the AKC's Sesquicentennial show in 1926 (as an exhibitor) and its Centennial show in 1984 (as a judge) both held in Philadelphia. He was the Best in Show judge at the latter event.

For those who are interested Mr. Kendrick wrote a wonderful article about the Sequi Dog Show in the September 1959 AKC Gazette. He notes in the article that there were 27 Manchester Terriers and 6 Toy Black and Tan Terriers.

Kendrick consistently worked to enhance the popularity of lesser known breeds. His judging style often ignored the usual popular choices. He awarded top placements to many breeds usually

overlooked, no matter what the rankings and glossy advertising said. *"THERE was no need for exhibitors, whose dogs had gained awards, to express more than the conventional "thank you" to show judges who had made the selections",* said William L. Kendrick of Devon, Pa., at a meeting (March 1967) of the Dog Fanciers Club at the Overseas Press Club.

Kendrick was known for his honest, blunt and sometimes brutal, pronouncements on the show scene:

Dog ratings: *"I feel all rating systems should be consigned to the ashcan."*

Junior handling: *"We should be judging dogs, not kids."*

Dog handlers: *"The best handling is the least handling."*

Club hospitality: *"The exhibitor is the forgotten person. Judges invariably are provided with luncheon, but the exhibitor is lucky to be able to buy a hot dog."*

Judges and exhibitors alike commented that he had a great eye for a dog and a great sense of humor.

"We used to call him Wild Bill Kendrick. Once at a big show can't remember if Chicago or New York, he had the dogs moving in two figure 8s at the same time, LOL and in those days they used to spar the terriers. He made a show out of that."

"At Philadelphia one year he lined up 4 exhibits for what everyone thought (1-4) were his selections for group placings. Smiling, he pointed to the handler and dog at the front of the line (who obviously thought the win was a lock)

and went: 4-3-2-1!"

William Kendrick judged at the Westminster Dog show (all assignments) a total of 15 years from 1937-1971 (1937, 1938, 1945, 1949, 1951, 1952, 1953, 1958, 1960, 1961, 1964, 1967, 1968, 1970, 1971) but did not judge Best In Show even though he was one of the most respected judges in America.

In the Judge's 10 Commandments Mr. Kendrick wrote the 7th commandment: Thou Shalt Not Be Hoodwinked by Clever Handling.

"The best handling is the least handling."

Mr. Kendrick Retired from Judging in 1989.

In 1973 Bill Kendrick married Venelle Hartman. She too was a Dog Fancier and was both a handler and later a judge. She started out in Poodles in 1957 and became a professional handler. She could groom a Poodle to perfection and won many Best in Shows, including at the prestigious Poodle Club of America.

As a judge, she judged at some of America's most prestigious shows, which included judging the Toy Group at the Westminster Kennel Club, and Best in Show at the Poodle Club of America. Vernelle Kendrick judged at Westminster in 1986, 1991, 1993, 2000

She was said to be a special lady, wonderful judge and was a good handler. Someone mentioned in a facebook posting: *"I remember the late Vernelle Kendrick telling me that she didn't need to read magazines to find a good dog. She could use magazines to rule out the bad ones"*

Mr. Kendrick was a breeder and exhibitor initially of Bull Terriers prior to attending college. He later

acquired the Queensbury Kennel from his uncle W. Freeland Kendrick, the former mayor of Philadelphia. As a result he actively breed and exhibited Bull Terriers, Manchester Terriers (Standard Variety) and many other lesser-known breeds. He also introduced the Boxer to the Philadelphia area.

As a Fancier of Dogs, Kendrick served as:

- President of the Kennel Club of Philadelphia for thirty years when he retired in 1990.
- Secretary of the Manchester Terrier Club during the late 1940's and 1950's.
- President, Philadelphia Bull Terrier Club 1930's
- delegate to the AKC
 - Member of the Montgomery County Kennel Club

During his time in college he was showing a Manchester Terrier named Queensbury Surprise, "Surprise". He had purchased Surprise from G. D. Simpson of Kent NY. Surprise went on to take winners and best of breed at Tuxedo and repeated it again at the Bronx. Surprise defeated Harvest Flyer for Best of Breed at New York.

Dixie Dempsey, author of the Complete Toy Manchester and at the time, the Publicity Director for the American Toy Manchester Terrier Club of America, wrote in the AKC Gazette circa 1947, *"I also talked to William L. Kendrick, who judged the Houston show and who is an undisputed authority on our breed. He thinks the future of the Manchester is bright. He thinks we are working along the right lines. He is especially pleased at the improvement in heads. He said in his judging in various parts of the country, he seldom sees one of the old apple heads being shown. He, too, praised the soundness of feet and legs, but he thinks*

Queensbury Surprise Wins Over Ch. Black Vick

Under date of October 13th. G. D. Simpson, of Kent, N. Y., writes: "Received a telegram yesterday from Wm. L. Kendrick, of Philadelphia, conveying the information that his Manchester Black and Tan Terrier, Queensbury Surprise, scored a great victory last week by defeating Ch. Black Vick, a six hundred dollar dog recently imported by a wealthy and prominent fancier of Philadelphia. This winning makes Queensbury Surprise a champion and he was not two years old until the twenty-third of October. The dam of this new champion is soon due to whelp what will probably be her last litter of pups, as she is nearly ten years old and almost blind. Benham-Willowdale Prince is the sire of the coming litter and also the sire of Kendrick's pair of winners, Queensbury Surprise and Queensbury Dawn. The latter lacks only four points of a championship, having one four-point and one three-point show to her credit."

we must never lose sight of the fact markings are our most distinguishing feature and we should fight hard to preserve them."

His affection for the breed was evident, when as a judge, he constantly recognized the breed at all levels. It was his honor to award Best in Show to the following:

- Klipper Coquette (SMT), June 19, 1955 – Chain O'Lakes Kennel Club, Lake Forest, IL.
- Canyon Crest's Dinah (SMT), March 17, 1964 – Shreveport Kennel Club, Shreveport, LA.
- Chatham's Mitzie, May 15, 1965 – Chester Valley Kennel Club, Ludwig Center, PA.
- Renreh Lorelei of Charmaron (TMT), June 2, 1968 – Delaware Co Kennel Club, Newton Square, PA
- Salutaire Surely You Jest (TMT), December 8, 1985 – Antelope Valley Kennel Club, Antelope Valley CA.

One Breeder discussed his dog Canyon Crest Stewardess and noted the following:

These are what Manchester Terriers should look like today.

This dog flows. The angulation is excellent. The top line is perfection. The tail set and carriage can't get any better with the slightly rounded croup.

The 1st and 2nd thigh excellent I have seen none better in today's time. Personally I like the shorter crop on the terrier like depicted. They are terriers. They should be depicted and judged as so.

I would only take a couple of points off for the planes of the head, that is it. Even at that, still very pleasing.

Mr. Kendrick is impressive. A very dapper chap indeed. He would not have anything of lesser quality.

The Kendrick's traveled expensively, judging and adding to their collection of paintings by a wide range of nineteenth and early twentieth century

artists.

William Kendrick, died mid-September 1992 in Pennsylvania. He was 88 years of age. His wife Vernelle Kendrick died in 2016.

After both of them had passed away, their Art-work collection over 25 pieces was placed on Exhibit at the William Secord Gallery in NYC, NY. From October 13, to November 03, 2017. All the artwork on display was made available for purchase.

“Many of the paintings in the collection are related to William’s breeding interests, with nineteenth century paintings of Manchester Terriers, Bull Terriers and Fox Terriers. When he married Vernelle Hartman in 1973, paintings of Poodles, Pekingese and Collies were added to their collection, including an extraordinary painting by Maud Earl of two Pekingese puppies with an African Gray parrot, painted in her classic oriental style of the 1920’s”

“Over twenty-five works will be exhibited, including historic paintings by Alfred de Dreux (French, 1810-1860), George Earl (English, 1824-1908), Maud Earl (English, 1864-1943), Marmaduke William Flower (English, 1849-1910), Frederick Hall (m am English, 1860-1948), Gustav Muss-Arnolt (American, 1858-1927), Carl Reichert (Austrian, 1836-1918), Philip Stretton (English, fl. 1884-1919) and Arthur Wardle (English, 1864-1949), among others.”

“Taken in its entirety, the collection is a testament to one couple’s love of purebred dogs and their ongoing pursuit of the dogs history and its depiction in the visual arts.”

Being too tucked up at loin, it clearly depicts the splendid head, front and general makeup of this consistent winner....*"

Editor Dog Fancier:—I just received a letter from Wm. L. Kendrick, a Philadelphia fancier, who bought a pup from me last winter and registered him under the name of Queensbury Surprise. He says; "Surprise took winners and best of the breed at Tuxedo, and repeated the feat at the Bronx. On both occasions he defeated for best of the breed the bitch that went to winners at New York last February. This bitch defeated Harvest Flyer for best of the breed at New York. I have also sold a sister of Queensbury Surprise to F. C. McLean, Hull, P. Q., Canada.—G. D. Simpson, Kent, N. Y.

Mr. G. D. Simpson's old Manchester Terrier female, the dam of Champions Queensbury Surprise and Queensbury Dawn, passed out this spring from old age after a worthy career. A daughter of hers, sister to the champions mentioned above, whelped a fine litter of pups in September, sired by Mr. Geo. H. Earle's much-heralded English Champion, Black Vic. Mr. Simpson, owner of these dogs, is a prominent breeder of this breed at Carlton, N. Y. He had a further misfortune this summer in having a promising young female, sired by Ch. Harvest Flyer, killed by an auto running over her. Besides being breeder of the champions, Surprise and Dawn, Mr. Simpson also bred Queensbury Bud and Tam of Daingerfield, prominent winners.

Here's recipe that makes a great take along meal for those in an RV heading to the Dog shows.

Hearty Lentil Stew

1 potato, peeled and cubed
2 medium onions, peeled and chopped
1/4 pound mushrooms, sliced
1 clove garlic, chopped
1 medium carrot, peeled and sliced
2 stalks celery, chopped
1 1/2 cups lentils, rinsed and drained
1 (16 ounce) can tomatoes, undrained and crushed
2 cups beef broth
1 cup water
1/2 dry red wine
1 small bay leaf
1 tablespoon Worcestershire sauce
1/2 teaspoon thyme
1/2 teaspoon marjoram
1/4 teaspoon black pepper

1/4 teaspoon marjoram
1/4 teaspoon chervil
1/4 teaspoon caraway seeds

Lightly brown potato, onions, mushrooms, garlic, carrot and celery in a non-stick skillet sprayed with vegetable coating. Add lentils, tomatoes, broth, water, wine, bay leaf, Worcestershire sauce, thyme, marjoram, pepper, chervil and caraway seeds.

Simmer, partly covered adding water as needed, 1 to 1 1/2 hours, until vegetables and lentils are tender. Makes six servings.

Manchester Terrier Club—Historical Notes

- In May of 1912 the Manchester Terrier Club was elected as a member of the AKC. By 1922 the club had been dropped from active Membership for non-payment of dues for 1922, this also effected two other clubs.
- In 1923 the club was reelected to membership in the AKC.
- In 1925 T. Pearsall Field was nominated as the AKC delegate for the Club. He continued as the delegate until 1932. Mr. Field was the owner of Kerney Rose
- In 1928 the AKC voted on banning the cropping or cutting of ears. It was defeated 35 to 41.
- In 1953 the Manchester Terrier Club had gone on record as to dropping from membership in the AKC. At that time there is mention that perhaps the Toy Manchester Terrier Club of America might seek to represent the breed, divided into two varieties for show classification.
- In 1952 Dr Herbert E. Viergutz was approved as an apprentice judge of Manchester Terriers and Toy Manchester Terriers.
- In 1959 The Manchester Terrier Club and The Toy Manchester Club of America combined to form the club we have today.

BODY short

HEAD narrow, almost flat, slight indentation up forehead; wedge-shaped; long and tight-skinned; cheeks smooth; well filled under eyes

EARS erect or button, small, thin; smaller at root, set high on skull close together; if cropped to point, long; erect

EYES small, bright; set moderately close; oblong slanting upwards on outside; should neither protrude nor sink; near black

NECK slim, graceful, free from throatiness slightly arched from occiput, blending into shoulders smoothly

NOSE black

MOUTH, level

BACK slightly arched at loin, falling to set-on of tail (same height as shoulder)

MUZZLE tapering to nose; jaws tight lipped

LOINS powerful

CHEST narrow between legs; brisket deep

COLOR black and tan; definite markings



Other than that, finances are okay, registrations are up, shows are down, and everyone is hoping




2021 AMTC Archive Inventory as Received from Virginia Antia via Wendy Schober


Going back a couple years now, I was told by our BOD if the HOF photos were digitized they would be added to the Club website.

Michelle Barlak, Health Committee Chair

In the April 28 meeting of the AMTC Board, I presented the results of the 3 surveys recently sent to the membership, and my recommendations based on those survey results.



The first survey was about membership response to the idea of AMTC starting its own semen bank. The results were as follows:

- 77.5 % of respondents were active breeders.
- 40% of active breeders have frozen semen stored
- 68.7% of those with semen stored have a plan for the semen to be willed to an individual upon their passing
- About 57% of those with semen stored would consider or would be willing to donate semen to the club now
- About 76% of those with semen stored would consider or would be willing to leave their frozen semen to the club upon their passing
- 45% of active breeders would purchase semen from the AMTC and 48% said they would consider it
- 48% of respondents are in favor of an AMTC Semen bank and an additional 48% would consider voting in favor of it.

Based on these survey results, this will be discussed at the AMTC General Membership Meeting at the 2021 National and volunteers will be solicited to continue to explore this idea. A lot of the groundwork has been done already by the Otterhound parent club and by the AKC, which would make the set-up and operation a little easier for our club, should we pursue this.

Health Committee Report— Continued

The next two surveys were soliciting membership feedback on the revised health test requirements for OFA CHIC. The following were voted on by the AMTC Board and approved by OFA. The new tests are as follows (effective immediately). Each owner must self report on the variety of their dog when submitting their test results to OFA.

Standard Manchester Terrier: The 4 required results were the top 4 voted on by the membership in the survey. The 5 optional results were the next most popular selected health tests on the list. As health chair, I agreed with these survey results and the AMTC Board also agreed and voted to make it official.

Required:

1. von Willebrand's Disease: DNA-based vWD test from an approved lab; results registered with the OFA
2. Autoimmune thyroiditis: OFA evaluation from an approved laboratory
3. Eye Examination: Eye Examination by a boarded ACVO Ophthalmologist
4. Cardiac Evaluation: Congenital Cardiac Exam, Advanced Cardiac Exam, Basic Cardiac Exam

Optional:

- Legg-Calve-Perthes: OFA Legg-Calves-Perthes Evaluation
- Juvenile Dilated Cardiomyopathy: DNA based JDC test from an approved lab

- Congenital Deafness: OFA evaluation based on BAER test
- Patellar Luxation: OFA evaluation, minimum age 1 year

Toy Manchester Terrier: The 5 required results were the top 5 voted on by the membership in the survey. The 3 optional results were the next most popular selected health tests on the list. As health chair, I agreed with these survey results and the AMTC Board also agreed and voted to make it official.

Required:

1. Legg-Calve-Perthes: OFA Legg-Calves-Perthes Evaluation
2. Juvenile Dilated Cardiomyopathy: DNA based JDC test from an approved lab
3. Xanthinuria type 2A: DNA based XUa2 test from an approved lab
4. von Willebrand's Disease: DNA-based vWD test from an approved lab; results registered with the OFA
5. Autoimmune thyroiditis: OFA evaluation from an approved laboratory

Optional:

- Patellar Luxation: OFA evaluation, minimum age 1 year
- Eye Examination: Eye Examination by a boarded ACVO Ophthalmologist
- Cardiac Evaluation: Congenital Cardiac Exam, Advanced Cardiac Exam, Basic Cardiac Exam





In April, AMTC Rescue was asked to take in a dog relinquished to a shelter by her owners. The dog was geriatric and displaying severe ataxia, along with a multitude of other symptoms. After intake, we were able to figure out the surrendering owners' veterinary

office and they shared with us the dog's medical chart. The shelter released the dog with results of tests they had run and x-rays. Dianna Texer and Sherrill Printemps cared for the dog and took her to a local veterinarian to go over all of the dog's symptoms and the test results. Unfortunately, it was determined that the dog's quality of life was very poor, and the condition was not treatable and the decision was made to humanely euthanize her. Dianna and Sherrill stayed with her so she was not alone.

Sometimes we have to make difficult decisions for our rescue dogs. We took her in hoping there would be a simple answer to her condition and that she had not been simply abandoned by owners to die alone in the shelter. One of my mentors in rescue once told me that even if you are only taking in a dog that ended up being euthanized, at least that dog was loved and cared for in their last days, and with someone who knew and understood the breed. Thank you to Dianna and Sherrill for showing this sweet Manchester love and compassion in her final days.




District 2





Agility is a growing dog sport in the United States, with over 1 million entries to the AKC's Agility program each year. Dogs race against a clock as they navigate an obstacle course with strong concentration and speed. Whether you just want to have fun exercising with your dog, or want to go further and enter an Agility competition, get ready for a fast-paced, rewarding experience that will get you and your dog in the best shape of your lives! Based on the dog's size at the withers, a handicap is applied and points are earned:

- 18" or greater = Handicap is 1.0
- 12" up to less than 18" = Handicap is 1.5.
- Below 12" = Handicap is 2.0.

MPH X HANDICAP = POINTS

Titles are earned at specific point levels and the highest suffix may appear after the dog's name:

BCAT = 150 points

DCAT = 500 points

FCAT = 1,000 points



How the PPCP Program Works

American Manchester Terrier Club Code of Ethics

Membership in the American Manchester Terrier Club (AMTC) is a privilege. In return for acceptance into the AMTC, I promise to abide by the following Code of Ethics and to submit to the enforcement of this Code by the AMTC Board of Directors.

GENERAL

I pledge as an owner of Manchester Terriers to be responsible for the dogs in my care. My responsibilities include providing proper shelter which is clean, dry and warm; appropriate veterinary care and inoculations; emergency veterinary care when needed; quality food and water; adherence to local and state animal control and licensing laws.

BREEDING

I pledge:

1. To accept and uphold the Standard of the Manchester Terrier as developed by the AMTC and approved by the AKC.
2. To breed only physically and mentally sound Manchester Terriers in order to maintain or improve the qualities of the breed as set forth in the Standard. I will not participate in the indiscriminate breeding of studs or bitches with no regard to quality.
3. To screen or obtain proof of screening of breeding stock for communicable diseases, hereditary faults or defects, either active or dormant. Questionable animals will not be used in my breeding program.
4. To forego breeding unless financially capable and willing to responsibly and caringly maintain whelped puppies until placed in their new homes.
5. To maintain complete and accurate breeding records in accordance with AKC regulations.

SELLING

I pledge:

1. To in no way misrepresent any Manchester Terrier for sale.
2. To provide all buyers with:
 - A. AKC individual registration application or certificate properly filled out by seller.
 - B. Minimum three-generation pedigree.
 - C. Record of inoculations, worming, etc.
 - D. Provide instructions for feeding and care.
 - E. Be available for guidance and questions.
3. **Not** to sell, give, trade, abandon or in any manner transfer litters or individual Manchester Terriers to pet dealers, pet wholesalers, auctions, laboratories, raffles, pet stores, puppy mills, animal shelters, or any source for resale. I will not knowingly transfer ownership or provide stud service to anyone who intends to breed Manchester Terriers for any of the above listed purposes.
4. To take back any Manchester Terrier I bred if the current owner of the dog can no longer keep him or her. I will evaluate the dog as to whether or not s/he is suitable for placing in a new home. In the very unfortunate circumstance that the dog is not suitable, I will either keep the dog myself or provide proper veterinary euthanasia. In the rare event that I cannot take back a dog due to current personal circumstances, I will place the dog in AMTC rescue. I, the breeder, will reimburse any and all reasonable expenses incurred on behalf of a dog in this unusual situation to AMTC rescue.

EXHIBITING

I pledge:

1. To serve as an example of good sportsmanship in any aspect of the sport of dogs, assisting and befriending newcomers to the best of my ability.
2. To show only those Manchester Terriers which deserve to be champions in light of the Standard and which are in proper condition.
3. Not to kennel pack for points in conformation or to engage in any other unfair practices in competition.

PENALTIES

I acknowledge and accept for disciplinary purposes a sliding scale of penalties based upon the seriousness of the deviation from this Code of Ethics. The Board of Directors will apply penalties equally to any and all offenders after a proper review of the evidence. Penalties include but are not limited to: reprimand from the Board; temporary suspension from AMTC membership; permanent suspension from AMTC membership; reporting offenders to the AKC; withholding AMTC awards. I have read and I promise to abide by the above Code of Ethics as set forth by the AMTC.
