When I was young, I read Readers' Digest avidly and especially looked forward to "The Most Unforgettable Character I've Ever Met". I wondered if in my life I would ever come across such a person. Today, I am writing about THAT person; Barbara Bryan.

The Manchester Terrier world quietly skipped a beat on March 27th with the loss of a great heart Barbara Bryan. To say she was a passionate Manchester Terrier lover is an understatement. Barbara was a complete fan. She was a lifelong student of the breed, yes BOTH varieties. She and her husband kept a modest home with a big yard as a haven for the Manchester Terrier family. The house was meticulously kept. Except for one room, the dogs had free range, and although Barbara's choice of floor covering was wall to wall white carpet and white tile, the floors were spotless, not even a stray black Manchester hair could be found.

Barbara was worldly, educated, and intelligent. She was a natural blond and would sometimes use the stigma that goes along with that to her advantage, but don't be fooled. Barbara was outgoing and friendly, she loved all dogs but it was

obvious that she was an ambassador of the Manchester Terrier. She had an innate purpose to promote these black and tans. She couldn't bear that these little dogs seemed to not get their due in the World of Dogs where they historically played such an important role somewhat forgotten.

Barbara was strong minded and strong willed. Just like a Manchester Terrier. She had the perfect disposition to keep this breed and everyone thrived. Barbara was unusual, almost purposefully eccentric, dramatic in her way. She chose to smoke cigarettes at the end of a holder, but Barbara was very real, and of course misjudged. In later years she made an overnight decision to stop smoking and she did, just as she had made the overnight decision to stop drinking which was before I came to know her. Barbara knew people continued to talk about that yet she did not let that bother her. She was too interested in enjoying life and enjoying her little dogs.

Barbara owned and selectively bred Manchester Terriers using her last name as a kennel prefix.

Some people would say that Barbara was picky. I say no, Barbara was particular. She dressed impeccably whether she was showing her dogs or watching her dogs be shown. She would sew pockets into beautiful but otherwise impractical suits and of course always wore fash-



ionable but sensible shoes. Barbara was even more particular about her dogs. Only the best would be shown. Every detail was to be tended to, every hair in place. Barbara emphasized the mental and physical condition of her dogs. She made sure I knew and would carry out everything that needed to be done to maintain this over long careers. It annoyed some people that Barbara would let her little dogs react to the presence of big dogs. She firmly believed (and I agree) that these dogs should feel like they have some chance of defending themselves if only for the reality that they may only deter the big dog long enough to be saved by their owner. Barbara was particular and it brought out the show photographers' best game. They know she would not tolerate a shadow behind her dog or obscurity by dark background.

Barbara's prized possession was Ch. Bryan's Up And At It Zitsa. Zitsa was not a fluke. She came out of a well planned and well researched breeding. There was a beautiful brother and two beautiful sisters that made their presence

known earlier and then there was this little eight pounder. Of course we knew that long in the past it was not unusual to see 5 pound dogs at specialties, but at this point Zitsa would be the smallest Toy Manchester Terrier that would be seen in the show ring. She was a mighty mite and wanted to show up her littermates as soon as we would decide to add her to the entry. With a keen expression and big heart Zitsa made her debut at 8 mos of age by winning BOV and Toy Group First. Then Zitsa would take on the world. Her formidable record spanned several years. Each year she came out stronger, each year she wanted to go, each year she ate her dinner every evening, she bathed in the sun, she carried a full coat, and had a full set of big white teeth! And Zitsa's intense stare could make the biggest dog look away.

The details of Zitsa's quality were apparent, including her thumbprints. I remember one time a judge actually rubbed at them and looked up at me. I quietly said, " rub as you may, she got those from her mother and father ". Barbara of course loved that.

Zitsa also enjoyed some time off in the middle of her campaign for motherhood. She produced an extraordinary boy Ch. Bryan's Zip A Dee Doo Dah. Barbara was able to experience a thrill of a lifetime showing Zippy to a Best In Show herself Barbara told me that her only regret was that she didn't start showing the Manchesters at a younger age. Still, she spent decades and made more of an impact in that time and touched more lives, dogs as well as human, than she would take credit for. Thank you for asking me to share this with you.

Dwight Varner 80, of Sterling, Illinois passed away the morning of June 29, 2021

Dwight was preceded in death by his mother Doris Ballard; his children, David Varner and Gweyn Varner, his brothers-inlaw, Glen Wiemken and Dewayn Wiemken.

He is survived by his loving wife Janet; his brothers-in-law, Jim Wiemken (Jan) and Don Wiemken; his cousin Patricia

Pitts of Sterling, and several nieces and nephews.

Dwight and Janet met as high school sweethearts at the age of 17 and married, sharing a very fulfilling life together.

Their 62nd Wedding Anniversary was celebrated this June of 2021.

In their early years, Dwight was drafted into the Army. What Dwight thought would be a tour in Nam changed quickly when he arrived in Germany to find his orders had been changed. He would now be stationed in Germany for a year. Jan stayed behind and worked for G. E.

Dwight's involvement in dogs started when he and Jan acquired their first Irish Setter Field Dog in 1969 that Dwight also attained a Companion Dog title on.



In 1970 they purchased their first conformation dog; Irish Setter "Tyrone Farm O'Shawnesy."

It wasn't until March of 1978 they purchased their first Manchester Terrier from Charlie and Judy Deets. This dog was shown to American and Canadian Champion, AJ's Straja Am., Can., Bda., CD, ROM.

January, 1979 their second Manchester Terrier came into their life and became Am., Can., Ch. AJ's Cheena Am., Can., CD, ROM, HOF.

Members of AMTC since 1979, Dwight served the club well on the Board of Directors and was a member of the Ethics Committee.

So many credits to the Canty prefix, breeding both varieties for decades with well over 70 Champions in the USA and Canada with many Hall of Fame inductees and Register of Merit dogs producing at least 4 Champion offspring to their credit.

Another of their many love affairs included their love of motorcycles. Dwight riding his fully dressed Harley Davidson and Jan by Dwight's side, riding her motorcycle.

If ever there was a truer American Patriot it was Dwight Varner.

Dwight participated twice in the Memorial Day weekend "Ride to Freedom" also known as "Roaring Thunder." A ride to the Vietnam Memorial Wall in Washington D. C.

Each year since May 1988 tens of thousands of motorcyclists from all over the country would make this ride to honor all Veterans who served and remind Americans of the POW and those MIA.

On behalf of the American Manchester Terrier Club; we salute you as we say our final goodbyes, thanking you for your service to our country.


Member Profile

"We bought our first AKC registered dog in 1969 which was a field Irish Setter, which my husband trained to a C.D. We bought our first show dog in April of 1970, a male Irish Setter, Tyronne Farm O'Shawnesy. We bred our first litter in April of 1971.

My first Manchester was AJ's Styraja (aka Star) who became American and Canadian Champion AJ's Straja Am., Can. & Bd (Bermuda) C.D. Rom. I got her in March of 1978. In January of 1979, I got my second Manchester AJ's Cheena so we would have a point when we went to a show. Cheena was my first Hall of Fame Manchester – Am. And Can. Ch. AJ's Cheena A. & Can. C.D. Rom. HOF.


I bred my first litter in August of 1980 of one pup, Am. & Can. C.D. Tartan of Canty A. & Can. C.D. We have bred over seventy (Editor's note - yes that is 7 - 0) Champions. Of the 70, there were 17 Toys and 26 Standards that we owner handled to their Championships.

I only have one Grand Champion, Gch. Canty's Zivan Cu-Tu of Fantasy, as I don't show that much anymore. We live in Northwestern Illinois. I have been in six or so kennel clubs, but am only active in 3 now. I am President and Obedience Chair of the Clinton Iowa Kennel Club. I am Conformation Chair of the Illowa Kennel Club (a UKC Club). I have been a member of the AMTC for thirty six years".

He's old. He has aged that minute right before your eyes. Or so it seems. He is 12 years now, the age at which a slow decline begins for the average Manchester Terrier.

Because all dogs adapt to a fairly consistent routine whether as kennel dogs or house-pets, loss of hearing and dimming eyesight do not pose as immediate difficulties. Dogs can compensate very well if provided a secure environment. An owner may not notice when a dog's hearing begins to fail; at one time or another we have all had to call a dog more than once before it responded.

Pride of the Aged

Regardless of a dog's old-age failings, he/she is

apt to be very clever masking them. Pride and dignity? Of course; even with animals. Getting up in the morning may become quite a chore as arthritis sets in, but he/she is apt to prolong stretching time, getting him/herself together to avoid embarrassment.

What can we do to ease the aging process for that champion which, in his day, gave you so many exciting moments? Or the pet which seldom leaves your side? Proper diet and warmth.

Warm surroundings, especially sleeping quarters, offer the same benefit, to dogs as to arthritic humans. Most Manchesters, if given the opportunity, will cover themselves with a blanket. This is the type warmth the old-timers need, draft-free.

Special Diet

As for diet, the main consideration is to lessen the work of the kidneys and heart. It might seem foolish to put a dog on a kidney diet when no problem seemingly exists, but allaying problems is the answer to a healthier long-lived animal. Although a veterinarian speaking at a seminar commented that older dogs would be better off eating stale doughnuts instead of regular dog food, we would wish better things for our aging dogs. Special prescription diets can be purchased of course, but why not make your own? You will need a 12 oz. box of brown rice. 12 slices of dry bread, a 12 oz. carton of non-fat cottage cheese, and four hard-boiled eggs. Break the bread into bite-sized pieces, add the hard-boiled eggs (chopped into small pieces) and cottage cheese. Before adding the cooked rice, allow to cool to a lukewarm temperature. Mix well. Put the mealsized portions into small plastic bags and place in (Continued on page 22)

your freezer. The above recipe is enough to feed a 10-lb dog twice a day for one week.

Remove from freezer as needed; add a vitamin supplement and calcium. Should you forget to take a package from the freezer in time to thaw before serving, simply place in your toaster oven (*microwave*), low setting, for 15 to 20 minutes (*maybe less in a microwave*). Even when properly thawed, warming slightly is appreciated by the dog. – Ida Mae Jordan



This neighborhood was incredible in helping look for Dolce. People walk in the morning and evening, and one time when I handed a flyer to a couple on a walk, they got a call from some-



MIN PIN COLUMN 1939_12 and 1940_01 AKC GAZETTE

IT is with considerable pleasure that I turn over our column to Miss Hertha von der Kammer, cofounder and a life member of the Miniature Pincher club of America, for her promised history of our breed. As the article is rather long, it has been decided to it in two installments. The Club hopes that you will enjoy the articles, and will thank Miss von der Kammer for her kindness in making her interesting transcript and in giving it to us for publication in the Gazette. And now for the first installment. Here it is:

Our Miniature Pinscher is not the only breed where the true history is veiled in darkness. It is my desire to lift this veil enough to leave little to the imagination as to the ancestry of the Miniature Pinscher. Many similar attempts have been made in the past, but no one has yet been able to ascertain unchallengeable facts. After searching through more than a hundred books in quest of this information, it was found that their history was of such extensive nature that full justice could not be done in the short time allotted. That the Miniature Pinscher is related to both the Doberman and the Manchester needs no confirmation. Both trace their ancestry back to the Manchester terrier, which has imparted to both these descendants many of its main characteristics. While the Doberman Pinscher was not known as such before 1865, which fact is well proven, the Miniature Pinscher was well established around 1850.

The Doberman Pinscher was named in honor of a Herr Dobermann, who lived in Germany from 1834 to 1894. With a friend, Herr Stegmann, they chose the most powerful shepherd dogs and crus* bred those with types they thought best suitable for this purpose. Exactly how many different breeds were used to develop the Doberman cannot be definitely stated, but the German Shepherd and the Rottweiler were included.

A Herr Goller bred this combination to the Manchester terrier of England, and the first so-called black-and-tan Doberman was evolved in 1865. In 1899, the Doberman Pinscher Club was founded in Apolda, Germany; and since then the Doberman, as an established breed, has made rapid progress, both in Germany and the United States.

So far, the relationship of the Doberman to the Manchester terrier is concluded and I am now leading to the fact where the Manchester terrier played its part in the evolution of the Miniature Pinscher.

E. C. Ash, in his "Dogs and Their History," mentions that perhaps the earliest recognizable blackand-tan terrier appears in the "Hours of the Virgin," an illuminated manuscript of about 1500. Between 1600 and 1700 such terriers were occasionally mentioned, and we have descriptions, the most interesting perhaps, that some of these terriers were long legged and some had short and crooked legs and that the crooked legged ones were smooth coated and the straight and long legged terriers had coats of shaggy hair. The black -and-tans were known, later, as the English Terrier.

As time went on, little public interest centered on the various crosses. In this making of new breeds, the black-and-tan terriers were often entirely replaced by the new types, but 'here and there the old world terrier continued its life. In 1800, the black-and-tan terriers were divided into the old types, yet bred in purity, and various black-and-tan terriers descended from the crosses in the making of new breeds. Many of these dogs were most attractive and their often delightful appearance caused them to be kept and much admired.

Around 1800, we find the black-and-tan terrier a well built, smooth coated dog, not the old type of black-and-tans, but a good fox terrier except in color. Among such bred dogs, not infrequently a litter of smooth haired, white puppies were found, and in the next forty years we have more than one allusion to the "white black-and-tans."

It was in 1819 that "Billy" appeared. When this hero of black-and-tan history won a rat-killing match against a bitch, the property of a Quaker named Bowring, it was the first we hear of him. In 1821, on May 13, the owner of the rat-pit wagered a silver dollar that the dog would not kill 100 rats in 12 min. — The challenge was accepted. He killed five score rats supplied to him in one minute less than the stated time. In 1825, on July 7, the rat-pit was crowded. Boxes had the special price of five shillings each, and the pit was sold at three shillings a seat. The dog, then weighing 27 pounds, killed 100 rats at the rate of one rat in four seconds. Show bills later inform us that a young red bitch, "got by Billy" would be exhibited. He is portrayed in a color print of 1827 as a white terrier with dark patches on the face and on the side of the head. He has no appearance of a Manchester Terrier at all, but of a useful working fox terrier.

By the year 1849, interest centered in a smaller

dog, and dogs below seven pounds in weight were in great demand and would sell at remunerative prices for as much as five or ten guineas each. The breed, indeed, had divided in two kinds. There were the lightweight dogs, the forerunner of the present-day toy; and larger dogs.

In 1771, Whitacker in his history of the "Manchester" had described "their little terriers," a breed with crooked legs and shaggy hair. But if it was the same breed it had changed for now, in the year 1859, Stonehenge describes the Manchester Terrier to be smooth haired with long tapering noses, narrow flat skull, eyes small and bright, chest rather deep than wide.

The color was now important. Blackand-tans the "only true color," writes Stonehenge; adding "but many are white, slightly marked with black, and also sometimes but very rarely, blue."

Eight years later, once more Mr. Walsh dealt with the breed. We still find white mentioned. "White or black-and-tans are the best colors for all terriers." By 1878, no other color but black-and-tan or red was allowed, and the least speck of white "was fatal in the show-ring."

Around 1878, a black-and-tan would be weighing anything from six to 20 pounds and some wellknown dogs weighed as much as 24 pounds. At this time, once more the breed was altered and crossed with small greyhounds. This crossing had its disadvantages for many dogs had terrier bodies and greyhound heads. The breed spread from Manchester all over the country, now, more than ever, a fancier's dog. Then, once more, the type altered. The black-and-tans, however, retained much of the quality of the Italian greyhound, and

is a very beautiful little dog indeed. The plain black-and-tan lost ground, and only a few bred and kept them. The toy retained gracefulness, so important in a dog to be owned by ladies of fashion. The weight of the toy was constantly reduced. From 10 pound dogs, a time came when many were seven and eight pounds. "Still smaller dogs were bred until they varied from four to five pounds," (Ash). The head of the dog illustrated by Mr. Ash resembles the elongated head of the miniature pinscher of today's standard. It also bears the same style of ear crop as used in the present day, wherever it is legal. An illustration in 1859 of Lady, a bitch stated to have been bred by Frank Redmond's Tarter out of Vic, a Manchester-bred bitch, formerly the property of the Hon. Egremont Lascelles, is symbolical of the Miniature Pinscher of today. That is all that I can carry of Miss von der Rammer's interesting article. In next month's Gazette I will finish it

YOU may remember that in the last issue of the old year, I turned over our column to Miss Hertha von der Kammer, co-founder and life member of our club, so that she might publish the history that she had written on the Miniature Pinscher. As the history was too long for one issue of the Gazette, Miss von der Kammer divided it into two parts, and this month I have the pleasure of giving our readers the second installment of the story. Here it is:

In the history of the Manchester Terrier that was published in last month's Gazette we have a well established record for this breed, and it is my opinion that both the Dobermann Pinscher and the Miniature Pinscher are descendants of the Manchester Terrier, but the Miniature Pinscher is a refinement of the Manchester Terrier prior to 1878 whereas the Dobermann Pinscher is a cross between that of the original Manchester Terrier prior to that time and the Rottweiler and the German Shepherd, and the similarity of the Miniature Pinscher —as we know it today—to the Dobermann Pinscher can be very easily recognized.

However, it seems that our breed is more like the Manchester Terrier prior to 1878, at which time, according to Mr. Ash, "then once more the breed altered" and the black-and-tans retained much of the quality of the Italian Greyhound while the plain black-and-tan lost ground and, incidentally, it was through my grand-parents, who were dog fanciers at that time in Germany, that the first information as to the history of the Miniature Pinscher was learned.

According to them, for about 20 years prior to the year 1870, there existed two types, the larger called Rehpinscher of about 20 pounds and the Zwergreh Pinscher up to 5 pounds. Zwerg-Reh-Pinscher in English means dwarf-deer terrier. Both kinds were being used extensively for exterminating rats and mice.

In 1895, the Pinscher-Schnazerklub, which was founded in Germany, sponsored the development of the breed, and gave to the fancy its first standard. In 1902, the International Zivcrhundklub (Schosshundklub) was founded in Germany. Miniature, or toy dogs, were then regarded as only being a "permitted stepchild." Men would not have anything to do with a dwarf or miniature of any breed. They were only regarded as lady's pets. Herr Woerz in his book "Der Luxushund" in 1909 refers to the Miniature Pinscher as the "Glatthaariger Deutscher Zwergpinscher"—in English : Smooth-haired German-Pinscher—40 to 50 cm. in height at the shoulder and maximum in weight 20 pounds, and the Glatthaariger Deutscher Zwerg pinscher"—no height given weight from 2-5 pounds.

These Zwerg—or dwarf pinscher— were of an extraordinary diminutiveness, rickety in body and with the typical apple-head often resulting in a cleft palate and incomplete closing of the sutures of the skull and submerging all the typical terrier type features of the original Miniature Pinscher.

At the shows, these incomplete creatures were shown resting on cushions and wrapped up in flannels. They did not secure much recognition. However, since about 1925 this type was abolished, and a more sturdy type of Miniature Pinscher came in vogue.

Since then, the breed has had little change and the weight has remained about the same, from 5-10 pounds. However, the smaller the miniatures are, the greater their value, as long as they remain normal and healthy.

While there are opinions that aiming to produce as small a specimen as possible has been detrimental to the breed, my personal experience has been that the smaller type, about 4-8 pounds, is the more desired pinscher, and if scientifically bred the sturdiness of the breed will not be lost. I have produced many 4-6 pound dogs which were as perfect and sound as the larger type, not having lost any of the specifications of the standard. The miniature pinscher when intelligently bred are easy whelpers.

Despite the fact that toy breeds in general have not received the recognition one might desire, I venture the opinion that our little breed will remain ever popular and kept increasing every year.

From the meager data obtainable it is my opinion that the Miniature Pinscher of today is more of the roughed type descendant of the Manchester Terrier without the influence of the Italian Greyhound ; while the Toy Manchester Terrier, as we have him today, is more of the racy type. Therefore, we might refer to the Toy Manchester Terrier as the English and to the Miniature Pinscher as the German descendant of the Manchester Terrier, for Miniature Pinschers are not bred in England, but they have made good progress in the United States and in the Scandinavian countries. At some future time, when more information can be gathered on the subject, I again will report my finding and refer especially to the color of the Miniature Pinscher which is in much greater variety than that of the Manchester Terrier or the Doberman Pinscher. All who have read this series by Miss von der Kammer undoubtedly will look forward with interest to anything that she might write on the color of our dogs.

HOW MANY TIMES have you walked down the street with your newest champion-in-the-making on a leash, or sat in a show building and had some interested bystander ask: "Is that a Chihuahua?"

If the current prospect be black and tan, the question is usually varied by the query "Is that a Toy Black and Tan?" The first inclination I have, no matter how many times this occurs, is to answer

sharply "NO." However, I realize that there is a similarity in the breeds, while the origin of all three is definitely obscured by time.

Some of us believe that the Chihuahua, a native American, was brought over with the conquerors of the Incas; so if this were true we could safely say that probably all three stem from the same English Terrier. The definite breeds we have today developed through the infusion of different blood. My better judgment and common sense tells me that I should prepare an answer for these questions, so that my explanation will leave the person better informed not only about our own breed, but also about the others that are so often confused with ours.

I became so interested while making this comparison that I thought perhaps others would be benefited by this too. a) Miniature Pinscher; b) Chihuahua; c) Toy Manchester Terrier.

Color: a) Six allowable colors or color combinations; b) Any color; c) One color only.

Weight: a) 6-10 pounds; b) 1-6 pounds; c) Limit 12 definite contour. pounds.

Ears: a) Set high, trimmed, upstanding; b) Upstanding, held at 45° angle when in repose; c) Well up on skull, held close together, thin.

Eyes: a) Full, set wide apart, fitted well into the sockets; b) Full, set wide apart; c) Set close together, oblong, slanting upwards.

Skull: a) Appears fiat; b) Well rounded; c) Almost flat.

Muzzle: a) Tapering, strong; b) Moderately short, slightly pointed; c) Tapering, well filled under eyes. Body: a) Wedge shaped, square, h-1; b) Longer than high; c) Moderately short.

Chest: a) Full; b) Full; c) Narrow.

Back: a) Level; b) Level; c) Sloping at the loin.

Tail: a) Broad, cropped 1-2 inches in length, held erect; b) Long, carried cycle either up or out; c) Short, tapering, set on end of arch in back, level with shoulders.

What characteristics can we stress that set the breeds apart, which when once called to our attention will make a lasting impression?

Eyes—Carefully recheck those descriptions. Did you know that all dogs' eyes were shaped the same; that the kind of eyelids, and the set of the eyes in the skull are the factors that bring about the difference in eye appeal?

The set of the shoulders and the set of the tail are characteristics in which all three vary, yet each plays an important part in the general appearance of the breed.

Topline—The Toy Manchester Terrier has a very definite contour.

I hope these comparisons will prove of value, and not appear too bookish or stuffy. I assure you that my information comes from acquaintance as well as study; for I own a Toy Manchester Terrier champion whose wins make her rate with the best. I count as my friends Attas' Chipola and Hound Shello. Need I say more? No, except that good dogs like great men do not have their place of birth restricted to one locality. Check the records.—Mrs. D. E. VanBuskirk, Secretary, Box 122, Bellaire, Tex



Manchesters of both varieties to our pack going forward.




Doberman Fun Facts

- The Manchester Terrier is often said to resemble the Dobermann in miniature, however the truth is, it is the other way round. The Dobermanns creator, Herr Louis Dobermann, used Manchester Terriers to create his breed.
- After Dobermann's death, attention began to be paid to the breed's appearance as much as its working ability. Around the turn of the 20th Century, crosses were made to two English breeds – the black-and-tan Manchester Terrier and the Greyhound – giving the breed some of its streamlined fluidity.
- The Doberman Pinscher Club of America was founded in 1921 by Gov. George Earle III, who was also a breeder and member and President of the Manchester Terrier Club of America, a founding member of the American Toy Manchester Terrier Club and American Manchester Terrier Club of America. His Kennel Name was Red Roof Kennels.
- AMTC member Pamela DeHetre (Pamelot) was also a past president of the Doberman Pinscher Club of America and is credited with the idea and gaining approval to get the Dobequest Pedigree database developed and running. Circa 2003.



The Dobermann Pinscher is a combination of several breeds including the Beauceron, German Pinscher, Rottweiler and Weimaraner. The single exception is the documented crossing with the Greyhound and Manchester Terrier. It is also widely believed that the old German Shepherd was the single largest contributor to the Dobermann breed. Philip Greunig's *The Dobermann Pinscher* (1939) describes the breed's early development by Otto Goeller, who helped to establish the breed. The American Kennel Club believes the breeds utilized to develop the Dobermann Pinscher may have included the old shorthaired shepherd, Rottweiler, Black and Tan Terrier and the German Pinscher.

German Pinscher Fun Facts

- German Pinscher Following both World Wars, the breed was nearly lost. There were no litters registered in West Germany from 1949 to 1958. Werner Jung is credited with singlehandedly saving the breed from extinction by smuggling a black and red bitch out of East Germany and breeding her with four oversized Miniature Pinscher males and one Miniature Pinscher Female to reestablish the breed. Most if not all German Pinschers today are descendants of these dogs.
- The German Pinscher originated in southern Germany and was first entered into German records in 1885 as a smooth coated Pinscher. The Pinscher was one of the foundation breeds in the origins of the Doberman Pinscher and the Miniature Pinscher. The Wire-Haired Pinscher and Smooth-Haired Pinscher were originally one breed with two coat varieties. The breeds were officially divided in the early 1900's with the wire hair pinscher being renamed the "Schnauzer" while the smooth haired variety remained the "Pinscher". These medium-sized dogs were bred from early European herding and guardian breeds and were not related to the terrier breeds developed in Britain.
- In the late 1970's and early 1980's, German Pinschers began to be imported into the United States and bred in small numbers. Early US breeders imported from Germany, England, Sweden, France, Finland and Czechoslovakia. The German Pinscher population has been growing slowly but steadily in the United States since the breed was accepted into the American Kennel Club in 2003.
- The sleek, no-frills German Pinscher is among Germany's oldest breeds and the prototype of other pinscher breeds. This energetic, super-intelligent dog was at first used as a rat catcher but can be trained for all types of canine work.
- I'm bigger than a Min Pin and smaller then a Doberman, so stop asking which one I am. In

fact, I'm more closely related to the Standard Schnauzer than either of those breeds.

- No, I'm not a Doberman Pinscher or a Miniature Pinscher (Min Pin), I am my own breed! And an old one, at that. In fact, as a German Pinscher, I'm part of the origins of several newer breeds, like the Affenpinscher, all schnauzers and, of course, the Doberman Pinscher and Miniature Pinscher.
- Pinschers were used as guardians for coaches. They also lived in homesteads where they were used to kill vermin, a job they did by instinct, as such behavior did not need to be trained into the breed. Even today you can observe German Pinschers searching for and finding rats in open areas and in homes.




- Other names: Toy Manchester Terriers were commonly referred to as Rat Terriers.
- People who own a Manchester Terrier may be asked if it's a Miniature Dobermann. It's an easy mistake to make at first glance, as this unusual little Terrier does somewhat resemble the Dobermann breed, but that's where the similarities end.
- Manchester Terriers are said to be the descendants of the old English Black-and-Tan Terrier. Unlike most Terrier breeds, the Manchester is a city dog. Shipping docks around Liverpool and Manchester were alive with rats due to poor sanitation in the 1800s, so there was plenty of work for this quick-witted and nimble Terrier.
- When the Kennel Club opened its stud books in 1873, the Manchester Terrier was still known as the English Black-and-Tan Terrier. At the time, the distinguished dog judge and writer Hugh Dalziel described the Manchester as the most elegant and graceful of all

Terriers.

 Mrs. Margret Bagshaw (Canyon Crest) knew
 AKC Judge William Kendrick (Queensbury
 Kennel) and was introduced to the Manchester Terrier by Mr. Kendrick. Some of their
 foundation stock came from the Queensbury

Kennel
Mrs. Margaret Bagshaw was a Judge of Great Danes, Miniature Pinschers, and Standard and Toy Manchester Terriers in 1946.



Miniature Pinscher Fun Facts

- Mr. and Mrs. William Bagshaw who owned Canyon Crest Kennels were breeders of both Miniature Pinschers and Manchester Terriers.
- In 1941 Ch. King Eric v. Konigsbach made history as Westminster's first Miniature Pinscher group winner, there owners were the Mr. and Mrs. Bagshaw of Canyon Crest Kennels
- In 1953 Janet Mack reported in the AKC gazette that a new club had been formed called "Eastern Toy Manchester and Miniature Pinscher Club," The main purpose of the club is to promote show activities.
- In 1954 Mrs. Margaret Bagshaw was elected as a Director to the Miniature Pinscher Club of California
- Mrs. Margaret R. Bagshaw of Canyon Crest was the Author of Pet Miniature Pinscher, part of the same series of books as Pet Manchester written by Janet Mack.
- Pamela Dehetre was a handler, beeder and judge of Manchesters, Miniature Pinschers and Doberman Pinschers. She wrote a guest column for the MPCA in the 2003_09 AKC Gazette on her judging perspective from judging at their national in 2003. As a handler she has handled Min Pins since the late 60's.
- The Min Pin when introduced was placed in

the Misc. category, then moved to the Terrier Group and then moved to the Toy Group a year later.

Why is it called a "Pinscher"

Some confusion surrounds the origins of the name "Pinscher" The extract translation from German is "to pinsch," and this is followed by the same interpretation. If you understand that terrier –or "ratter," which the Pinscher was in his barn days—kills its prey by pinching the spinal cord at the back of the neck, the meaning of this term becomes clearer. This is done very swiftly, and the neck is broken. Most terriers breeds are required to have complete incisors in their dentition because those teeth are used to "pinch" and kill their pry. - Jackie Hungerland, Miniature Pinscher: Reigning King of Toys



by Raymond H. Oppenheimer For many years Raymond H. Oppenheimer was a breed columnist in the English 9. Don't allow personal feelings to influence your Dog World newspaper. His books McGiffin and Co and After Bar Sinister are breed classics. (as published in the Pinscher Patter, Sept 2004)

There are a vast number of different breeding methods, some good, some bad. I should never presume to try to tell fanciers what is the right method because there is no such thing. Outstanding success can be achieved and has been achieved in a variety of different ways, so all I am going to do is to make some suggestions which I think helpful and to warn against certain pitfalls which trap too many of the unwary.

- 1. Don't make use of indiscriminate outcrosses. A judicious outcross can be of great value, an injudicious one can produce an aggregation of every imaginable fault in the breed.
- 2. Don't line breed just for the sake of line breeding. Line breeding with complementary types can bring great rewards; with unsuitable ones it will lead to immediate disaster.
- 3. Don't take advice from people who have always been unsuccessful breeders. If their opinions were worth having they would have proved it by their success.
- 4. Don't believe the popular cliché about the brother or sister of the great champion being just as good to breed from. For every one that is, hundreds are not. It depends on the animal concerned.
- 5. Don't credit your own dogs with virtues they don't possess. Self-deceit is a stepping-stone to failure.
- 6. Don't breed from mediocrities; the absence of a fault does not in any way signify the presence of its corresponding virtue
- 7. Don't try to line breed two dogs at the same time; you will end by line breeding to neither.
- 8. Don't assess the worth of a stud dog by his inferior progeny. All stud dogs sire rubbish at times; what matters are how good their best

efforts are.

- choice of a stud dog. The right dog for your bitch is the right dog whoever owns it.
- 10. Don't allow admiration of a stud dog to blind you to his faults. If you do you will soon be the victim of autointoxication.
- 11. Don't mate together animals which share the same faults. You are asking for trouble if you do.
- 12. Don't forget that it is the whole dog that counts. If you forget one virtue while searching for another you pay for it.
- 13. Don't search for the perfect dog as a mate for your bitch. The perfect dog (or bitch) doesn't exist, never has or never will!
- 14. Don't be frightened of breeding from animal that have obvious faults so long as they have compensating virtues. A lack of virtue is far the greatest fault of all.
- 15. Don't mate together non-complementary types. An ability to recognize type at a glance is a breeder's greatest gift; ask the successful breeders to explain this subject - there is no other way of learning. (I would define noncomplementary types as ones which have the same faults and lack the same virtues.)
- 16. Don't forget the necessity to preserve head quality. It will vanish like a dream if you do.
- 17. Don't forget that substance plus quality should be one of your aims. Any fool can breed one without the other!
- 18. Don't forget that a great head plus soundness should be one of your aims. Many people can never breed either!
- 19. 19. Don't ever try to decry a great Bull terrier. A thing of beauty is not only a joy forever but also a great pride and pleasure to all true lovers of the breed.
- 20. Don't be satisfied with anything but the best. The second best is never good enough



Whenever one reads about the origin of the Dobermann one finds that several breeds took part in the "creation" of our distinguished breed. I myself was struck by the resemblance in appearance of the Manchester Terrier and the Dobermann. I decided to find out about this breed and its influence on our breed.

Phillip Gruening in his book The Dobermann Pinscher" mentioned names of two Dobermanns that carried Manchester blood "Prinz v Ilm-Athen and Fedor v Aharth". William Sidney Schmidt in his book "The Dobermann Pinscher" also mentioned names of Dobermanns that carried Manchester Blood "Sieger Sturmfried v Ilm-Athen (one on Prinz's most notable sons), and Tell v Kirchwazke.

Prinz's dam, Lady v Ilm-Athen was part Manchester Terrier. Prinz became one of the great sires of the breed, almost all of progeny being black with clear dark markings, and in the field of colour his dominance was profound.

According to Goeller (one of the first Dobermann breeders) the Manchester Terrier was no brought to Thuringia before 1890, at which time the new breed was introduced. However it is a positively proven fact that at a later date the blood of the Manchester Terrier was used.

According to Gruening, at the turn of the century we recorded cross breeding with the Manchester Terrier six years later with the Greyhound and again with the Manchester.

Let us check carefully the origin and character of the Manchester Terrier. Generations ago, even before the days of the shows there was in England, Black and Tan Terriers not as elegant as the today dog, but course in type and with smutty tan markings. These dogs were used for killing rats, a popular sport in those days.

It is difficult to trace back to the origin of the Black and Tan Terrier but it is believed that the Whippet, Greyhound and Italian Greyhound were involved in the creation of this breed. At first this breed was known as the Black and Tan Terrier and in 1923 when the club was formed the name was changed to Manchester Terrier.

The Manchester Terrier is a very alert dog, aloof, very quick, fearless and sometime stubborn. He can run very fast and has the ability to change direction almost like "turning on a sixpence" when in full chase. It is obvious that this breed contributed to its alertness, its fast movement and its ability to turn on the spot while chasing, furthermore its guick teeth (the Manchester used to kill rats by grabbing their shoulders with his teeth and breaking their backs with a sudden upward toss). The blood of the Greyhound breed developed the high speed in the Dobermann. Furthermore, it is believed that this breed was used in order to improve the coat and colour of the Dobermann. The Early Dobermann had a thick, wooly undercoat which disappeared thanks to the cross breeding with the Manchester Terrier.

Judge in many years. I am so happy and excited for Carolyn!

AKC Canine College Course is up and running again! We have worked with AKC Canine College for a variety of things over the years. Presently we are working with the Multimedia Manager towards an Illustrated Breed Standard for AKC Judges Education.

December brings us back to Orlando, Florida for the Herding and Toy Breed Seminars sponsored by AKC/DJAA Advanced Judges Institute.

Michelle Barlak will be presenting our Manchester Terrier Seminar. This will be our first presentation with our newly revised Breed Standard in place, effective October 6, 2021.

As always, we will need ringside mentors and dogs for the hands on portion of the seminar. If you can do either or both please let Michelle or me know at your earliest convenience.

With the Delta variant running rampant in the United States presently, I don't know what restrictions or precautions will be in effect. I will be sure to make an announcement when I have further information.

Scales have certainly been a big controversy.

A brief recap going back to November, 2019 when Tim Thomas first made contact with me about the scales.

Tim Thomas, VP of Dog Show Judges has been in contact with me regarding scales.

We discussed the issue of the scale not being produced by the Superintendent when requested by a judge National week in Boise.

Tim is going to follow up with the events department to ensure it was properly addressed with the Superintendent.

Now is our opportunity to speak up.

Rod Herner had put me in touch with Cindy Stansell, AKC Judge and Breeder of Frenchies, another weighed breed.

We advocated together.

Here we are now, finally, up to date on the Guidelines for APPROVED Scales at AKC CONFOR-MATION DOG SHOWS. Effective January 2022.

AKC Conformation Judges Updates AA

applications <u>received after September</u> **30, 2021** must comply with the standard criteria of the *Judging Approval Process*.

• The Board at its April 2021 meeting reviewed enhanced Guidelines for approved scales at AKC conformation events drafted by AKC Staff. The purpose of the revised guidelines for scales is to instill greater confidence in the equipment used to determine eligibility associated with weight for both the judge and exhibitor. A highlight of the revised scale guidelines is the establishment of minimum platform sizes. All-breed dog shows and any conformation event where Dachshunds, Standard Manchester Terriers or French Bulldogs may compete will be required to have a scale whose platform is a minimum of 160 sq. inches in area (i.e. 16" x 10") and conformation events limited to Toy breeds will be required to have a scale whose platform is a minimum of 108 sq. inches in area (i.e. 12" x 9").

The **Guidelines for Approved Scales at AKC Conformation Dog Shows** has been sent to all licensed superintendents and included in the Events Department communications to licensed and member clubs with a compliance date of January 1, 2022. It will also be posted on the AKC website and included in the next revision of the *AKC Show Manual*.

Also, to bring you up to date on VERBAL PROTESTS which are THE RULES FOR AKC CONFORMATION JUDGES effective July 14, 2021 JUDGES have been updated as follows: (See insert to the right—>)

Effective July 14, 2021

This insert is issued as a supplement to *Rules Policies* and *Guidelines for Conformation Dog Show Judges* amended to October 2019 and approved by the AKC Board July 13, 2021.

Replace the existing section on **Verbal Protests** (page 26) with the following:

[R] Verbal Protests Any person who is handling a competing dog in the ring in any conformation competition may then verbally protest to the judge before every dog in the class has been individually examined and individually gaited. (Chapter 15, Section 2, *Rules*)

Protests may be made alleging a dog being shown in the competition has a condition which makes it ineligible to compete (Chapter 11, Section 8, or Chapter 11, Section 8-C, *Rules*), a condition requiring disqualification under the standard for the breed or excusal for condition of class. (Chapter 14, Sections 3, 4, 6 or 6A *Rules*)

When a verbal protest is made, examine the dog <u>protested</u>. If, in your opinion the dog does not possess the disqualifying fault <u>or is compliant with the condition of</u> <u>class protested</u>, advise the exhibitor who made the protest and mark your judge's book, "Verbal protest, (stating the reason for protest), not sustained." If the dog has the disqualifying condition <u>or does not meet the conditions of</u> <u>class</u>, disqualify or excuse the dog as applicable and mark your book "Verbal protest, (stating the reason for the protest), disqualified (or excused)." Protests regarding conditions of class are to be marked "Verbal protest, (reason for protest), not sustained" or "Verbal protest, (reason for protest), excused."







What is the AKC Temperament Test?

(from the AKC website)

The AKC Temperament Test (ATT) was developed to bring focus and provide a meaningful evaluation to assess the temperament of our canine companions.

The ATT tests how a dog reacts to a variety of stimuli. Desirable traits are that the dog will be emotionally stable, inquisitive, cooperative, appropriately social for its breed, biddable and demonstrates the ability to recover from a startling situation in a reasonable amount of time.

Undesirable traits are fear, shyness, lack of cooperation and an inability to recover from unfamiliar or unexpected situations. Examples of undesirable behaviors include being afraid of friendly strangers or unfamiliar stimuli, obsessive barking, and aggression.

In the ATT, dogs are tested in 6 categories of stimuli that include:

- 1. Social
- 2. Auditory
- 3. Visual
- 4. Tactile
- 5. Proprioceptive (motion)
- 6. Unexpected stimulus

Earn an ATT Title:

If a dog passes the ATT on two occasions, under two different evaluators, the owner may apply for the AKC Temperament Test (ATT) suffix title. The ATT Title Application along with the passing Evaluator Score Sheets from two different tests and the required title application fee must be submitted to AKC. Upon verification, the ATT title will be applied to the dog's record and will appear on the dog's AKC title record. The title certificate will be mailed to the dog's primary owner of record. All dogs entered in tests should already have either an AKC or FSS registration number or a Canine Partners Listing number or Purebred Alternative Listing Number.

Hosting and Event:

Any licensed AKC club can apply to host an AKC Temperament Test. An approved AKC ATT Evaluator will need to be assigned. Clubs can host 2 tests in one day and there is no mileage or distance conflicts. ATTs can be held in conjunction with other AKC events or as a stand alone event.

The Manchester Terrier's Temperament is (Summary): Keenly observant, devoted, but discerning. generally friendly with other dogs. Not aggressive or shy.



How the PPCP Program Works

- Members of Purina Pro Club must declare participation in the Purina Parent Club Partnership (PPCP) program and designate their national parent club. The parent club also must be enrolled in the PPCP program.

American Manchester Terrier Club Code of Ethics

Membership in the American Manchester Terrier Club (AMTC) is a privilege. In return for acceptance into the AMTC, I promise to abide by the following Code of Ethics and to submit to the enforcement of this Code by the AMTC Board of Directors.

GENERAL

I pledge as an owner of Manchester Terriers to be responsible for the dogs in my care. My responsibilities include providing proper shelter which is clean, dry and warm; appropriate veterinary care and inoculations; emergency veterinary care when needed; quality food and water; adherence to local and state animal control and licensing laws.

BREEDING

I pledge:

1. To accept and uphold the Standard of the Manchester Terrier as developed by the AMTC and approved by the AKC.

2. To breed only physically and mentally sound Manchester Terriers in order to maintain or improve the qualities of the

breed as set forth in the Standard. I will not participate in the indiscriminate breeding of studs or bitches with no regard to quality.

To screen or obtain proof of screening of breeding stock for communicable diseases, hereditary faults or defects, either active or dormant. Questionable animals will not be used in my breeding program.

To forego breeding unless financially capable and willing to responsibly and caringly maintain whelped puppies until placed in their new homes.

5. To maintain complete and accurate breeding records in accordance with AKC regulations.

SELLING

I pledge:

1. To in no way misrepresent any Manchester Terrier for sale.

2. To provide all buyers with:

A. AKC individual registration application or certificate properly filled out by seller.

B. Minimum three-generation pedigree.

C. Record of inoculations, worming, etc.

D. Provide instructions for feeding and care.

E. Be available for guidance and questions.

3. Not to sell, give, trade, abandon or in any manner transfer litters or individual Manchester Terriers to pet dealers, pet wholesalers, auctions, laboratories, raffles, pet stores, puppy mills, animal shelters, or any source for resale. I will not knowingly transfer ownership or provide stud service to anyone who intends to breed Manchester Terriers for any of the above listed purposes.

4. To take back any Manchester Terrier I bred if the current owner of the dog can no longer keep him or her. I will evaluate the dog as to whether or not s/he is suitable for placing in a new home. In the very unfortunate circumstance that the dog is not suitable, I will either keep the dog myself or provide proper veterinary euthanasia. In the rare event that I cannot take back a dog due to current personal circumstances, I will place the dog in AMTC rescue. I, the breeder, will reimburse any and all reasonable expenses incurred on behalf of a dog in this unusual situation to AMTC rescue.

EXHIBITING

I pledge:

1. To serve as an example of good sportsmanship in any aspect of the sport of dogs, assisting and befriending newcomers to the best of my ability.

2. To show only those Manchester Terriers which deserve to be champions in light of the Standard and which are in proper condition.

3. Not to kennel pack for points in conformation or to engage in any other unfair practices in competition.

PENALTIES

I acknowledge and accept for disciplinary purposes a sliding scale of penalties based upon the seriousness of the deviation from this Code of Ethics. The Board of Directors will apply penalties equally to any and all offenders after a proper review of the evidence. Penalties include but are not limited to: reprimand from the Board; temporary suspension from AMTC membership; permanent suspension from AMTC membership; reporting offenders to the AKC; withholding AMTC awards. I have read and I promise to abide by the above Code of Ethics as set forth by the AMTC.
