Board Meeting Minutes**October 2021 – No Board Meeting Held****AMTC Teleconference Board Meeting Minutes**

November 10, 2021

(Postponed from October 27, 2021 Regular Meeting)

The teleconference board meeting was brought to order at 7:42 p.m. Central Standard Time by President, Susan Thrasher.

*Roll Call: Pres. Susan Thrasher, 2st VP, Roberta Berman; Secretary, Kathy Nissen; Board members: Annette Bujold, Jean Good and Ellen Murtagh. Absent: 1st VP, Christina Caridis; Treas. Dianna Texter; Board member: Patrick Mackesey. A majority of the voting board (quorum) was in attendance to conduct the meeting.

***President's Report:** Nothing new to report

***Secretary's Report:** Kathy Nissen noted she received Judges Selection Proposals from Beverly Vics and informed the board Sue Webb would like to rejoin the AMTC. An application was sent to her.

*No other reports were given.

Old Business:

***Updates for 2022 and 2023 AMTC National events** – nothing new to report.

***Breeder Education** – nothing new to report.

***Ethics Committee's Purpose:** tabled at this time.

***Good Dogs Parent Club Grant:** Secretary, Kathy Nissen, informed the board we have been awarded an \$800.00 grant. It is hoped these funds can be split up and utilized for health studies, breeder education and judges' education materials.

***November newsletter board approved revisions to submitted draft** – to date, the board has not received acknowledgement of receipt of acceptance of these revisions.

***Sunshine Cards** – it was agreed that each district's Sunshine representative inform either Secretary, Kathy Nissen or Sunshine Chair, Rachel Jonas, of any members that need cards need sent to on behalf of the club. Also, each district's Sunshine representative is welcome to send cards to those in their respective districts, as well.

***Hall of Fame Report** – Roberta Berman, Jean Good and Annette Bujold are working diligently on revising the point schedule and requirements for attaining HOF titles.

New Business:

***District 1 Governor Vacancy** – Beverly Leidner has offered to fill the vacancy for District 1. Motion to approve made by Ellen Murtagh, 2nd by Kathy Nissen. All in favor, motion carried.

***Possible Standing Rules, Guidelines, Policies & Procedures Revision** – While newsletter editor, Sam Hessel, is doing a wonderful job with our club's newsletter, it has increased dramatically in size and expense. Christina Caridis proposed future newsletters be no more than 30 pages with the layout being organized to maximize space on each page. Expenses for printing and mailing hard copy to those subscribing yearly exceed the cost of the \$15.00 yearly subscription fee. While the newsletter is available on our website, not all members are online, thus the continuation of hard copy availability. It was decided the newsletter needs to be directed more toward our breed, as a whole, with breed related information and articles. Should an issue of the newsletter lack information in submitted reports, breed related information, etc., other articles may then be considered. Therefore, it was agreed by the board to recommend a revision to the Standing Rules, Guidelines, Policies and Procedures to utilize the minimum number of pages necessary for all issues with the exception of the issue directly following and spotlighting the AMTC National event. Language to be drafted prior to the 2022 Annual Meeting for member review, discussion and approval.

***AKC Market Place Breed Information** – it was brought to the board's attention the language describing our breed needs to be revised. Utilizing the word "revolting" in reference to the long ago pastime of rat killing is not a positive reflection for

our breed. Secretary, Kathy Nissen, will contact Jo Ann Emrick and ask if she would be willing to rewrite the information describing the Manchester Terrier on AKC Market Place and submit to the appropriate department at the AKC.

***Hall of Fame Face Book Project** – Jo Ann Emrick sent the board a proposal asking to start a “Hall of Fame Face Book Group” similar to the “Manchester Terrier Archives Group”. There would be photos and pedigrees of HOF dogs that could either be uploaded by the dogs’ owners or by Jo Ann. In the ‘comment’ area, only the name of the dog(s), its accomplishments and those persons in the photo identified, would be allowed. This would be an ongoing process as . any new dogs achieving HOF status will be uploaded to the group. Yearly statistics would be provided by Roberta Berman, HOF Chairperson. The board agreed this would be a very beneficial project for the club and breed.

***Regular November and December 2021 Board Meetings** – Due to Thanksgiving and Christmas, Hanukah holidays taking place on or close to the board’s regular meeting nights, it was decided to postpone our next regular meeting until January 26, 2022. Should any club related matters be brought to the board’s attention, they will be discussed via email correspondence.

No further business – motion to adjourn made by Roberta Berman, 2nd by Annette Bujold. All in favor, meeting adjourned at 8:29 p.m. Central Standard time.

Special AMTC Teleconference Board Meeting Minutes

January 5, 2022

Due to his unwillingness to comply with several Board requests regarding further revisions/corrections/refusal to include two (2) committee chairpersons articles/final drafts which included final approvals of the 2021 AMTC August and November issues of the AMTC newsletter, the board unanimously approved to relieve Sam Hessel of his duties as newsletter editor. The Board made several attempts to communicate with Mr. Hessel with no response. The outcome was a financial burden to the club, and the board felt it necessary to execute AMTC Bylaws, Article V COMMITTEES, Section 2. The Board thanked Mr. Hessel for his time and effort in producing a quality newsletter.

Everything is on track and show chairperson, Robin Gates is waiting for the hotel to provide a link for attendees to make reservations. Old Business:

2022 & 2023 AMTC National Events: see 1st VP Report.

Breeder Education Committee: Still waiting further information/guidelines from AKC.

Hall of Fame Report: Roberta Berman stated there was nothing new to report other than it is a work in progress.

Ethics Committee's Function: Christina Caridis motioned to dissolve and remove the Ethics Committee from our Standing Rules, Guidelines,

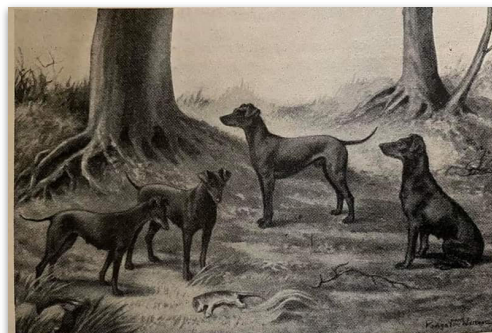

The History Of The English Toy Terrier (Black & Tan) Part 1

ETT (Black & Tan) Club Archivist Dr Steve Inch OBE (Edalene) looks into the origins of the English Toy Terrier and the English Toy Terrier (Black And Tan) Club which recently celebrated its 80th Anniversary

The Early Black And Tans

There are references to Terriers and Black And Tan Terriers (the forerunner to the modern ETT) going back several hundred years. It is widely recognised that the first illustration of a “terrier” was in the “Hours of The Virgin” manuscript of 1500, while references to an actual “Black And Tan Terrier” can be found in the 1750 treatise “De Canibus Britannicis” of Dr Johannes Caius. Like many other breeds of the period the name was fairly loosely applied – with Black and Tans (B&T) which were rough coated and smooth coated, short legged and long legged, and with various descriptions of colour, markings, physical character and size.

Small B&Ts were a favourite of Regency ‘Dandies’ and Georgian Gentlemen, although at that time they were still essentially working dogs carried in deep pockets or pouches by Huntsmen and used to flush out foxes which had gone to ground. The noted English writer J H Walsh (who wrote under the pseudonym “ Stonehenge”) described the B&T as “ useful for hunting and a strong little dog of great endurance and courage with a nose as good as a Beagle”.

It was in the Victorian cities that the B&Ts hunting abilities really came to the fore. The rapid growth of cities during the industrial revolution was accompanied by poor housing, unsanitary conditions, disease and vermin. The B&T played an important role in vermin control and there are many tales of the rat-catching prowess of the B&T with its strong jaws and scissor bite proving to be a very efficient and effective means of dispatching the rat.

This did not go unnoticed among the sporting fraternity of the time and the B&T was a firm favourite in the rat pits which many public houses in the cities operated in their back rooms. When an 1835 Act Of Parliament banned several blood sports it did not apply to rat pits and led to a huge increase in the popularity of rat baiting, and the gambling which went with it. Records of the time show that “Tiny The Wonder” managed to dispatch 200 rats in under an hour at the Blue Falcon Tavern in around 1850. Many of these back room events included owners exhibiting “pets of the fancy” prior to the actual ridding event. And by the mid 19th century “the showing” element started to come to the fore as the climate turned against the rat pit, and rat baiting was eventually declared illegal.

Change was definitely in the air. To understand and appreciate this it is necessary to understand how the canine world itself was developing during the latter part of the 19th

Century. This saw a number of developments which cumulatively provided the foundations for much of the dog breeding and showing which we take for granted today.

Until the 1870's dog breeding and showing was largely unregulated with several varieties of coloured Terriers, with no real categorisation other than Smooth Coat Black and Tans and Rough Coat Black And Tans. Dog Shows – or “leads” as they were known at the time - regularly attracted entries of between 40-60 Black And Tans with one London Show in 1863 attracting nearly 100 entries divided into three groups by weight. Far more common were unregulated dog shows, often casual affairs taking place in the back rooms of pubs and almost all exclusive to men.

One report from the time suggested that the early showings saw “various guises of Black And Tan with motley collections of size and coating”. Cross breeding was common and there were no approved standards to which breeders could operate or judges could judge. In fact many of the UK breeds we know today are products of selective cross breeding – and the ETT is no different. It is widely accepted that breeders were experimenting by crossing Black & Tans with Whippets, Italian Greyhounds and King Charles to produce more refined versions which laid the foundation for the development of the ETT as we now know it.



The 1850's : Early Black And Tan Terriers

From the 1870's through to the 1890's there were several developments which brought much needed order and stability. Key amongst these was the formation of the Kennel Club in 1873 and the steps which it took to introduce registration and regulation, particularly through the collation of its stud books from 1874 onward. The first stud book, (which was retrospective to 1859) had sections for Toy Terriers (Smooth) And Toy Terriers (Rough and Broken Haired) but as yet with no indication of colour. However by 1878 many of the 'smooths' were now identified by colour – the Black and Tan, the Blue and Tan, the White, the Brindle and the White & Brindle . Of these only the Black and Tan survives today in the form of the Manchester Terrier and the English Toy Terrier.

From 1880 there was further refinement with the stud book introducing categories for Black and Tan Terriers (except toys), Toy Terriers (Smooth Coated), and English and Other Smooth Haired Terriers. The former is what eventually became the Manchester Terrier, the middle eventually became the ETT, and the latter was mainly composed of English White Terriers

and Blue And Tan Terriers. And by 1880 there was the introduction of 'Championship Classes' at certain shows with rules established for recognising 'Breed Champions'. Champion Dolly is generally accepted as the 1st Toy Black & Tan to be made up (in 1884).

These refinements were accompanied by the establishment of standards to assist the breeding and judging of individual breeds. These took the form of a 'description of the breed' and a 'points' system for individual features such as the head, colouration, body shape etc. These were the forerunners of the breed standards we know today. Several books written in the 1890s detail the 'points' to be used for judging Black and Tan Terriers – with the only differences between the miniatures and the larger dogs at that time being weight.

The development of the 'description of the breed and the points of the dog' scoring system became largely the responsibility of the breed clubs, which expanded considerably after 1880. The original Black And Tan Terrier Club was established in 1884. In addition to offering prizes at many shows in England to encourage a healthy entry the club played a lead role in developing the first formal "description of the variety" and "the scale of points". Not that this was universally supported by all breeders ! This club was joined by The Black & Tan Terrier Club of England in 1892, The Black and Tan Terrier Club of Scotland in 1893, and the Manchester Black & Tan Terrier Club in 1893. There was also a South of England Black And Tan Club, the Black And Tan Terrier Club of Ireland, and a separate breed club for the White English Terrier.

The Black & Tan, Miniature Black & Tan, and White English Terriers

In July 1903 the Kennel Gazette makes the first mention of the Smooth Toy Terrier being renamed the Black & Tan Terrier (Miniature) while the larger dog continued to be known simply as The Black And Tan Terrier. 14 Miniatures were registered in that year. At that time the standard and points were identical for the miniature and the larger breed, other than the

continued differentiation by weight (under 7lb for the miniature). Support for the breed coalesced around a revived Black & Tan Terrier Club which had responsibility for nominating the breed representative to the Kennel Club, was often asked to act as the breed guarantor, and provided prizes at championship shows. As it developed its national role the regional clubs ceased to operate. The Club met monthly in London under a Committee which largely consisted of breeders and owners of the Miniature.



A Period Of Decline

The early 20th century proved a difficult time for the B&T and its very survival was at risk. The late Victorian period brought in a fashion for smaller dogs to serve as “Ladies Companions” and with it came a series of breeding practices designed to meet this new demand. It was not unusual for breeders to breed with the runt or smallest in a litter rather than the best in a litter to produce a small dog. This drive to miniaturise led to B&Ts as light as 2.5Lb/1KG, with poor coats, apple shaped heads, bulging eyes, ears of all shapes and carriage, and weak bones. The robustness which had characterised the breed for over 100 years was effectively being bred out.

Thankfully there was a core of serious and committed breeders who continued to follow the basic breed standard introduced in the 1890’s, with minor modifications thereafter, and by the 1920’s the numbers were on the increase and the health of the breed on the way to being restored. Indeed the numbers registered doubled through the 1920’s. Dogs of the time from Ch Cheeky and Ch Glenartney Laddie (1900’s), Ch Model Perfection (1910’s) and through to Ch Squeek Of Harford (1920’s) certainly showed the development of the long lean head, the dark almond shaped eyes and the characteristic markings which are part of the current breed standard. The breed owes a huge debt of gratitude to breeders who ‘kept the faith’ over that 30 year period including Mrs Whaley, Mrs C Monk, Mrs L Hignett, Mr R Stirling, Mrs Blondin Robiolio and Mr Bill Tweed

In 1924 the Black And Tan Terrier was renamed The Manchester Terrier, leading eventually to the formation of the British Manchester Terrier Club, and marking a clear division between the smaller and the larger dogs in the UK which has lasted to the present day. Discussion on

renaming the Miniature Black And Tan arose sporadically in the following years, and momentum increased as its popularity increased throughout the 30's. The number of B&T Miniatures registered averaged over 100 per year through the decade. In 1934 a petition sent to the Kennel Club, signed by 80 judges and breeders, proposing a name change from the Miniature Black And Tan to the Manchester Terrier (Miniature) was rejected.

Finally in March 1938 a group of Black and Tan enthusiasts met at Crufts and decided that the time was now right to form a new society devoted specifically to the Miniature. Dorothy Dymock, of the well known "Dym" kennel, was appointed Secretary and she prepared/ submitted an application to the KC to register the "British Miniature Black and Tan Terrier Club". Dorothy was one of THE top breeders at the time, campaigning her Dym Dimmock, to 21 CCs, making him one of the top award winning dogs in ETT history. Others involved in the effort at that time to form the club were Mrs Melvyn (no kennel name), Miss K Hannam, Mrs Christine Wilkinson (Half Moon), Mrs S Green (Harford), and Mrs Percy Daniels (Lilliput). The KC declined to accept "British" in the title but did agree to register it as the "Miniature Black And Tan Terrier Club". And that's how it stayed for the next 20 or so years.

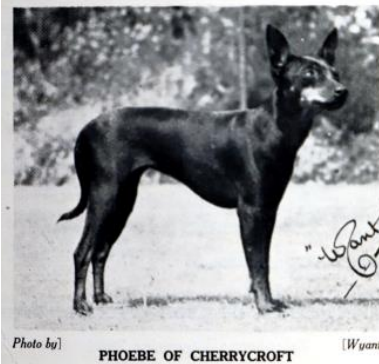

Champions From The 1930's

Although the 2nd world war brought the canine world to a standstill dog breeding and showing resumed fairly quickly after 1945. For the Black And Tans this led to the establishment of many new kennels, and gave new impetus to the work of the Miniature Black And Tan Terrier Club. Most of the top breeders played a part in the running of the club and many donated prizes and trophies to be competed for at the Club's Championship and Open Shows. At one time the club had over 50 trophies. Breeders closely involved with the

club at this time included stalwarts from the 1930's (Dorothy Dymock (Dym), Christina Wilkinson (Half Moon), Mrs Sophia Green (Harford) and "more recent entrants" such as Eleanor Dann (Cherrycroft), Edwin Speight (Whiterails), and Stanley McKie (Colvend). Many of the modern day ETTs can track back to the lines developed by these individuals.

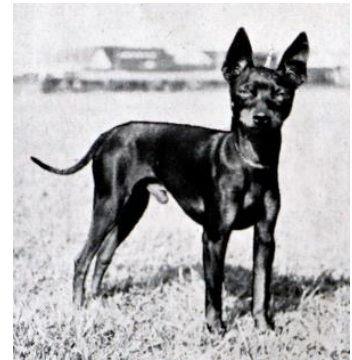

American Manchester Terrier Club Code of Ethics

Membership in the American Manchester Terrier Club (AMTC) is a privilege. In return for acceptance into the AMTC, I promise to abide by the following Code of Ethics and to submit to the enforcement of this Code by the AMTC Board of Directors.

GENERAL

I pledge as an owner of Manchester Terriers to be responsible for the dogs in my care. My responsibilities include providing proper shelter which is clean, dry and warm; appropriate veterinary care and inoculations; emergency veterinary care when needed; quality food and water; adherence to local and state animal control and licensing laws.

BREEDING

I pledge:

1. To accept and uphold the Standard of the Manchester Terrier as developed by the AMTC and approved by the AKC.
2. To breed only physically and mentally sound Manchester Terriers in order to maintain or improve the qualities of the breed as set forth in the Standard. I will not participate in the indiscriminate breeding of studs or bitches with no regard to quality.
3. To screen or obtain proof of screening of breeding stock for communicable diseases, hereditary faults or defects, either active or dormant. Questionable animals will not be used in my breeding program.
4. To forego breeding unless financially capable and willing to responsibly and caringly maintain whelped puppies until placed in their new homes.
5. To maintain complete and accurate breeding records in accordance with AKC regulations.

SELLING

I pledge:

1. To in no way misrepresent any Manchester Terrier for sale.
2. To provide all buyers with:
 - A. AKC individual registration application or certificate properly filled out by seller.
 - B. Minimum three-generation pedigree.
 - C. Record of inoculations, worming, etc.
 - D. Provide instructions for feeding and care.
 - E. Be available for guidance and questions.
3. Not to sell, give, trade, abandon or in any manner transfer litters or individual Manchester Terriers to pet dealers, pet wholesalers, auctions, laboratories, raffles, pet stores, puppy mills, animal shelters, or any source for resale. I will not knowingly transfer ownership or provide stud service to anyone who intends to breed Manchester Terriers for any of the above listed purposes.
4. To take back any Manchester Terrier I bred if the current owner of the dog can no longer keep him or her. I will evaluate the dog as to whether or not s/he is suitable for placing in a new home. In the very unfortunate circumstance that the dog is not suitable, I will either keep the dog myself or provide proper veterinary euthanasia. In the rare event that I cannot take back a dog due to current personal circumstances, I will place the dog in AMTC rescue. I, the breeder, will reimburse any and all reasonable expenses incurred on behalf of a dog in this unusual situation to AMTC rescue.

EXHIBITING

I pledge:

1. To serve as an example of good sportsmanship in any aspect of the sport of dogs, assisting and befriending newcomers to the best of my ability.
2. To show only those Manchester Terriers which deserve to be champions in light of the Standard and which are in proper condition.
3. Not to kennel pack for points in conformation or to engage in any other unfair practices in competition.

PENALTIES

I acknowledge and accept for disciplinary purposes a sliding scale of penalties based upon the seriousness of the deviation from this Code of Ethics. The Board of Directors will apply penalties equally to any and all offenders after a proper review of the evidence. Penalties include but are not limited to: reprimand from the Board; temporary suspension from AMTC membership; permanent suspension from AMTC membership; reporting offenders to the AKC; withholding AMTC awards. I have read and I promise to abide by the above Code of Ethics as set forth by the AMTC.
